

## ECO SG, President of Tajikistan

meet in Guliston city

The Secretary General of the Economic

Cooperation Organization (ECO), Hadi Soleimanpour has met with the President of the Republic of Tajikistan, Emomali Rahmon to discuss enhancement of regional tourism, ensuring peace, security and stability in the neighboring countries of Afghanistan as well as the country's socio-economic development.


The meeting of August 21, 2019, at the Guliston city of Sughd Province of Tajikistan, saw the two sides discuss among others the reform process and the ECO Trade Agreement (ECOTA).

While describing reform as a means to the enhancement of the efficiency of the Organization, the Secretary General said with the aim of enhancing the efficiency, the Organization is undergoing structural reforms which are currently under deliberation at the ECO Council of Permanent Representatives (CPR).

On the ECO Trade Agreement (ECOTA), Dr. Soleimanpour added that in order to facilitate further economic cooperation within the region; the ECOTA Cooperation Council is amending the 2003 Free Trade Agreement to reflect the new realities of the region.

The Secretary General proposed that an economic ministerial meeting could be convened in Tajikistan in early 2020, and could serve as a catalyst for promotion of





further economic cooperation in the ECO Region.

The Organization is committed to rail-way transport corridors and is focusing on transforming the transit corridors of the region into economic ones, and seeks to facilitate more connectivity between land-locked Member States to the seaports of the ECO region as envisaged in the Turkmenbashi Declaration, he added.

The Secretary General said that the valuable experience gained through the Central Asia-South Asia power project, commonly known by the acronym CASA-1000, could effectively contribute to the implementation of the ECO Regional Electricity Market project.

While welcoming the initiative of Tajikistan's President in declaring 2019-2021 the "Years of Rural Development, Tourism and Folk Crafts", Dr. Soleimanpour explained that the arrangements required for the meeting of ECO Tourism Ministers scheduled to

be held in Khujand city on October 3-4, 2019 are underway within the Secretariat.

Appreciating the efforts made by the Secretary General and his team, the President of the Republic of Tajikistan expressed satisfaction over the existing cooperation in trade, transit and transport policy as well as the strengthening cultural and humanitarian ties. He emphasized on Tajikistan's commitment to further strengthening the comprehensive cooperation in trade, investment, energy, transport and communication, industry, agriculture, environment and tourism sectors with the other ECO member states.

Appreciating the selection of Dushanbe as ECO's tourism capital, the President expressed optimism that the forthcoming ministerial meeting on tourism would give an effective impetus to the development of tourism sector in the ECO Member States.

## ECO Informal COM Convenes in New York

(COM) has convened on the sidelines of the 74th Session of the United Nations General Assembly in New York to discuss relevant regional and global developments within the ECO framework.

The 26th Informal Meeting was cochaired on September 27, 2019, by the Minister of Foreign Affairs of Tajikistan, Sirodjiddin Muhriddin and Minister of Foreign Affairs of the Republic of Turkey, Mevlut Cavusoglu.

Also present were Foreign Ministers of the Republic of Azerbaijan, Islamic Republic of Iran, Islamic Republic of Pakistan, Republic of Tajikistan, Republic of Turkey, Deputy Minister of Finance and Economy of Turkmenistan, and Permanent Representatives of Islamic Republic of Afghanistan, Republic of Kazakhstan, Kyrgyz Republic,




Republic of Uzbekistan to the United Nations. The Turkish Cypriot State attended the Meeting as an "Observer".


During the meeting of August 22, 2019, the Tajik Minister underlined the great human and natural potential in the region as well as the importance of its efficient utilization for the progress and prosperity of the ECO nations. He also underscored the continuity of Tajikistan's relations with the Organization, adding that the ECO's chairmanship of Tajikistan coincided with an important span of time.

Referring to the ECOTA Trade Agreement, Mr. Hikmatullozoda noted that despite the passage of 20 years since the signing of the said agreement, its full implementation has yet to take place. Given the current realities, it is necessary to re-consider the ECOTA Trade Agreement, he said.

Referring to ECO's priority areas within the Vision-2025, the Secretary General of the Economic Cooperation Organization (ECO) underlined the necessity for strengthening economic, trade, financial and investment ties amongst the Member States. Mr. Soleimanpour also encouraged Tajikistan to consider becoming a member of the he ECO Trade and Development Bank (ECO-TDB) which was established on August 3, 2005 in Istanbul. In addition the establishment of ECO Clearing Union would facilitate ensuring better conditions for payments in the region, promote financial and monetary cooperation and facilitate expanded trade and economic collaboration amongst the Member States, he added.


## Meet in Dushanbe

The Secretary General of the Economic Cooperation

Organization (ECO), Hadi Soleimanpour has met with the Iranian Foreign Minister, Mohammad Javad Zarif to discuss the issues of mutual interest, including connectivity and commerce in the region.

During the meeting of May 23, 2019, Dr. Soleimanpour expressed ECO's deep appreciation to the Government of the Islamic Republic of Iran for the country's continued support and kind hospitality as the host of ECO.

The Secretary General also discussed with Foreign Minister on the ECO Regional Planning Council, the organization's main technical planning body which is responsible for preparing policies and programs on organizational activities including trade, investment, transportation and communication. Their interaction also took into account the ECO's priority areas as well as achievements made so far in 2019 on connectivity, commerce and energy cooperation.

Acknowledging the significant role of the ECO on enhancement of bilateral and regional cooperation, the Iranian Foreign Minister stated that Iran attaches great importance to expanding relations with its neighbors on both bilateral as well as multilateral forums and regards the regional arrangements like the ECO as imperative to achieving such objectives.

The enhancement of regional connectivity can serve as useful element to pave way for further and continued development in the diverse areas of collaborative activities, including trade and investment in the region, Mr. Zarif added.

The Foreign Minister reaffirmed his sup-



port to the ECO and Secretary General's efforts with a view to improving the efficiency and effectiveness of the organization. The two sides reassured their commitment to work together for securing the objectives of their common agenda and addressing any challenges.

## Third ECO Ministerial Meeting on Tourism

held in Khujand, Tajikistan

The 3rd ECO Ministerial Meeting on Tourism proceeded

by the 5th High Level Experts Group (HLEG) on Tourism was held in Tajikistan's second-largest city of Khujand.

The meeting of October 3-4, 2019, was hosted by the Committee of Tourism Development of the Republic of Tajikistan with the presence of delegations from the Islamic Republic of Iran, the Kyrgyz Republic, the Islamic Republic of Pakistan, the Republic of Tajikistan, the Republic of Turkey and the Republic of Uzbekistan.

In his opening statement ECO Secretary General, HadiSoleimanpour underscored the importance of tourism and its sustainable development within the region. The tourism industry has gained a very positive attention from the Member States and has become a priority development field for the coming decade, he said. The Secretary General drew attention to the fact that the development of the tourism industry throughout the region needs intra

regional international connectivity through all modes of transportation. This could ensure comfortable, cheaper, more accessible and secure travel in ECO Region, Dr. Soleimanpour said.

The session was inaugurated by the Governor of Tajikistan's Sughd Province, Rajabboy Ahmadzoda, who highlighted the potentials and progress of the Republic of Tajikistan in Tourism Sector and the importance of knowledge sharing events in support of mutually beneficial cooperation among the Member States.

The meeting adopted the ECO Principles for Sustainable Tourism Development in ECO Region and the ECO Tourism Plan of Action. It also designated Tajikistan's city of Dushanbe as ECO Tourism Capital for 2020-2021 and the Iranian cities of Sari and Ardabil for the years 2022 and 2023 respectively.

The 4th and 5th ECO Ministerial Meeting on Tourism will be hosted by The Republic of Uzbekistan and Islamic Republic of Iran respectively in 2020 and 2022.



## ECO SG, Kazakh D. Foreign Minister meet in Tehran

The Secretary General of the Economic Cooperation

Organization (ECO), Hadi Soleimanpour has met with the F. D. Minister of Foreign Affairs of the Republic of Kazakhstan, Mukhtar Tileuberdi at the ECO Secretariat in Tehran on 11April 2019.

The Secretary General welcomed the Minister to the Secretariat and acknowledged the rigorous efforts and enduring commitment of the Republic of Kazakhstan in pursuit of regional cooperation among ECO member States. He also deeply appreciated the first president and the leader of the nation of the Republic of Kazakhstan, Nursultan Nazarbayev, for his commendable support and patronage and hoped that with his guidance the Organization would further achieve its objectives.

Dr. Soleimanpour briefed the Minister about the ECO's current progress and future plans in different areas. He presented key features of ECO Vision 2025 & ECO Reform Process and informed the Minister that in order to materialize the vision of our leadership and to upgrade the living standards of the people of the region, ECO has been working on the implementation of several projects. The ECO Secretary General also provided an update on key legal frameworks of the organization. He highlighted the significance of ECO Trade Agreement (ECOTA) in enhancing intra-region trade and requested Kazakhstan to become a signatory to ECOTA. While expressing his views about regional financial framework, he informed the Minister about the plan of establishing ECO regional financial system which would provide facilitation to settle payments to import and export of goods and services



among the ECO Member States. He invited the assistance of Kazakhstan in drafting the agreement of its establishment. He also invited Kazakhstan to consider joining the ECO Trade and Development Bank. The ECO Secretary General appreciated Kazakhstan's support on ECO's initiative to commercialize the railway between Kazakhstan, Turkmenistan and Iran (KTI) and expressed his hope that the Government of Kazakhstan would continue its assistance for KTI study project and in developing other important corridors in ECO region.

The Minister of Foreign Affairs of the Republic of Kazakhstan thanked the ECO Secretary General for providing detailed information about the Organization and its activities. He also appreciated the initiatives launched by ECO in different sectors aimed at promoting regional trade and regional integration among the member states and expressed his full support towards activities of ECO. He acknowledged the idea of establishing ECO regional financial system and informed the Secretary General that Astana International Financial Centre could assist ECO Secretariat in realizing this important regional financial framework.

The newly appointed ambassador of Tajikistan to Iran, Nizomiddin Zohidi presented his letter of credence to the Secretary General, H.E. Dr. Hadi Soleimanpour at the ECO Secretariat on June 3, 2019.

During the meeting, the sides discussed issues of cooperation between Tajikistan and ECO and strengthening the organization's activities in various fields during the Tajikistan Chairmanship.

Special attention was paid to the implementation of the ECO Vision - 2025 strategic, ongoing reform process, as well as the implementation of joint transport projects in the ECO countries.

The ECO Secretary General congratulated Ambassador Zohidi on the beginning of his activities as the Permanent Representative of Tajikistan to ECO and wished him successful tenure in Tehran.

## takes part in ECO-CCI meeting in Istanbul

The Secretary General of the Economic

Cooperation Organization (ECO), Hadi Soleimanpour has participated in the 26th Executive Committee and 17th General Assembly Meetings of the ECO-Chambers of Commerce and Industry (ECO-CCI) on July 30, 2019 in Istanbul.

During the session, the ECO Secretary General underscored the significance of cooperation in promoting economic growth of the Member States and improving living standards of people in this region who are blessed with abundant natural and human resources. He hoped that implementation of the ECO Vision-2025 will take the region on a trajectory of enhanced economic growth and development in the next decade. He also referred to ECO's legal frameworks especially ECOTA, APPI, TTFA, institutional mechanisms, initiatives, projects and programmes which are a clear reflection of collaboration, nonetheless, it requires more interest and participation of the Member States to capitalize the potential benefits and generate greater opportunities. He maintained that ECO Secretariat is in an effort to speed up completion of projects in the areas of trade, transportation, energy, tourism, etc., with the collaboration of regional and international organizations and appreciated interest of the private sector therein which would help improve speed of implementation of on-going projects/programmes and develop new ones for the collective benefit of the region.

The meeting inaugurated by President of the Union of the Chambers and Commodity Exchanges of Turkey (TOBB), M. Rifat Hisarciklioglu and chaired by the Secretary General ECO-CCI, Adem Kula. Also present were the President of Federation of Pakistan Chamber of Commerce and Industry (FPCCI), Daroo Khan Achakzai and the representative of the Iran Chamber of Commerce and Industry, Seyed Hossein Salimi.

The dignitaries from the National Chambers of the Member States in their statements highlighted that the trade level among Member States is far below expectation level and that investment in regional infrastructure and human resources can play important role in fostering economic growth and development in the region. They stressed on the need for increased cooperation at government and business levels and operationalization of ECO Trade Agreement (ECOTA) and improve connectivity through KTI, KTAI rail and road corridors to make the region more integrated for the prosperity and socioeconomic development of the region. They emphasized on removal of impediments for enhancement of intra-ECO

During the Statutory Session of the 26th Executive Committee and 18 General Assembly Meeting, the Secretary General of ECO-CCI, Mr. Adem Kula, presented activity report of



ECO-CCI since 25th ECO CCI Executive Committee Meeting held in Tashkent in December, 2018. Reports of sectoral Committee Meetings i.e. Trade Facilitation Committee, Industry and Investment Committee, Transportation Committee, Tourism Committee, Arbitration Committee, Women Entrepreneurs Council (WEC) Committee held on 28-29 July, 2019 were presented along with the report on the training session of National Chambers. Mr. Muhammad Safdar from the Directorate of Trade and Investment represented ECO in these meetings prior to Executive Committee and General Assembly Meetings.

The Meeting concluded with appreciative note and high spirit aiming to strengthening cooperation and collaboration in all vital areas and with resolution to take maximum advantage from the region's vast and huge resources through stepping up efforts in all major areas and strengthening cooperation under the ECO umbrella.

## **ECO SG,**Foreign Minister of Turkmenistan meet in Ashgabat

The Secretary General of the Economic Cooperation

Organization (ECO), Hadi Soleimanpour has met with the Turkmenistan's Foreign Minister, Rashid Meredov on August 11, 2019 to discuss opportunities for more active participation of the country in ECO activities including transport, energy, trade, tourism.

The meeting on the sidelines of the 1st Caspian forum in the Turkmen city of Avaza along the Caspian coast, saw the Secretary General detail the latest developments and

perspectives including the commercialization and transforming the Kazakhstan, Turkmenistan and Iran (KTI) railway into an economic corridor, the Plan of Actions on Natural Disasters, the Afghanistan Advocacy Program and means to enhance the role of ECO Trade and Development Bank.

During the discussions, the Foreign Minister stated that Turkmenistan firmly supports ECO's endeavors aimed at fostering economic activities in the region. He expressed his readiness to consider all proposals of strengthening of cooperation within the Organization.

The first Caspian Economic Forum marks the first anniversary of the conclusion of the Convention on the Legal Status of the Caspian Sea, which was signed by the five heads of states of the five Caspian states of Russia, Kazakhstan, Turkmenistan, Iran and Azerbaijan in Aktau, Kazakhstan on August 2018. The convention has served as a starting point for further regional integration and opened a new chapter of cooperation in the fields of transport, trade, energy and ecology.

The 3rd Meeting of the ECO Heads of Meteorological Services hosted by the Islamic Republic of Iran Meteorological Organization (IRIMO) was held at ECO Secretariat Tehran, on November 12, 2019.

The Meeting was attended by the delegations from the Islamic Republic of Afghanistan, Islamic Republic of Iran, Kyrgyz Republic, Islamic Republic of Pakistan, Republic of Tajikistan and Republic of Turkey in addition to the ECO Regional Center for Risk Management of Natural Disasters (ECO-RCRM).

The session was inaugurated by the Secretary General of the Economic Cooperation Organization (ECO), Hadi Soleimanpour, who expressed his wishes for successful meeting. ECO Deputy Secretary General, Sayed Yahya Akhlaqi highlighted the importance of water conservation, drought monitoring system and effective utilization of yield management.

The President of Islamic Republic of Iran Meteorological Organization (IRIMO), Sahar Tajbakhsh Stated that as natural disasters knows no geographical boundaries, ECO Member States may make use of the best practices of other countries regarding weather-related disas-



ter management.

In addition to decisions and recommendations for enhancing the cooperation among the ECO Member States in the area of natural disasters management and objectives related to ECO Vision 2025, the meeting approved the statute of the ECO-RCRM. The meeting also welcomed the Islamic Republic of Afghanistan's offer for hosting the next ECO Heads of Meteorological Services Meeting in August 2020.



#### **ECO SG Inaugurates**

## **ECOTA** Cooperation Council Meeting in Tehran



The Secretary General of the Economic

Cooperation Organization (ECO), Hadi Soleimanpour has inaugurated the 8th Meeting of Cooperation Council for the **Economic Cooperation Organization** Trade Agreement or ECOTA at the ECO Secretariat in Tehran.

The meeting of August 18-19, 2019 was attended by the delegates from all five Contracting Parties namely the Islamic Republic of Afghanistan, the Islamic Republic of Iran, the Islamic Republic of Pakistan, the Republic of Tajikistan, and the Republic of Turkey.

In his opening statement, the Secretary General highlighted significance of trade as the foundation of economic growth and socio-economic sustainable development and enumerated promising benefits such as improving living standards of the populace, creating investment opportunities, job creation, industrial

growth and technological advancement. He added that the current level of intra-ECO trade hovering around 8 percent of the total region's trade is not comparable with other peer economic blocs. He referred to the ECO Vision-2025 which stipulates to double intra ECO trade by 2025 from its current level which needs to be pursued vigorously.

He further maintained that there is need to adopt an innovative approach to implement ECOTA or upgrade its mechanism to deliver its aims in the light of the views of the contracting parties. To move forward, he propounded the idea of sectoral application in the first stage and the Council agreed to consider the proposal of the ECO Secretariat by taking it up with their respective Governments.

The Secretary General, ECO Chamber of Commerce and Industry (ECO-CCI), Adem Kula said as the voice of business leaders of ECO region, ECO-CCI fully supports the efforts on the implementation of ECOTA and finding new ways for its operationalization. As the dynamics of the world are changing rapidly cooperation among countries, trade blocs, regions and even unions are developing and those already developed are deepening, he added. Mr. Kula extended his organization's offer to be a part of the efforts and play instrumental role in enhancing intra-regional trade.

In his statement in the Statutory Session, the ECO Deputy Secretary General, Sayed Yahya Akhlaqi, underlined that efforts for economic and trade growth are crucial for our region which has great geo-strategic, geo-political and geo-economic significance due to abundant natural and human resources. He maintained that ECOTA can be implemented with more constructive approach and better understanding among the contracting parties.

The Heads of Delegations of the Contracting Parties delivered brief statements underscoring the need for trade liberalization in the region. They presented their views on implementation of ECOTA, highlighted progress and enumerated actions taken by their respective governments to implement tariff concessions.

\_ECO\_ CHRONICIE The 4th Meeting of

the Board of Trustees (BoT) of the Economic Cooperation Organization Science Foundation (ECOSF) was held in Isfahan, the Islamic Republic of Iran on July 9, 2019 with the participation of delegations of the four ECOSF Member States.

Representatives from Afghanistan, Iran, Pakistan

and Tajikistan, considered the comprehensive report of the ECOSF President on the activities and programmes of the Foundation and approved its strategies and work plans for the period 2019-2020. The Meeting also adopted the Isfahan Communiqué 2019. The meeting was preceded by the 5th Meeting of ECOSF Executive Committee on 8 July, 2019.

## ETDB Annual BOG

## Meeting held in Istanbul

The 18th Annual Meeting of the Board of Governors (BOG) of the ECO Trade and Development Bank (ETDB) was held on July 04, 2019 at Istanbul, the Republic of Turkey.

Speaking at the plenary session ECO Secretary General, Hadi Soleimanpour, congratulated the management of the Bank for financing the priority ECO projects and supporting financial needs of ECO Member States and underlined the need of promoting further of the existing cooperation between the Bank and Secretariat for socioeconomic development within Member States.

Based on the outcomes of the last ECO Summit and Council of Ministers Meetings, Dr. Soleimanpour informed the Board that ECO is focusing on implementation of regional priority projects of ECO Vision-2025 and harmonizing the activities of the Secretariat with the ECO Specialized agencies including ECO Bank etc.

In addition, the Secretary General emphasized on the need for the establishment of the ECO Vision Fund with collaboration of ECO Bank to finance the implementation of the priority projects, a mechanism to facilitate payment transactions for ECO trade and services and the expansion of the mandate and capacity of the ECO Bank to rightly address ECO's main priority areas.

Within the frame work of the cooperation between the two organizations the Secretary General also requested the BOG to consider providing loans to the Member States for implementation of joint ECO



regional projects and financial assistance for feasibility studies, capacity building projects and consultancy services to ECO projects.

The BOG of ETDB comprise of representatives appointed by the Governments of the Member States and holds annual meetings and such other meetings deemed necessary by the Board. All the power of the Bank is vested in the BOG. The BOG, inter alia has the power to increase or decrease the authorized capital of the Bank, elect the President of the Bank, approve, after reviewing the auditors' report, the balance sheet and the statement of profit and loss of the Bank, determine the reserves and distribution of the profit of the Bank etc.

The ETDB was established on 3 August 2005 with its headquarters located at Istanbul, Turkey and started its operations in 2008. The representative offices of the Bank at Tehran, Iran and Karachi, Pakistan are fully functional. The current shareholders are now six members of ECO, namely Afghanistan, Azerbaijan, Iran, Kyrgyz Republic, Pakistan and Turkey.

The ETDB offers a range of medium-to-long term products i.e. project finance, corporate finance, trade finance and loans to support small and medium-sized enterprises directly or through financial intermediaries to private and state owned entities. In this context, sectors such as infrastructure, manufacturing, agriculture, energy, transport and communications, which have potential impact on the development of the member states, are given special attention.

## ECO Workshop on Cybercrimes

A workshop on Cybercrimes was

held in Tehran on at the International Police Academy of the Islamic Republic of Iran (AIPA) with the participation of representatives from six ECO Member States namely the Islamic Republic of Afghanistan, Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, the Islamic Republic of Pakistan and Republic of Turkey.

The session of November 3-7, 2019 was co-organized by the Economic Cooperation Organization, the National Central Bureau (NCB) of Tehran and AIPA to inform participants on means to combat cyber-attacks and mobile

hacking. In addition, data collection methods, skimming and infiltration test tools, OSINT (open-source intelligence), crime scene investigation, cyber digital forensics, digital evidence lab, and data excavation were also discussed.

During the session, ECO Deputy Secretary General, Huseyin Avni Bicakli said that the Organization has been tasked with coordinating collective regional efforts in the fight against organized crime within the Region with a view to promote peace and stability as one of the prerequisites for economic development.

During the meeting Iran's Deputy Head of Interpol, Kazem Mojtabaei, said that various training sessions have been delivered to different countries in Iran and expressed hope that effective cooperation within the region on cybercrimes can assist law enforcement officials in identifying international cyber criminals.



## ECO Railway Heads

### Meeting held in Istanbul

The 14th Meeting of Heads of Railway

Authorities of ECO Member States and the 8th Railway Committee of TTCC (MHRA) was held on 20-21 June 2019 in Dushanbe, Republic of Tajikistan to evaluate the operationalization of existing railway routes by completing rehabilitation and construction of missing links.

The Meeting which was inaugurated by the First Deputy Minister of Transport of Republic of Tajikistan, Sohrab Mirzozoda saw High level Delegations from the ECO Member States updated the Meeting on prospective progress on railway development, at national level and regional level. Official representatives of International Organizations, including ESCAP, IsDB, ADB, UIC, OTIF and UNECE contributed



to the Meeting by sharing views, suggestions and constructive proposals on the betterment of regional railway connectivity, common access, and safety.

The ECO Secretariat was represented by Director for Transport and Communications, Ahmad Saffari, who in turn welcomed the delegates to the session which in line with recommendations of Turkmenbashi Declaration adopted by the 9th Meeting of Ministers of Transport of ECO Member States (1-3 May 2019, Turkmenistan) noted considerable progress on railway projects: Qazvin-Rasht-Astara (Azerbaijan)-Astara (Iran) and Islamabad-Tehran-Istanbul.

Pre-operationalization steps for the existing railway routes have been developed: (i) on KTI, the need to ensure that the implementation of the Study Project on KTI be realized timely, in line



with its set schedule was highlighted and the Inter-Governmental Agreement was said to be in place for endorsing Common Management Mechanism for the route; (ii) on Istanbul-Almaty & Bandar Abbas-Almaty routes, no sharp issues were revealed? for regular run of container trains and, thus, pre-operationalization plan was agreed to be put up for endorsement by the upcoming meeting of en-route countries.

The construction of KTAI railway project was discussed, in detail, as were new routes designed to improve regional railway connectivity in the ECO region. In line with recommendations of Dushanbe Communiqué (17-18 April 2018, Tajikistan) new ways of widening the ECO regional connectivity by rail were discussed. From this stance, a new railway project "Afghanistan-Uzbekistan-Kyrgyzstan-China" was endorsed for implementation.Ô

The need for transforming ECO's existing railway routes into economic spaces with structured integrated economic and free trade hubs with production sources in close proximity with supply chains so that railway services could further maximize on large scale spillover effects of such zones has been emphasized.

The Meeting also agreed to cooperate on railway passenger transport. Prerequisite arrangements for the proposed railway transport mode were quoted by Iran, Azerbaijan and others. The passenger tourist train was said as tested in the direction of Mashhad (Iran)-Ashgabat (Turkmenistan) and those ECO countries that have an interest in improving their tourism potentials by transport means were welcomed. The participants suggested issuing ECO Railway Maps, Annual Railway Transport Statistical Year Book and compile ECO Railway Directory for the purposes of information and knowledge sharing.

The subsequent 15th Meeting of Heads of ECO Railway Authorities/9th Railway Committee Meeting of TTCC was agreed to be held in Iran in 2021.

The Assembly also invited the United Nations Conference on Trade and Development (UNCTAD), World Trade Organization (WTO) and the International Trade Centre to develop strategies for the member States of the ECO for trade liberalization and the promotion of foreign direct investment to facilitate the global and regional integration of their economies.

The GN-SEC represents an innovative south-south and triangular multi-stakeholder partner-ship to accelerate the energy and climate transformation in developing countries. Since 2010, the United Nations Industrial Development Organization (UNIDO) assists the regional economic communities/organizations and their member states in the establishment and operation of regional sustainable energy promotion centers. The GN-SEC is currently becoming a formalized global platform to advocate for SDG-7, SDG-9 and SDG-13 and joint interests in international policy processes, and is hosted by UNIDO in Vienna, Austria.

The 4th Steering Committee Meeting brought together the GN-SEC members, supporting partners, and the representatives of international organizations. The Meeting marked the involvement of new members to the GN-SEC process, including ECO. Its proceedings addressed the achievements and next milestones of GN-SEC and its members, lessons learned from different regions across the globe,

Director of Energy, Minerals and Environment of ECO Secretariat, Mr. Fuad Farzalibevov participated at the Meeting. ECO Director delivered the presentation on the Preparatory Phase of the Project of the establishment of ECO Clean Energy Centre, being jointly implemented by ECO and UNIDO. Having briefed the audience on the background, objectives, recent status, expected benefits and impacts of the above Project in his presentation, ECO Director characterized the ECO Clean Energy Centre as a promising future element of GN-SEC being implemented across the globe that could complement and potentially interconnect other Centres within GN-SEC framework. He highlighted that the establishment of the Centre will be an explicit example on how the countries mostly endowed with hydrocarbons resolve on a regional level on contributing to the sustainable energy transition. He stated that the Project has been recently launched and is currently underway. # ECO participates in the Baku International Energy Charter Forum

On the invitation of International Energy Charter, ECO Secretariat participated in the Baku International Energy Charter Forum held in Baku, Azerbaijan on October 23-24, 2019.

The forum was jointly organized by the Ministry of Energy of Azerbaijan and the International Energy Charter on the theme of "Enabling Energy Transformation through Technology and Policy Innovations". More than 200 participants, including Ministers, high-level officials and leading experts from Member and Observer countries, international organizations, the energy industry and academia participated in the Forum.

The opening remarks were delivered by

Minister of Energy of Azerbaijan, H.E. Parviz Shahbazov and Energy Charter Secretary General, Dr Urban Rusnák. This was followed by the high-level addresses from the representatives of the governments and international organizations. The Speakers highlighted different approaches to facilitate the energy transition while industry representatives shared their best practices and lessons learnt in terms of energy efficiency and renewable energy sources.

The Forum aimed at discussing the role of regulatory frameworks and technologies in promoting sustainable energy. The ECO Secretariat was represented by Assistant





Director for International Relations, Muhammad Farooq.

During his speech to the session, Mr. Farooq briefed the session that Energy represents one of the highest priorities within ECO and ECO Vision 2025, a major strategic document of ECO, lays down "the enhancement of energy security and sustainability through wider energy access and trade" as an ECO's strategic objective. Inspired by this objective, the Vision has identified the "deployment of environmental-friendly energy technologies" and "promotion of energy investments through advocating innovative incentives" among key expected outcomes, to be achieved in the coming years.

He also informed the audience that ECO Region is endowed with the one third of the global hydrocarbon resources and it is one of the key suppliers of oil and natural gas to the world markets contributing to the international energy security. However, despite the rich oil and gas resources, the energy agenda of ECO has been undergoing the paradigm shift towards transformation to sustainable energy over the past few years.

He also underscored the significance of

establishment of ECO Clean Energy Centre as a catalyst of both South-South and North-South cooperation dimensions as well as facilitator of technology and knowhow transfer in the ECO Region. He also mentioned that establishment of ECO Regional Electricity Market (ECO-REM), aims at harmonizing and merging the electricity markets in our Region, has been identified as a key area for ECO-Energy Charter cooperation. He assured that ECO, as an important regional partner for global agendas, stands ready for any dialogue with international partners for accomplishment of this goal.

On the sidelines of the forum, the ECO representative also had the opportunity to meet the Secretary General of the International Energy Charter and high level officials of the various countries. During his meeting with Secretary General International Energy Charter, both sides stressed the importance of strengthening cooperative relations in the energy sector. In this regard, the Secretary General of the International Energy Charter also assured Mr. Farooq to organize a training/capacity building workshop for ECO Member States in the first quarter of 2020.

tion of the Secretariat of the WHO Framework Convention on Tobacco Control, a Representative of the ECO Secretariat attended the Geneva meeting on November 7-8, 2019.

While the meeting was organized by Convention Secretariat on Tobacco Control and the Protocol to eliminate illicit trade in the Tobacco products (the Secretariat), the Representatives of Intergovernmental Organizations from African Capacity Building

Foundation (ACBF), Southern African Custom Union (SACU), Organization of Eastern Caribbean States (OECS), African, Caribbean and Pacific Group of States (ACP) and Persian Gulf Cooperation Council (GCC) also attended the meeting to raise awareness about both treaties to regional integration bodies and at the same time identify potential avenues for collaboration on this issue.

During a 2-days interactive meeting, the Convention Secretariat, which was created during the first Conference of the parties in 2003, highlighted the activities it had been making under the assigned task. Currently, there are 181 Parties of the WHO framework Convention on Tobacco Control including ECO Member States, covering more than 90% of the world population. The ECO Secretariat was also advised by the Convention Secretariat to work on accession to Conference of Parties (COP-Convention)) and Member of Parties (MOP-Protocol) as observer. To date 28 International intergovernmental organizations and 21 nonegovernmental organizations, accredited as observers to the COP, are committed to the purpose of the WHO Framework Convention

on Tobacco Control, disregarding any sort of funding that has vested interest in the tobacco industry.

The ECO Representative Mr. Mojtaba Faraji briefed the meeting about the ECO Region and Member States as well as aims and objectives enshrined in the Izmir Treaty. While, explaining the ECO rules of procedures for getting observer status in other organizations, he underscored the specific segments of ECO Vision 2025 regarding trade, environmental and health issues which

are considerable by FCTC and Protocol of elimination of illicit trade of Tobacco products, as well. The ECO Representative also advised the Convention Secretariat to extend its support to IGOs for preparing regional frame works aligned with WHO Framework Convention on Tobacco Control and Protocol to Eliminate Illicit Trade in Tobacco Products for effective implementation of global agenda for Tobacco Control and Illicit Trade of its products.

The WHO Framework Convention on Tobacco Control (WHO FCTC), the first international treaty negotiated under the auspices of WHO, adopted by the World Health Assembly on May 21, 2003 that entered into force on February 27, 2005. It has since become one of the most rapidly and widely embraced treaties in the history of the United Nations. The WHO FCTC, developed in response to the globalization of the tobacco epidemic, is an evidencebased treaty that reaffirms the right of all people to the highest standard of health. The Convention represents a milestone for the promotion of public health and provides new legal dimensions for international health cooperation.

# **ECO** Secretariat **Takes Part in UNCITRAL**

Meeting in New York

On the invitation of the UN Commission on

International Trade Law (UNCITRAL). ECO representative from the Trade Section for the first time participated in its Working Group-I Meeting themed Micro, Small and Medium-sized Enterprises (MSMEs), 32nd Session, which was held on March 25-29, 2019 at the United Nations Headquarters in New York. It was well attended and contributed by the experts and representatives of the Member States, Observers and International and Regional Organizations.

The event was organized in two segments; First, the Colloquium on "Contractual networks and other forms of inter-firm Cooperation" with the aim to explore legal tools for facilitating/fostering MSMEs' cooperation by sharing of resources and enhancing access to businesses having a relatively low level of initial capital, low entry and exit costs, etc. Participants shared popular forms of business entities and cooperation modes in their countries. In this part, experts from governments, private sector, academia and the non-profit sector exchanged views on challenges in an informal environment.

Second, in the light of discussions in the first part and in furtherance of the previous work/draft of the UNCITRAL, the Working Group Meeting discussed the relevance of models developed and deliberated/ revised Draft Text for Legislative Guidelines for the UN Limited Liability Organizations (UNLLO) enabling legal environment for MSMEs in different countries. The Working Group expressed that the current draft



text of the Guide was a classical corporate model and after extensive discussion on several concepts and aspects of the UNLLO, revised the draft text and propounded recommendations related there-

Delegates from Member and Observer States and those intergovernmental and non-governmental organizations invited to participate attended this part of the event.

Noting that MSMEs are the backbone of the economies especially of the developing ones such as in the ECO region and representing 95 percent of the firms in the world in this category and providing nearly 70 per cent of the employment, there is greater need to develop legislations guidelines to promote and enhance potential of MSMEs to capture greater share in local production and exports.

These endeavors provide an enabling environment for better compete the markets leading to sustainable growth in the national economies and for realization of the UN's Sustainable Development Goals (SDGs) set for 2030.



Before the preparation of ECO-Vision 2025 the focus on tourism industry had been mainly about the economic growth side because tourism developments and realizations in ECO Member States were too low with respect to the its capacity. Around 5 percent of international arrivals and 3 percent of tourism receipts made in to ECO Region.

Although "undertourism" issue seems negative, ECO region is still untouched and pre-

served. During the 3rd ECO Ministerial Meeting on Tourism in the Khujand City of the Republic of Tajikistan on October 4, 2019, tourism sustainability has been discussed in detail. For future progress and development in tourism industry, ECO Principles for Sustainable Tourism Development were approved. Tourism industry can be built more environmentally, healthy, and sustainable basis.

# ECO Principles for Sustainable Tourism Development

Sustainable Tourism in the ECO region meets the needs of contemporary generation (tourism stakeholders) without compromising the ability of the region's future generation to meet their needs. It leads to manage all available resources in such a way that economic, social, cultural and aesthetic necessities can be fulfilled while maintaining cultural integrity, essential ecological processes, and biological biodiversity and life support systems in the Region.

Sustainable tourism in the ECO region should seek a balance among (a) economic benefit and investment; (b) social participation, including local communities, with direct earnings, and seeking preservation and consolidation of its cultural values and traditions; (c) conservation and protection of environment and biological diversity, taking into account the introduction of education and dissemination of information to promote an environmental consciousness

among the local population and visitors.

ECO Sustainable tourism development is conducted (operate) in the framework of sustainable development while addressing the natural, cultural and human environments. It calls for special priority in the matter of cultural diversity and respect for the human dignity of both local communities and tourists. It should meet the economic expectations and environmental requirements of destinations. It is considered the establishment of stakeholders' alliances based on sustainability criteria, an integrated policy approach, consideration of regional culture and economy, participation of all actors including active role for industry in sustainable tourism development.

Sustainable Tourism Development guidelines and management practices are applicable to all forms of tourism in all types of destinations. Sustainability principles refer to the environmental, economic and socio-cultural aspects of tourism development, and a suitable balance must be established between these three dimensions to guarantee its long-term sustainability.

ECO regional sustainable tourism develop-

ment, a mean to ensure country planning in each ECO Member States, is mutually supportive and a common approach for integrated tourism development to be observed in the region. It provides an overall regional framework for maximized economic benefits of tourism avoiding destinations degradation from tourism activities. It fulfills the strategic objectives identified by ECO Vision 2025 for "establishing a peaceful and green tourism destination with diverse products and high quality services in the Region" based on the following principles:

## ■ 1)Principle of Inter-generational Equity

This principle oversees the preservation of the natural and environmental resources for the benefit of the next generation and guarantees the safeguarding of the tourism resources of the Region (by present generation) for future generations. To observe Intra-generation Equity in regional tourism development, the Principle of Prevention Action and Precautionary Principle based on international law should be taken into consideration.

# ■ 2)Principle of Intra-generation Equality

This principle applies for fair use of natural resources by present generation to address their development needs and economic growth as well as social welfare. It also implies that use of shared natural resources by one State should fairly take into account the developmental needs of other State.

### ■ 3)Principle of Integration development and environment

This principle implies the need to ensure that environmental considerations are integrated into tourism development programs, with a view to achieving sound, continuous and sustainable economic growth as well as ensure tourism development proposals designed to meet international guidelines for sustainable development and integrate to national development plan. To observe the integration principle in regional tourism development, the principle of right to development, the polluter pays principle, principle of dissemination of environmental information; principle of environmental

impact assessments based on international law should be noted.

#### ■ 4)Principle of sustainable use of natural and biodiversity resources

It considers the optimal use of environmental resources, maintain essential ecological processes and conserve aesthetic values as well as biodiversity resources of host communities. The principle of sustainable use of natural resources aims to ensure the exploitation of natural resources in a sustainable, appropriate, rational and/or prudent manner. Its approach is to focus on the adoption of standards governing the usage rate of natural resources in tourism development process, particularly rare and precious resources such as water and energy, rather than their preservation for future generations. To observe this principle, the principle of conservation and sustainable use of biodiversity resources for considering ecosystem approach in tourism development plan in ecologically sensitive areas and protection and rational exploitation of ecosystem biodiversity, species diversity, and genetic diversity should be applied.

#### ■ 5)Principle of preservation of cultural identity

This principle deals with the need to respect, preserve and support the identity, integrity and legacy of local and indigenous cultures in tourism destinations. This principle has a meaningful linkage with the principle of carrying capacity and should be analyzed with the principle of the participation of the local community in the management of tourism destinations.

#### ■ 6)The principle of carrying capacity

This principle addresses the need to identify the limits of social and environmental capacities of tourism destinations and reflect them in relevant policy and planning, in order to absorb tourists without submerging and overwhelming local culture and causing environmental damage. The principle of carrying capacity often calls for a restriction (control) on tourism to avoid cultural and environmental degradation.

#### ■ 7)Principle of cultural and natural heritage and landscape

This principle addresses the need for the collective protection of natural heritage sites of

outstanding universal value and promotes landscape protection, management and planning, in tourism destinations and their buffer zones, and to retain a harmony with the cultural and natural heritage of the area.

#### ■ 8)The participatory principle and partnership of all stockholders

The principle of partnership addresses the need to provide an appropriate environment in which all stakeholders have the opportunity to conduct their affairs and hear and be heard. The participatory principle also implies the need to have shared responsibility at all levels and within all processes. It implies that the role of all stakeholders including ECO tourism industry, local and regional investors, local community, government representatives, international organizations, NGOs and environmental groups on the management and decision making process at tourism destination should be guaranteed. It also observes the need for active participation and involvement of local communities and indigenous peoples in the decision making process of tourism development and management at ECO tourism destinations.

#### ■ 9)Principle of integrated sustainable tourism planning

This principle describes the need for the integration of ECO regional and national sustainable tourism strategies, policies and planning into overall national development plans. Such integration is crucial for the sustainability of tourism activities and development in destinations in the Region. It also focuses on the need for cross sectoral integrated planning and projects as well as creation of chain production in tourism industry across the Region.

#### ■ 10)The principle of committed tourism industry

This principle applies to the participation, involvement, engagement, and commitment of the tourism industry to short, medium, and long-term policy setting and decision making and their implementation and management processes regarding sustainable tourism activities. It also considers that the sustainability of tourism activities in ECO tourism destinations depends on the approaches of the regional and international tourism industry and the types of

services and products to be offered at destinations and the fact that short term interests of tourism business should transform to mid and long- term one by the tourism industry through, inter alia, close partnerships with government and civil society, better environmental management and practices, higher commitments to engender a new culture of accountability and apply sustainable consumption and production patterns to tourism activities in ECO tourism destinations.

# ■ 11)The principal of tourism safety and right to rest and leisure

The principle of tourism safety addresses the need to ensure the security and safety of visitors and their belongings, as a necessary precondition to establishing a sustainable business in ECO tourism destinations and observes the need to respect law and value of the visiting country by tourists. This principle also implies the right of everyone to rest and leisure as an inalienable part of human rights and applies to the right of all persons to enjoy reasonable work hours, periodic holiday with pay and freedom of rest and movement without limitation. It also considers the right of visitors to have easy access to ECO tourism destinations while addressing seasonality of tourism.

# ■ 12)The Principle of sustainable transport development

This principle addresses the role of sound, safe and sustainable transport system in sustainable development of ECO tourism destinations. It also addresses the needs for reliable and economically viable connectivity system in the ECO region to provide market friendly access to these destinations through integrated destination access strategies in our Region.

# ■ 13)The Principle of incentive measures and voluntary initiatives

This principle addresses the use of incentive measures and voluntary initiatives as socio-economic tools to serve the participatory principle, and raises the issue of environmental consciousness, dissemination of information and capacity development in ECO tourism destinations.

#### ■ 14)The Principle of development of

#### suitable indicators and standards

This principle addresses the need to develop basic indicators and standards to monitor the progress of the sustainable development of tourism, and to assist decision-makers and policy-makers in focusing on the sustainability of tourism activities and development in ECO Region.

By implying this principle, indicators and standards can translate physical and social science knowledge into manageable units of information that can facilitate the decision making process. They can help measure and calibrate progress towards sustainable development tourism goals as indicated in vision 2025. They can also provide early warning, sounding the alarm in time to prevent economic, social and environmental damage. This principle has links with the sustainability principle.

# ■ 15)The Principle of sustainable consumption and production pattern in tourism industry

This principle addresses the need to eliminate unsustainable production and consumption patterns in ECO tourism destinations, in order to minimize depletion and reduce pollution. It regulates consumers' behavior towards sustainable consumption and assists the tourism industry in fulfilling its responsibility and commitment to the environment.

# ■ 16)The Principle of financial resources and investment protection in tourism

This principle suggests an appropriate international and regional financial mechanism to address the investment needs of ECO tourism industry and alleviate the financial constraints of ECO sustainable tourism developments. It addresses the need for proper mechanism and national legislation to protect income investment and confront with financial constraints which affect the proper implementation of ECO tourism action plan.

Acknowledging the necessity to educate and mobilize the ECO community about sustainability and sustainable principles of tourism, the application of such principles should be made on all ECO Tourism Policies and Development Plans, enabling the pursuit of such targets in an effective and efficient manner.
