The Islamic Republic of Afghanistan Hosts

2nd Meeting of the Heads of Free Trade/Special Economic Zones of the ECO Member States

The '2nd Meeting of Heads of Free Trade/Special Economic Zones of the ECO Member States' was virtually hosted by the Islamic Republic of Afghanistan on August 2, 2021 under the chairmanship of H.E. Mr. Atta Nasib, Director General of Afghanistan Investment Facilitation Unit (AIFU), office of the President of I.R of Afghanistan. The representatives of the ECO Member States, delegation of the ECO Secretariat headed by Deputy Secretary General, Dr. Yahya Akhlaqi, Secretary General of the ECO Chamber of Commerce and Industry, Mr. Adam Kula and the representatives of Iran Chamber of Commerce, Industries, Mines and Agriculture (ICCIMA) & Pardis Technology Park of Iran; participated in event.





H.E. Mr. Atta Nasib, while chairing the meeting; apprised the participants about the special attention of the government of Afghanistan to the establishment and strengthening of ECO Zones with a view to deepen economic ties with the countries of the ECO region.

He shared the vision of His Excellency the President of the Islamic Republic of Afghanistan to enhance regional economic cooperation for development, expand trade relations and enabling investment climate to play a pivotal role as a trade and transit hub in the region.

He shared the resolve of Islamic Republic of of Afghanistan to trade and connectivity with neighboring countries. He informed that AIFU is committed to take practical measures for establishing FT/SEZs in Afghanistan, utilizing the good experiences of other ECO Member States, including Turkey, Azerbaijan and Kazakhstan.

The ECO Deputy Secretary General, Dr. Yahya Akhlaqi extended his warm gratitude to the Islamic Republic of Afghanistan for hosting the meeting while thanking the participants to attend the event. He stated that the aim of meeting is to take stock of the decisions made during the '1st Meeting of Heads of SEZs of the ECO Member States' and implementation of these decisions. Moreover, the meeting is expected to develop an 'Action Plan' and a 'Road-Map' to improve business climate in ECO region, for investors and traders to invest and trade goods and services under the umbrella of ECO Zones.

The ECO Director (Trade & Investment), Mr. Zahid Hussain Abbasi; whilst briefing the meeting, emphasized the need to opertionalize the ECO Agreements like ECOTA, APPI, ECO Reinsurance Company, cooperation in Customs and Taxation etc, to bolster business climate in the region. He explained the initiatives of the ECO Secretariat for removing Non Tariff Barriers (NTBs) and setting up robust financial systems for better transparency, predictability and reduction in cost of business.

The meeting deliberated on the harmonization of policies for the networking among ECO Zones, the sharing of experiences from the existing legal and regulatory frameworks for fostering proposed cooperation.

The meeting also requested the ECO Member States, to consider early implantation of ECOTA and APPI and expedite their nominations for the 'Standing Committee of ECO Zones' and engage their relevant SEZ/TFZ authorities for finalization for the guidelines with the Secretariat for setting up the network of ECO Zones.

ECO Holds Midterm Meeting of RPC

The Midterm Meeting of the ECO Regional Planning Council (RPC) was held virtually on July 28, 2021. The Representatives of the ECO Member States and ECO Observers participated in the event. The ECO Secretary General, H.E. Dr. Hadi Soleimanpour and Chairman of the CPR, H.E. Mr. Ahmet



Gurbanov, as well as ECO Deputies Secretary General, relevant Directors and Program Officers also attended the meeting.



The Deputy Minister of Finance and Economy of Turkmenistan and the Chairman of Midterm RPC, H.E. Mr. Toyli Malikov underscored that activities within the ECO had notably

increased in recent years, bearing positive impact on ECO's efforts for expanded regional cooperation. Nevertheless, he emphasized on the significant potential of the region, especially in economic, trade, transport, energy and investment areas that he considered necessary to be utilized to attain the developmental goals of ECO Vision 2025. He further accentuated that maximized collective and sustainable efforts of the member states could help enable the regional economy to recover from the post-pandemic state of rigidity.

While inaugurating the event, the ECO Secretary General, H.E. Dr. Hadi Soleimanpour welcomed the event's participants. Highlighting the RPC's actual mandate, Dr. Soleimanpour noted that this particular midterm meeting would review and adjust the year 2021's activities and engagements of the organization in special consideration of the COVID-19 and the post-pandemic conditions that obliged a shift in the global and regional working methods.

The Secretary General underlined that ECO was able to successfully hold several ministerial and experts group meetings of regional significance within the

first half of 2021, particularly the 14th ECO Summit on March 4, as well as 2nd General Conference of the Parliamentary Assembly of

ECO Countries (PAECO) on June 1-3 at Islamabad.

Dr. Soleimanpour briefed the meeting about sectorwise implementation of some ECO projects, stressing that in the recent years the projects'



execution rate has significantly increased.

The meeting took into account the progress report on the ECO Work Program and Calendar of Events 2021 that contained ECO priority areas of development, including (i) trade & investment (ii) transport & communication (iii) energy, mineral & Environment (iv) agriculture & industry (v) tourism (vi) economic research & statistics (vii) human resources & sustainable development (viii) judicial & parliamentary coordination and ECO Advocacy Program for Afghanistan (ix) ECO **Regional Institutions /Specialized** Agencies/Affiliated Bodies and International Relations. The reviewed Work Program and Calendar of Events 2021, based on updates/suggestions of the member countries, were also adopted during the midterm meeting of the RPC.

ECO Secretary General Attend an International **Conference in** Uzbekistan

On the invitation of the Government of Uzbekistan, the Secretary General of the Economic

Cooperation Organization, H.E. Dr. Hadi Soleimanpour visited Tashkent to attend an International Conference "Central and South Asia: Regional Connectivity, Challenges and Opportunities held on July 14 - 16, 2021.

The event was participated by several Heads of State, including President of the Islamic Republic of Afghanistan, H.E. Mr. Ashraf Ghani, and the Prime Minister of the Islamic Republic of Pakistan, H.E. Mr. Imran Khan, as well as high-level government officials of the Central and South Asian countries and the Representatives of some International and Regional Organizations.

While inaugurating the Conference, the honourable President of Uzbekistan, H.E. Mr. Shavkat Mirziyoyev underscored the rich historic and cultural linked past of the Central and South Asian Regions through the Silk Road. Emphasizing on the commonalities between the two regions, he noted that their reconnection was necessary to meet certain ends of mutual interests and benefits. President Mirziyoyev proposed an initiative for strengthening regional connectivity in the context of Uzbekistan's new open foreign policy strategy aimed at further deepening the economic cooperation in Central Asia with access to South Asia.

In his statement, the ECO Secretary General, H.E. Dr. Hadi Soleimanpour acknowledged the importance of common strategy for developing nexus approach to enhance interactions of regional players towards securing a better future. Salient features of his statement, inter alia, highlighted the significance of inter-regional connectivity to materialize the shared aims and objectives of the adjacent nations, underlining ECO's role for realization of the peoples' aspiration in wide range of areas, particularly, through development of transport and communications' network amongst its ten Central and South Asian Member States.



ECO Secretary General Meets with the **President** of Turkmenistan



On the invitation of the Government

of Turkmenistan, the Secretary General of the Economic Cooperation Organization, H.E. Dr. Hadi Soleimanpour paid an official visit to Ashgabat from June 28-30, 2021.

During his visit, the ECO Secretary General held a meeting with the honourable President of Turkmenistan, H.E. Mr. Gurbanguly Berdimuhamedov and explored the possibilities of developing the ongoing dialogue between the two sides for expanding multilateral cooperation and increased economic activities in the ECO region.

Felicitating H.E. Mr. Berdimuhamedov to assume ECO's Chairmanship for 2021, the Secretary General expressed his optimism that the Organization would enter into another phase of development under the kind patronage and visionary leadership of the honourable President of Turkmenistan. Dr. Soleimanpour also briefed the President about the preparatory arrangements being made for the next (15th) ECO Summit which is scheduled for November 28, 2021 in Turkmenistan. He expected highest level participation in the Summit by Member States, as well as ECO regional and global partners.

H.E. Mr. Gurbanguly Berdimuhamedov commended the Secretary General and his team for their active role in developing the Organization's agenda, as well as supporting Turkmenistan to facilitate the progressive activities of the ECO under their chairmanship.

He mentioned that Turkmenistan attaches huge significance to the ECO as an important regional economic forum, reaffirming country's continued and committed efforts

to secure the objectives of ECO Vision 2025 and the Organization's strategic aims in the pursuit of sustainable development and growth in the Region.

Dr. Hadi Soleimanpour also had a meeting with H.E. Mr. Rashid Meredov, Minister of Foreign Affairs of Turkmenistan.Their interactive talks, inter alia, touched upon ECO's engagements and activities within the framework of the Organization.

The main aspects of the concept developed by

Turkmen side for enhancing and accelerating ECO's functioning were also discussed during the deliberations.

The Foreign Minister recalled

that Turkmen side aims to continue the arrangements to prepare to host the next Summit on the ECO Day on November 28, 2021.

The meeting further witnessed Turkmenistan's joining of the Economic Cooperation Organization Framework Agreement on Trade Cooperation, which was signed by Mr. O. Gurbannazarov, the Minister of Trade and Foreign Economic Relations

of Turkmenistan.

During his visit, the ECO Secretary General also participated in the International Media Forum "Regional Dialogue with the Participation of Political Scientists and Journalists" held on June 30, 2021 in the Institute of International Relations of Turkmenistan and delivered his statement.



ECO Organizes the 5th Meeting of the Heads of National Statistical Offices of the ECO Member States



The 5th Meeting of the National Statistical Offices of the ECO Member States/7th High Level Expert Group Meeting on Statistics was organized virtually on 29th June 2021 by ECO Secretariat.

The Meeting was attended by the delegations of the Republic of Azerbaijan, Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Republic of Tajikistan, Republic of Türkiye and Turkmenistan.

The Deputy Secretary General of ECO, Ambassador Dr. Hüseyin Avni Biçakli, opened and chaired this high level Meeting.He noted that the ECO to regional economy was presently restoring its pre-covid19 pandemic sustainable normalcy. Along this path, the role of statistics was decmed as critical.

Establishment of ECO Statistical Network in 2011, further operationalized via ECOSTAT, presents bright evidence of cooperation among Member States in the area of statistical data & information sharing.

As with today's global realities tuned toward building post-pandemic resilient

economies, the emphasis was put on application of technologically new statistical analytics to produce real time numerical value of the extent and scope of the ECO Region's economic growth.

The Chairman of State Statistics Committee of Turkmenistan, Honorable Sylap Sh. Velbegov, highlighted the importance of statistics in policy development by presenting significant developments in Turkmenistan and, in that regard, stressed on sharing knowledge and statistical expertise accumulated by states at the ECO regional level.

Mr. Seyed Nematollah Mifrallah Nassiri, Deputy Head of the Statistical Center of the Islamic Republic of Iran (SCI) emphasized on the importance of knowledge sharing and statistical capacity building among ECO Member States and, in that regard, informed the Member States that SCI's Statistical Research and Training Center (SRTC) might provide the best of its practicebased expertise to ECO Member States.

Heads of Delegation of the ECO Member States delivered keynote state-



ments reflecting results-based statistical developments in countries while, at the same time, emphasizing the importance of addressing new technology-driven and thus modernized statistics' requirements via regional statistics, especially, on Business Register's development, FISIM with emphasis on Gross Value Added, Price Statistics and Tourism Statistics.

The previous proposals of the Member States on the Applied Statistics, Demography, Applied Statistical Research, GIS and System Development have met with the offer of technical support from within ECO. On the ECO Statistical Capacity Building Programme, the Member States appreciated that the project proposal is designed to introduce new technologydriven statistical tools and, that it had been supported by the five ECO Member States.

In this regard, they tasked the Secretariat to develop the consolidated project document based on the aforementioned proposal, being a collaborative effort of ECO and FAOSTAT.



— Azerbaijan Hosts the — 4th ECO Energy Ministerial Meeting



The 4th ECO Energy ECO_ Ministerial Meeting, hosted by the Republic of Azerbaijan, was held virtually on 24 June 2021. The Meeting was attended by delegations of the Islamic Republic of Afghanistan, Republic of Azerbaijan (host), Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Republic of Tajikistan, Republic of Türkiye, Turkmenistan and Republic of Uzbekistan as well as the Secretary General of ECO along with other relevant officials of the ECO Secretariat. Turkish Cypriot State as an observer to ECO also participated in the event. Delegates from Energy Charter, United Nations Industrial Development Organization (UNIDO) and Islamic Development Bank attended the meeting.

His Excellency Dr. Hadi Soleimanpour, the ECO Secretary General, delivered a welcome statement and noted that ECO had been undergoing paradigm shift in mainstreaming sustainable energy development. Establishment of ECO Clean Energy Centre, promotion of Regional Electricity Market and endeavours to enhance energy security in the ECO region are clear token of such efforts. He also pointed out great achievement that ECO Member States decided to put forward new Energy Strategy up to 2030.

Minister of Energy of the Republic of Azerbaijan (Chairman of the Meeting), His Excellency Mr. Parviz Shahbazov, extended felicities that new opportunities for green energy in the liberated territories of Azerbaijan and their positive impact on the climate change mitigation efforts have been acknowledged by the ECO Member States and reflected in the Baku Declaration. Besides, Minister Shahbazov acknowledged support for projects such as establishment of ECO Clean Energy Center, ECO Regional Electricity Market, as well as highlighted significance of new energy strategy as an important policy guidance to put forward regional energy



cooperation priorities of ECO Member States.

Head of delegations from Member States

delivered keynote statements emphasizing importance to enhance regional energy cooperation in clean energy, energy security, addressing UN SDGs as well as boosting business ties in the ECO region.

Earlier, on 22-23 June 2021, the 4th High Level Experts Group (HLEG) Meeting on Energy was organized virtually by the Ministry of Energy of the Republic of Azerbaijan.

Delegates from the Islamic Republic of Afghanistan, Republic of Azerbaijan (host), Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Republic of Tajikistan, the Republic of Türkiye, Turkmenistan and Republic of Uzbekistan, as well as, delegations from the ECO Secretariat, Energy Charter Secretariat and United Nations Industrial Development Organization (UNIDO) attended the meeting.



Mr. Rovshan Mirzayev, Director for Energy, Minerals and Environment of the ECO Secretariat welcomed the participants and noted that 4th HLEG meeting will consider future energy cooperation through validation of numerous documents of priority areas reflected as a follow up of "ECO Vision 2025".

By concurring in the proposed document

which will be sought to be endorsed by Energy Ministers of the ECO Member States on June 24, 2021 will pave a way result-oriented decision, which will guide our enhanced partnership in coming years.

The Member States discussed and approved a number of documents to give impetus to the future energy cooperation of the region.

Uzbekistan Hosts the 4th Meeting of ECO Heads of Anti-Corruption Organizations and Ombudsmen



The 4th Meeting of the Heads of Anti-Corruption Organizations and Ombudsmen of the ECO Member States was hosted by the Republic of Uzbekistan on June 16 - 17, 2021. The event, organized in Tashkent, was attended by delegations of all Member States. The ECO Deputy Secretary General, Ambassador Jandos Asanov and his delegation participated in the meeting virtually.

While inaugurating the meeting the Chairperson of the Senate of the Parliament of the Republic of Uzbekistan Her Excellency Ms. Tanzila Nurbaeva welcomed the event's participants. She informed the meeting about the work that is being carried out in Uzbekistan on uprooting corruption.

In his statement, Ambassador Asanov felicitated the Republic of Uzbekistan for hosting this important meeting, extending his warm gratitude to the Chairperson of the country's Senate for attending and opening the meeting. He commended the Uzbekistan's notable endeavours against corruption under the patronage and leadership of the honourable President of Uzbekistan His Excellency Mr. Shavkat Mirziyoev, acknowledging the country's excellent contributions to secure ECO's aims and objectives towards sustainable development in the region. Relevantly, J. Asanov recalled the views of President Mirziyoev expressed during the 14th ECO Summit that emphasized, inter alia, on the significance of the region's transit-transport sector, conveying ECO's full support and cooperation to Uzbekistan in all its efforts for regional progress and prosperity.

During the Meeting, the Member States agreed to: (i) expedite national procedures for signing/ratification of the Statute of the ECO Regional Center for Cooperation of Anti-corruption Agencies and Ombudsmen (RCCACO) and its early Operationalization as an effective and useful forum to achieve desired results against corruption as well as other forms offinancial crimes; (ii) organize training events concerning fight against corruption on regular basis; (iii) create a smart regional structure for transparency in the fight against corruption; (iv) organize the first Meeting of the General Assembly of the States Parties to RCCACO. The Member States also discussed various ways and means of strengthening mutual cooperation, as well as explored the possibilities for exchange of relevant information/experiences and sharing best practices on fight against corruption.

It was also deliberated to hold the Donors' Conference for Afghanistan as well as the ECO Day Program on the sidelines of next ECO Summit.

The honourable Minister emphasized on continuation of existing dialogue between Turkmenistan and ECO, assuring their full support to the Organization to boost regional progress and prosperity as well as overall socioeconomic development in the region. While appreciating the ECO Secretary General for facilitating and organizing several ministerial and other important events under their chairmanship, he invited him to visit



Turkmenistan for the extension of the ongoing negotiation process.

The ECO Secretary General re-acknowledged the valuable guidelines of the honourable President of Turkmenistan, H.E. Mr. Gurbanguly Berdimuhamedov given during the 14th ECO Summit, underscoring that the organization is well-prepared to make smooth implementation of its prioritized tasks in special consideration of the guidance provided by the honourable President.

The event also entailed some interactive segments between the relevant directorates of the ECO Secretariat and heads and representatives of the concerned ministries as well as agencies of Turkmenistan to touch upon the potential areas of regional cooperation, including trade, transport, energy, environment, agriculture, industry, human resources and sustainable development.

ECO Secretary General Participates in the 2nd OIC Summit on Science and Technology



On the invitation of the Organization of Islamic Cooperation (OIC), the Secretary General of the Economic Cooperation Organization (ECO), H.E. Dr. Hadi Soleimanpour participated in the 2nd OIC Summit on Science and Technology. The Summit was held virtually on 16 June 2021 under the chairmanship of Government of United Arab Emirates to review the implementation of OIC STI Agenda 2026.

The Heads of State and Government of the OIC Members acknowledged the efforts made by the leadership of the Republic of Kazakhstan in its capacity as Chairman of the First OIC Summit on Science & Technology for increasing Islamic Solidarity and cooperation in various fields, particularly for the scientific and technological progress of the OIC Member States.

The Heads of State and Government of Member States of the OIC appreciated the leadership of H.E. Arif Alvi, the President of the Islamic Republic of Pakistan and Chairman of COMSTECH for promoting intra–OIC scientific and technological cooperation, coordinating the efforts of Member States and relevant OIC institutions for the implementation of OIC STI Agenda 2026 and advancement of science, technology and innovation in the Member States, especially the Least Developed Countries (LDCs).

The OIC Member States recognized that promotion of science, technology and innovation is crucial for addressing the contemporary challenges of development, poverty eradication, environment, education for all, climate change, human health, and energy and water resources. The Summit also identified the importance of increasing intra-OIC as well as regional and international links to strengthen institutional capacity and human resource development in the Member States through targeted capacity-building and financial assistance so that the Member States can benefit from the technological advances and subsequently create, comprehend, adapt and use science, technology and innovation for the sustainable development of their people.

In his letter to H.E. Dr. Soleimanpour, the OIC Secretary General, H.E Dr. Yousef A. A. Al-Othaimeen thanked the ECO Secretary General for his participation in the 2nd OIC Summit on Science and Technology. The OIC Secretary General underlined the importance that the OIC attached to the ECO as a brotherly organization and expressed his desire for further close cooperation between the two organizations for benefit of the common member states

Pakistan Hosts the 2nd PAECO's General Conference

The 2nd General Conference of the Parliamentary Assembly of Economic Cooperation Organization (PAECO) was hosted by the National Assembly of the Islamic Republic of Pakistan on June 1-2, 2021,

In his inaugural statement, H.E. Dr. Arif Alvi, the President of Pakistan expressed his deep pleasure in welcoming the ECO parliamentary delegations. He noted that trade and connectivity could play a central role in ensuring consistent and unified regional progress, prosperity and development, adding that the inter-regional economic integration has got momentum in the past few decades, becoming priority of the governments to improve the quality of their peoples' lives. The President conveyed his firm conviction, stating that PAECO's initiatives towards viable regional integration through an open trade market within the region; an easy visa regime; promotion of an advanced communication, connectivity and transport, could noticeably develop peopleto-people interactions and lead to sustainable development and poverty alleviation in the region.

The event's inaugural session comprised a welcome address of the



Speaker National Assembly of Pakistan H.E. Mr. Asad Qaiser and statements of chairpersons of parliaments of Afghanistan, Azerbaijan, Iran, Tajikistan, Türkiye, Turkmenistan and Uzbekistan. Delegation of Majilis (lower house) of Parliament of Kazakhstan participated in the conference virtually.

While addressing the ECO Parliamentarians as Chief Guest of the Conference's conclusive session, the Prime Minister of the Islamic Republic of Pakistan, H.E. Mr. Imran Khan accentuated that parliamentary dialogue amongst the ECO Parliaments would help bring the most desirable issues to the forefront of discussions. He expressed optimism that PAECO's conference would prove to be defining moment towards making this parliamentary forum fully operational by ratifying its Charter, identifying a viable roadmap for the respective governments of all the ECO Member States. Expressing his deep concerns over the disastrous environmental issues, he urged the ECO Member States to take concrete decisions to contain adverse effects of the climate change to preclude any difficulties in the future.

Dr. Hadi Soleimanpour, the Secretary General of ECO who participated in the event virtually, underscored the significance of PAECO as an important ECO pillar. He briefed the Conference about some recent activities and engagements of the Organization, especially in the six prioritized areas of mutual cooperation, including trade, connectivity, energy, tourism, economic growth and sustainable development.

While acknowledging the fundamental role of PAECO to support and push the ECO's agenda of regional development, Dr.

The Conference had four thematic sessions that included (i) Women in Leadership Roles: Leading the Agenda of Regional Connectivity; (ii) Impact of Covid-19 on SDGs implementation in the region; (iii) Role of Parliaments in enhancing Trade & Connectivity and; (iv) Advancing Tourism for Development and Poverty Alleviation. Three committees were also formed to deliberate on issues of trade, communication and connectivity, women, youth and cultural affairs.

Soleimanpour particularly sought the Parliamentarians assistance to expedite the institutionalization of regional parliamentary cooperation, speeding up the ratification process of the PAECO's Charter as well as some core ECO Agreements.

The ECO Secretary General further emphasized that a strong and well-structured regional connectivity was genuinely needed for also adopted by the Conference. The main focus of the adopted document is to underscore the importance of transit trade, reducing the cost of doing business, and financial infrastructure in expanding intra-regional trade volumes. It further emphasizes on the need of simplification of visa processes for businessmen and tourists. Türkiye Organizes a Consultative Meeting on

ECO Regional Electricity Market

A Consultative Meeting on "ECO Regional Electricity Market" project was held virtually on May 31, 2021.

The Meeting was organized by the Republic of Türkiye and attended by the representatives of Azerbaijan, Iran, Türkiye to assess the possible cooperation opportunities in further stage of project. The ECO Secretariat facilitated the event and took part in the meeting by extending its vision and presentation on the status of electricity interconnections in Central Asia, Afghanistan and Pakistan.

Ambassador Dr. Huseyin Avni Bicakli, Deputy Secretary General, while delivering the opening remarks, stated that enhancement of regional electricity trade can initially be realized via strengthening intra-regional trade in sub-regional markets, where an interconnected grid already exists but much needs to be adjusted to ensure adequate supplies of energy and security of supply.

Another important advantageous element in interconnecting the power systems of the ECO Member States is the potential of regional power exchange, instead of only as a power export opportunity for the ECO Member States. He also clarified that role of international partners is instrumental to attract financial and technical support to the ECO-REM Project.

Dr. Öztürk Selvitop, Director General of Foreign Relations, Ministry of Energy and Natural Resources of the Republic of Türkiye, stressed in his opening remarks the importance of energy supply security and ensuring the stability and flexibility of the countries' energy sector, in particular with key significan of interconnections. Also, he emphasized efforts for evaluating and improving opportunities for international collaboration.

On behalf of Iranian delegation, Mr. Mohammad Ali Farahnakian, Adviser to the Minister for International Affairs and Head of the Center for International Affairs and Coordination of Water and Electricity Diplomacy, Ministry of Energy of the Islamic Republic of Iran, mentioned that Iran Ministry of Energy will comprehensively support initiating the ECO-REM. He emphasized that based on the previous agreements, initiating a pilot electricity market between Iran and Türkiye can speed up the development of the overall ECO-REM idea.

The experts from Azerbaijan, Iran and Türkiye, as well as ECO Secretariat delivered presentations covering the issues such as, recent developments in the electricity market of ECO region, regional electricity interconnection status and system operation activities.

ECO Proposes Enhanced Collaboration with the **RCUWM**

The 12th Governing Board Meeting (GMB) of UNESCO's Regional Centre on Urban Water Management (RCUWM) held virtually on 26 May 2021, with the participation of delegations from 18 countries. Representatives of 9 international and regional organizations including the Economic Cooperation Organization (ECO) also participated in the Meeting.

Regional Centre on Urban Water Management (RCUWM-Tehran) has been established under the auspices of UNESCO since 2002 in Tehran. The 12th GBM was attended by the relevant Ministers of Afghanistan, Bangladesh, Iran, Sri Lanka, Syria and Tajikistan; while Oman, Pakistan, Qatar and Türkiye participated in the meeting through their concerned deputy Ministers.

The meeting discussed several important issues including joint projects and transfer of experiences in the field of essential quality assured data and information for integrated urban water management, support for the development of water startups, and the use of new technologies in unconventional water management as well as task sharing between the interested member states on the approved proposals during the last GBM held in September 2020.

In his remarks, Head of International Relations Section of the ECO, Mr. Muhammad Farooq, appreciated the UNESCO and the government of Islamic Republic of Iran for their excellent contribu-



tions in the smooth and efficient functioning of the centre. He further recommended enhanced collaboration between the RCUWM and the ECO for extending regional cooperation in the relevant fields.

In the concluding Remarks, Chairman of the Governing Board, H.E. Mr. Reza Ardakanaian, Minister of Energy of I.R. of Iran, while thanking all the delegates for their active participation in the meeting, requested the member states and the relevant organizations to cooperate in the joint activities and projects of the Centre.

The 5th ECO Ministerial Meeting on

Finance and Economy was hosted virtually by Republic of Tajikistan on May 25, 2021. The Minister for Economic Development and Trade of Tajikistan, H.E. Mr. Zavqizoda Zavqi Amin chaired the event.

The relevant ECO Ministers/Deputy Ministers, high-level Representatives of the Member States, ECO Secretary

General, H.E. Dr. Hadi Soleimanpour and his delegation participated in the meeting. The President of ECO Trade and Development Bank, Mr. Yalcin Yuksel, along with his team as well as the Secretary General ECO-CCI, Mr. Adem Kula, also attended



the event.

The Minister for Economic Development and Trade of the Republic of Tajikistan underscored the importance of the meeting which was aimed at expanding the scope of existing cooperation and engagements

amongst the Member States as well as reviewing the overall pre/post-pandemic economic and financial conditions of the region. He appeared poised to express that the high-level interaction would yield desirable outcomes to gratify and jack up the economy of the region that is transiting through a strained phase due to the ongoing COVID crunch.

The ECO Secretary General, while recalling the aims and objectives of the Izmir Treaty, underlined



the ministerial meeting for the greater regional integration, giving a fresh impetus to the pace of multilateral economic activities in the region. He noted the essentiality of the event in special consideration to gauge

the organization's progress and performance in the area of finance and economy. Dr. Soleimanpour also acknowledged the committed contributions of the Member States for laying and maintaining the strong foundation of the ECO.

The meeting featured various ways and means of multifaceted economic and financial cooperation to maximize the utilization of available regional potentials for shouldering the process of socioeconomic recovery in the region during the time of crisis. Among other central issues, the participants considered an accelerated implementation of ECO Trade Agreement (ECOTA), trade liberalization policies to attract FDI in the region, expansion of membership of the Agreement on Protection and Promotion of Investment (APPI) as well as ECO Reinsurance Company (ERI) to host a secure environment for investment in the region.

> The ECO Secretary General, H.E. Dr. Hadi Soleimanpour, participated in the 77th Session of the Economic and Social Commission for Asia and the Pacific (ESCAP) held virtually on 28 April 2021. The theme for the session was "building back better from crises through regional cooperation in Asia and the Pacific".

> In the opening remarks of the Session, the Executive Secretary of ESCAP, Dr. Armida Salsiah, highlighted the importance of multilateralism in the aftermath of COVID-19 and articulated that regional and sub-regional approaches could contribute significantly towards success of the multilateralism. She shared some of the latest activities of ESCAP aiming at the economic recovery and social protection in Asia and Pacific.

In his statement delivered during the session, the ECO Secretary General, Dr. Hadi Soleimanpour, underlined the significance of building resilient and sustainable societies through collaborative efforts at regional and sub-regional levels for bringing swift socio-eco-



nomic recovery in the aftermath of the COVID-19 pandemic and reducing vulnerabilities to future crisis. He stated that the pandemic has reshaped regional and global socio-economic trends and recommend that in order to maintain their meaningful relevance in the present international scenario, the regional organizations should act regionally while engaging globally.

The ECO Secretary General shared some of the key measures being taken by the ECO and its member states for enhanced regional cooperation in alleviating the adverse socioeconomic impacts of the pandemic and transforming the ECO region a resilient region through intra and inter-regional collaboration in order to strengthen the preparedness for a more coordinated response in future. While highlighting the role of ESCAP in promoting intra-regional collaboration to advance common goals, Dr. Soleimanpour emphasized the importance of technical and financial assistance of ESCAP for ECO's programmes and projects. He also encouraged the ESCAP to explore partnerships to finance joint projects for infrastructural development, trade facilitation, clean energy and combating climate change for ensuring regional sustainable development and resilient regional economies in the aftermath of the COVID-19.

Türkiye Hosts the ECO Ministerial Conference Disaster Risk Reduction





The 8th ECO Ministerial

Conference on Disaster Risk Reduction (DRR) was virtually hosted by the Republic of Türkiye on March 17, 2021 under the chairmanship of the honourable Minister of Interior of Türkiye, H.E. Mr. Süleyman Soylu. The event, organized by Disaster & Emergency Management Presidency (AFAD) of the Ministry of Interior of Türkiye, was attended by high-level Representatives of the ECO Member States. The ECO Secretary General, Dr. Hadi Soleimanpour and his delegation also participated in the Conference.

The Acting President of AFAD, Mr. Hamza Tasdelen, while inaugurating the Conference, underlined the importance that AFAD attaches to the multinational collaboration for reducing the regional disaster risks. He underscored that the world was living in an age, where the impacts of natural and human-induced disasters are on the rise. Mr. Tasdelen conveyed that the

current hazards such as fast and irregular urban sprawl, increasing population, climate change and pandemics/diseases were all threatening us and the peoples of the world. He considered that the most fundamental instrument to combat such threats was to identify these challenges in every walk of life, ensuring the preventions to be in place.

The AFAD's Acting President believed that the 8th ECO Ministerial Conference on DRR would reinforce regional cooperation and partnership towards the reduction of risks, expecting the outcomes of the event to be contributing for future of the region.

Dr. Hadi Soleimanpour, the ECO Secretary General, thanked the host authorities for making excellent

arrangements to organize the Conference. He underlined that the ECO region had been undergoing repeated natural disasters, including earthquakes, landslides, drought, and floods, stating that the empirical evidences and scientific findings transpired the vulnerability of the region to be prone to adverse events in future.

Dr. Soleimanpour said that the region's exposure to various natural calamities was intensified due to the rapid climate

change and increased urbanization that continued to hamper region's socioeconomic progress with a notable toll on human capital. The ECO Secretary General recalled the Member States' efforts for discovering some intra-regional ways and means to meet such challenges.

The ECO Secretary General noted that the jointlydeveloped documents, including the ECO Regional Framework on Disaster Risk Reduction and its relevant roadmap as well as Ankara Declaration to be adopted by the Conference were expected to play a pivotal role in securing the desired aims and objectives on DRR.

H.E. Mr. Süleyman Soylu, Minister of Interior of Türkiye, while explaining the concept of globalization, warned that its experiences in technology and communications were not enough for a safer and wealthier world. Illuminating the helplessness of the developed countries, which were supposed to overcome any such challenges, he noted that they were most affected by the pandemic. He emphasized that the process of globalization should not only be the of wealth creation but also security and peace, focusing on transnational cooperation in trade and development, every security issue, goodwill, right to life and sincerity, including

each kind of disasters.

The Minister acknowledged the effectiveness of cooperative activities and shared experiences as well as risk reduction plans that helped reduce the possible damages of such disasters. He mentioned some of Türkiye's initia-

tives, projects and programs for mitigating and responding natural hazards to create a more resilient society, pointing out that creating a society resistant to disasters was also an important component of economic development.

The 8th ECO Ministerial Conference adopted the ECO Regional Framework on Disaster Risk Reduction (ECORFDRR) and its implementation roadmap as well as the Ankara Declaration as ECO's main documents on disaster risk reduction.







ECO and Eurasian — Regional Bodies — Hold a Joint Virtual Meeting

A joint virtual meeting ECO_ was held amongst the Secretaries General of the Economic Cooperation Organization (ECO), International Road Transport Union (IRU), the Permanent Secretariat of the Intergovernmental Commission TRACECA (PS IGC TRACECA), the Organization of the Black Sea Economic Cooperation (BSEC) and the Cooperation Council of Turkic-Speaking States (Turkic Council). The event, held on March 15, 2021, was aimed at elaborating the impact of COVID-19 as well as figuring out the possible ways forward to minimize the bearings of the pandemic on the road cargo transportation.

The ECO Secretary General, H.E. Dr. Hadi Soleimanpour considered that the prolonged shutdowns and restrictive policies would bear negative effects on the prospects of short-term intra-regional economic growth. He underscored that the ECO region already experienced post-pandemic slow-paced economic activities, including in the transport sector due to the imposition of preventive measures. Dr. Soleimanpour hoped that the impacts of this untoward situation could be overturned through resorting to a strong international cooperation and solidarity as well as collaborative, transparent, science-based and coordinated global and regional response. He pointed out that the central issue for regional economic organizations is to remain relevant under pandemic crisis. Relevantly, these Organizations need to

"think globally while act regionally" he added. To this end as well as regarding the area of connectivity, the ECO steers to concentrate on turning some selected Regional Transit-Transport corridors into Economic ones based on the proposal made by honourable President Berdimuhamedov of Turkmenistan after his country's assumption of ECO chairmanship.

Dr. Soleimanpour updated on some immediately taken steps that bore instant implications to resume activities for regional connectivity and smooth socioeconomic recovery in the region, including the adoption of ECO Practical Guidelines on Cross Border Facilitation Measures under conditions of COVID-19. He thanked the IRU to help successfully launch a test run of loaded trucks in July 2020 that carried goods under TIR carnets along the Kyrgyz-Tajikistan-Afghanistan-Iran (KTAI). He also acknowledged the importance of digital transport solution i.e. e-TIR and E-CMR in freight transport and the benefits of their inter-modality.

The meeting expressed concerns over the post-pandemic restrictions that severely affected the intra-regional and inter-region-

al trade in goods, hampering essential supply chains and smooth movement of cargo drivers at the border crossing points. During their online interaction, the Secretaries General noted that many road transport operators, particularly small and mid-size firms, were on the verge of bankruptcy, encouraging concrete measures to help avoid their imminent liquidity crisis. It was emphasized that the transport workers required equal protection and priority for inoculation against the pandemic. The meeting recommended a well-coordinated approach to be adopted for a digital COVID test or passport for commercial drivers, seeking the creation of a network of designated focal points of the Member States for enhanced coordination and collaboration.

The meeting further agreed on the implementation on IRU's Call for Action, urging the national governments for coordinated response to mitigate the negative effects of the pandemic, provision of financial support to their road transport operators, harmonized border crossing procedures and preferred utilization of digital trade facilitation tools.

1st Joint <u>ECO</u> Meeting by Iran, Pakistan and Turkey on activation of Technical Management Boards of ECO-RISCAM was virtually held on March 10, 2021. The 1st Joint Meeting by Iran, Pakistan and Turkey for discussions and decision concerning the activation of Technical Management Boards of ECO-RISCAM virtually hosted by Institute of Standards and Industrial Research of Iran (ISIRI), was attended by the Representatives of the Islamic Republic of Pakistan, Republic of Turkey, ECO Secretariat and ECO-RISCAM. Dr. Alireza Khakifirouz, President of

Iranian National Center of Accreditation chaired the meeting.

The meeting discussed, inter alia, activation of Technical Management Boards. Other issues taken into account during the interaction were activities in the area of standardization, conformity assessment, accreditation and metrology in 2021-2.

The Statute of ECO Regional Institute for Standardization, Conformity Assessment, Accreditation and Metrology (RISCAM) was approved by the 18th Council of Minister (COM) along with the Road Map for its provisional implementation. The official opening ceremony of the Central Secretariat of ECO- RISCAM and its Technical Management Board of Conformity Assessment was held on 14 December, 2016 in Tehran, Iran. The Secretariats of the Technical Management Board (TMB) of Standardization and Accreditation will be located in Turkey, Metrology in Pakistan and Conformity Assessment in Iran.

The ECO Vision 2025 has mandated the ECO-RISCAM to work for developing industrial standards and encouraging of green industries and services for the region.

The participants agreed to make all possible efforts for an increased level of cooperation and collaboration in the relevant areas of activities.

During the inaugural session of the Symposium, the ECO Secretary General delivered his opening speech and thanked the organizers for providing an opportunity to the relevant stakeholders, academics and intellectuals for exchanging views in order to meet the challenges of the contemporary world in the field of education and research. Dr. Soleimanpour highlighted the importance of close cooperation among the ECO Member States in education and research for realization of the Organization's strategic goals.

The delegates acknowledged the efforts and valuable contributions of the ECO Secretariat. FCO Cultural Institute and the Allahmeh Tabataba'i University of Iran for successful organizing this important Symposium.

In the concluding session of the Symposium, a special discussion session was arranged where the participants provided their views and shared their experiences for enhanced regional cooperation in the field of education and research in the wake latest challenges of the globalized world.

The 14th ECO Summit



The Republic of Turkey organized the 14th ECO Summit virtually on March 4, 2021 under the chairmanship of H.E. Mr. Recep Tayyip Erdogan, the honourable President of the Republic of Turkey. The event, convened under the theme of 'Regional Economic Cooperation in the aftermath of COVID-19, was inaugurated by H.E. Mr. Imran Khan, the honourable Prime Minister of the Islamic Republic of Pakistan.

All the ten ECO Heads of States and the ECO Secretary General, as well as the ECO Observers, including the President of Turkish Cypriot State, Secretaries General of the Turkic Council and International Energy Charter were present in the Summit.

H.E. President Erdogan, while acknowledging the significance of ECO for regional development, emphasized on the early implementation of ECO

Trade Agreement (ECOTA) and other progressive initiatives aimed at pushing the process of development in the region. He noted that the COVID-19 pandemic gravely damaged the global economy and trade, straining on the existing healthcare system. President Erdogan said: "we can only win the fight against this global debacle through strong solidarity, regional and international cooperation." He underscored that during Turkey's Chairmanship of the Organization, the country had remained focussed on consolidating the organization and advancing regional cooperation. He felicitated H.E. Mr. Gurbanguly Berdimuhamedov, the honourable President of Turkmenistan for assuming the chairmanship of the ECO for 2021, extending his best wishes for the country's success as new ECO Chair.

The honorable President of Turkmenistan, H.E. Mr. Gurbanguly Berdimuhamedov, expressing thanks for the assigned responsibility, assured of his country's complete support to secure the organization's overall aims and objectives. Voicing the priority vectors of cooperation within the framework of Turkmenistan's chairmanship of the ECO, he underlined his country's intention to promote the organization's work, focussing on the development of economic, cultural and humanitarian ties. He added that unfolding of the trade, transit-transport, energy, industrial and communication potential of the ECO would remain in the center of Turkmenistan's strategy during their chairmanship of the Organization. President Berdimuhamedov considered the establishment of economic corridors as a system of sustainable routes for the movement of goods, services, investment and industrial cooperation as well as energy corridors for diversification of energy resources supplies in the region, as Turkmenistan's key mission, with participation of Member States. endorsement of the Guidelines by honorable ministers.

The ECO Guidelines on Cross Border Facilitation Measures have been approved by the 247th Meeting of the ECO Council of Permanent Representatives (CPR), the Secretary General recalled.

Connectedly, Dr. Soleimanpour sought the consideration of the Ministers for implementation of the framed guidelines, as well as

creation of 'TIR EPD green lanes' along the region's main transport routes for an expeditious movement of goods on the BCPs. While referring to the need for implementation of ECO Transit Transport Framework Agreement (TTFA), he further conveyed the latest status and future planings for other ECO arrangements on different modes of transport. including railways, roads, maritime and civil aviation.

The Chair of the event and Minister for Road and Urban Development of the Islamic Republic of Iran, H.E. Mr. Mohammad Eslami, appreciated the Member States for their cooperative role to maintain and facilitate the regional trade and transport activities on region's BCPs.

Other participating Ministers and Deputy Ministers of the Member States also spoke to maximize their cooperation, especially in the COVID's crunch, to meet the emerging regional challenges.

The meeting, while acknowledging the severity of the crisis and meet the

region's immediate needs and requirements, adopted the recommended ECO Guidelines, as well as a 2020 Ministerial Declaration on transport which was considered by the relevant High Level Working Group's meeting on December 8, 2020.

The Declaration requested Member States to fully implement the ECO Transit Transport Framework Agreement (TTFA), and fulfill



their commitments as per TTFA provisions. The Document appreciates Member States for their constructive role during COVID-19 pandemic by keeping their borders open and facilitating transport and trade in the region, congratulating the Member States on the successful Test Run of the loaded trucks under TIR in KTAI Road Corridor during July -August 2020. It further tasks the ECO

Secretariat to initiate new projects on Railway, Maritime and Civil Aviation cooperation in 2021.

Secretary General Participates in the Third Asia-Pacific Forum

On the invitation of the UNESCAP, the Secretary General of the Economic Cooperation Organization, H.E. Dr. Hadi Soleimanpour participated in the Third Asia-Pacific Forum for South-South and Triangular Cooperation. The event jointly organized by ESCAP, UNOSSC, Government of Indonesia as well as the Thailand International Cooperation Agency (TICA) was held on November 25, 2020 under the theme of "The Role of South-South Cooperation in Building Back from COVID-19 Pandemic in Asia and the Pacific.

Addressing the Forum, Dr. Soleimanpour underlined some of the ECO's post-COVID experience and

practices, conveying the immediate measures taken to counter the negative impacts of the ongoing pandemic on the region, including the initiative for establishing an all-inclusive consultative mechanism for regional health sector. Considering the adverse effects of the pandemic on transport sector, the ECO Secretariat developed some guidelines on cross border facilitation measures for the maintenance of essential supply chains to support the region's livelihood, the ECO Secretary General conveyed.

He further highlighted the strong and active cooperation between the ECO Secretariat, Member States and relevant international institutions to meet the urgent needs of the most vulnerable and affected countries in the region.

While acknowledging the importance of the role of South-South and Triangular Cooperation in the post-COVID scenario, Dr. Soleimanpour noted that the South-South and Triangular Cooperation could be instrumental to bring a degree of relief to the most affected developing nations. He stressed that any medicines or medical discoveries needed to be shared widely, ensuring their availability to all, preferably to most vulnerable countries.

Forum's participants, inter alia, discussed and explored the ways and means to meet the negative consequences of COVID-19 pandemic, including the significance and role of South-South and Triangular Cooperation in this regard.

Regional Seminar on **Geographical** Indications

An ECO delegation headed by Dr. Sayed Yahya Akhlaqi, Deputy Secretary General, participated in the Regional Seminar on Geographical Indications (GIs) held virtually on November 18, 2020. The event under the theme of Distinctive Signs for "Origin-Based Products: Geographical Indication, Collective and Certification Marks" was hosted by the Intellectual Property Center (IPC) of the Islamic Republic of Iran, in cooperation of the World Intellectual Property Organization (WIPO), organizer of the Seminar. High-level Representatives from ECO Member Countries also attended the seminar.

In his statement Dr. Akhlaqi emphasized the aspects of the event covered under the umbrella of Geographical Indications, including (I) Protection of Distinctive Signs for Origin-Based Products, (II) Creating Commercial Value through Connecting Goods to their Geographical Origin: Challenges and Opportunities, (III) Systems of Protection for Origin-based Product and (IV) Protecting Geographical Indications Abroad.

While highlighting the importance of Distinctive Signs for Origin-Based Products, he underscored that trainings and exchange of expertise are the bases for expanding cooperation amongst the Member States and other International Organizations. He noted the essentiality of the role of national IP offices for developing nexus in order to accelerate the process of cooperation in the relevant area of activity.

The Member countries and heads of delegations also delivered their reports/representations on different aspects of the Geographical Indications.

ECO Participates in a Trilateral Meeting on KTI Railway Corridor

A trilateral review meeting on the project for commercialization of Kazakhstan-Turkmenistan-Iran Railway Corridor (KTI) was held virtually on October 28, 2020. The representatives of the Islamic Republic of Iran, Republic of Kazakhstan and Turkmenistan, as well as relevant officials of the IsDB, ESCAP, ECO and OSJD participated in the meeting.

In the opening remarks, Mr. Kanan Nazarov, ECO Deputy Secretary General, while expressing satisfaction with the ongoing activities on the study project, stated that proposed MoU is believed to serve a solid basis for future and uninterrupted interaction between the en-route countries. He also hoped that the future phases of the Study Project would result in transforming the present KTI railway corridor into a competitive, vibrantly developing economic corridor with its all necessary prerequisites to provide livelihood, vital employment, and cumulative benefits for multiple users in the Member States.

The UNESCAP's Representative, while stressing the significance of the Event, highlighted the interest and huge investments made by the railways of en-route countries to make this route physically feasible and their efforts towards development of the Corridor which is believed to be very important railway connectivity for the Central Asian region and beyond. ESCAP is also hoped to IsDB's future collabo-



ration to enable the steps forward and ultimately convert it into an economic corridor.

The Representative of the Islamic Development Bank, while noting their collective success on the project, recalled that the final goals of the project are to develop and commercialize the corridor. Recalling IsDB's commitment to the project, considering it to be on priority of the Bank, Bank's readiness for the physical finances at poststudy phase was also noted.

The meeting agreed that the MoU would not create any new legal issue for the relevant countries and the MOU urges upon all parties to use the existing OSJD legal instruments on railway transport unless decided by all countries otherwise. The Meeting decided to allow a two-week time for securing formal views of the relevant authorities of the en-route countries on the MoU

The en-route countries also agreed that the future phases of the Study Project should be result-oriented towards the transformation of the present KTI railway corridor into an economic one with all its prerequisites including, inter alia, developing economic hubs/zones at the areas adjacent to the border crossings points of KTI route, keeping in view the Khorgos, the special trade zone/dry port on the Kazakhstan-China border, as one of the best practices in the region.

News in ECO

ECO Secretary General Participates in the in the Baku International Energy Charter Forum

On the invitation of International Energy Charter, a delegation of the ECO headed by the ECO Secretary General H.E. Dr. Hadi Soleimanpour, participated in the Baku International Energy Charter Forum held virtually on October 28, 2020 under the theme of "Transition to renewables in power generation, transport,



heating and cooling: modern challenges and trends".



In his statement at the high-level ministerial session, Dr. Soleimanpour expressed his deep concerns over the recent attacks on the strategic energy and transport infrastructure of Azerbaijan, worrying that such an offensive tendency could be detri-

mental to overall regional energy security.

The ECO Secretary General also expressed his condolence to the Government and the People of Azerbaijan for the martyrs who sacrificed their lives in recent episodes of the conflict.

He emphasized on the importance of peace and stability in the region in order to achieve the envisioned regional development goals, supporting the peaceful settlement of the dispute based on the international principles of sovereignty, territorial integrity and inviolability of recognized borders.



The ECO Secretary General underlined the ECO's efforts to pave the way for diverse and resilient regional energy architecture, mainstreaming the sustainable energy transition in the organization's overall energy agenda and transformation to clean energy sources. He underscored the ECO's commitment to "Affordable and Clean Energy" under the Sustainable

Development Goal-7, adding that transformation to renewable modes as well as cleaner and sustainable energy sources, portrays one of the expected outcomes perceived in the ECO Vision 2025.

Dr. Soleimanpour also mentioned the organization's current process for the establishment of ECO Clean Energy Center and ECO Regional Electricity Market as explicit examples of ECO's efforts in the field of energy cooperation.

The ECO Secretary General invited international partners seeking their

cooperation to enrich the ECO's recent initiative for the formation of new Energy Strategy which is aimed at providing a comprehensive direction for transformation of energy mix to reliable, sustainable, resilient and reformed energy market amid new dynamics on the global energy prospects.

ECO Delegation Attends 28 th Executive Committee & 18th General Assembly of ECO-CCI

ECO Delegation Attends the 28th Executive Committee & 18th General Assembly of ECO -CCI, held on 19th October' 2020.

The 28th Executive Committee & 18th General Assembly of ECO Chamber of Commerce and Industry (ECO-CCI) held on 19th October, 2020 in a virtual mode.

An ECO delegation headed by H.E. Dr. Hadi Soleimanpour, Secretary General of the ECO, participated in the event. In his statement, Dr. Soleimanpour expressed his deep concern over the flagrant violation and breach of internationally recognized humanitarian law and recent military attacks on the civilian population and residential areas in the Ganja city, Azerbaijan. Whilst extending deep condolences over the loss of precious human lives in this historical city, he paid tribute to the bravery and martyrdom of Azeri soldiers who sacrificed their lives to defend territorial integrity and sovereignty of Azerbaijan, recognized by international community through various UN resolutions.

The ECO Secretary General underscored the importance of regional private sectors as a driver of sustainable economic growth and enhanced trade & investment, leading to job creation and poverty alleviations, as set forth in the ECO Vision-2025. Dr. Soleimanpour highlighted the need for a more proactive role of the private sectors through national chambers with a closer liaison with their governments to remove the impediments in regional trade integration and formulate uniform policies to create Regional Value Chains (RVCs). In this context, he suggested to the national chambers to pursue signing and ratification of "ECO Agreement on Promotion and Protection of Investment (APPI)" as well as operationalization of "Articles of Agreement of the ECO Reinsurance Company". He also suggested to national chambers of the non-signatory Member States to consider joining these two forums for increasing 'secure' investment.

Dr. Soleimanpour shared that the ECO has launched Small Scale Studies projects on trade facilitation, reduction in tariffs and removal of non-tariff barriers (NTBs). Referring the negative repercussions of COVID-19 on the region's economy, he stressed the need for joint efforts to face challenges in the post pandemic era. The need to harmonize measures related to Covid-19 to facilitate trade in goods and services in hard hit sectors like transpiration, hospitality, travel and tourism etc, was also emphasized.

The Secretary General of ECO shared the idea that ECO-CCI may set up a regional task force to coordinate with private sectors and business communities across the ECO region, identify policy and production gaps in the wake of pandemic and recommend more realistic and uniform set of policies to regulate trade and investment, support long term development of RVCs and establish their linkages with GVCs. The task force may also study the potential for harmonization of standards like testing and certification for Covid-19 and measures on Sanitary and Phyto-Sanitary (SPS) and Technical Barriers to Trade (TBTs) to regulate movement of people, goods and services.

Energy Charter Secretariat and the ECO Secretariat Jointly Organizes a Virtual Workshop

The Energy Charter Secretariat in cooperation with the ECO Secretariat organized a virtual technical workshop on 14 October 2020 on the theme of "Perspectives and Challenges of Regional Electricity Markets: Harnessing Trade and Investment Opportunities". The event brought together over forty government officials and energy experts from ECO Member States as well as international and regional organizations.

The objective of the workshop was to discuss international experiences on integration of power markets as well as the challenges and perspectives of developing ECO Regional Electricity Market (ECO REM). The representatives of the European Commission, Eurasian Economic Commission, World Bank and Asian Development Bank shared best practices and lessons learnt on power market integration and implementation of infrastructure projects. Experts from SAARC Energy Centre and CDC "Energiya" discussed current developments in the regions of Central and South Asia in terms of energy supply and demand, connectivity and electricity trade.

The participants also discussed further steps on establishing ECO REM which offers multiple benefits to participating states in terms of energy security, resource complementarily and economies of scale.

Participates in the 19th Annual Meeting of the ECO Trade Development Bank

An ECO delegation headed by H.E. Dr. Hadi Soleimanpour, Secretary General of the ECO participated in the Plenary Session of the 19th Annual Meeting of the Board of Governors of the ECO Trade and Development Bank (ETDB) held on September 30, 2020.

The conference, organized on the occasion of International Day on Universal Access to Information (IDUAI), was cohosted virtually by Public Foundation for Support and Development of National Mass Media of Uzbekistan and the Project Coordinator of the Organization for Security and Co-operation in Europe (OSCE) in Uzbekistan.

The conference, attended by over 180 participants from Uzbekistan, the OSCE area and beyond, recognized the significance of access to information and focused on the right to information in times of crisis as well as the advantages of having constitutional or policy guarantees for public access to information and formulation of sustainable policies through and beyond the COVID-19 crisis.

In view of the COVID-19 pandemic and rapid socio-economic developments taking place at the regional and global levels, the ECO strongly believes that joint and integrated efforts are required by all the

On October 15, 2019, the 74th UN General Assembly proclaimed September 28 as International Day on Universal Access to Information (IDUAI).

ECO Secretary General Participates in a Joint

ESCAP-OSJD Virtual Meeting

A joint ESCAP-OSJD virtual meeting of experts on challenges & opportunities for international railway transport along the TAR Network and beyond was held on July 7 - 8, 2020 to discuss the post-COVID-19 situation and measures required to prevent the negative impacts of the disease on the railway transportation.

The event brought together 120 experts from different countries of Asia and Europe as well as some regional and international organizations including representatives of the International Union of Railways (UIC), International Railway Committee (CIT), and International Coordinating Council on Trans-Asian Transportation (CCTT).

The meeting mulled over the scenario of regional and global railway networks, pursuing the objective of sharing the relevant experiences amongst Euro-Asian countries to cope with the post-COVID-19 crisis and identifying required actions to further enhance the sustainability of railway freight transport on the Trans-Asian Railway (TAR).

During the opening session of the meeting, Dr. Hadi Soleimanpur, Secretary General of the Economic Cooperation Organization, delivered his keynote statement, sharing the ECO's responsive activities to counter the adverse effects of the ongoing pandemic on transit transport in the ECO countries. While mentioning the "ECO Guidelines" shared amongst the Member States of the Organization, he underlined that the organization's core concern in the period of such crisis was, inter alia, to address region's fundamental requirements including, smooth passage of transportation carrying essentially required food and medical items through the border crossing points.



The ECO Secretary General emphasized on the need for a continued cooperation between the ECO and ESCAP proposed to the ESCAP to contribute in developing and jointly implementing some bankable projects on ECO's railway network.

He further sought the ESCAP's assistance to transform ECO's existing transit transport corridors into sustainable economic passages in the interest and benefit of the region.

The participants underscored the need for an accelerated and boosted volume of cooperation at national and international levels to make a collaborative, coordinative and largely engaged effective response to preclude impact of the

The Foreign Minister reasserted Pakistan's commitment to ECO and determination to achieve organization's goals, assuring the Secretary General of his complete support for enhancement of cooperation amongst the ECO Member States in the pursuit of aims and objectives envisaged in the ECO Vision 2025.

The Secretary General acknowledged the Pakistan's leading role for regional economic integration through the ECO's platform, commending the country's longstanding support to secure the organization's developmental goals enshrined in the Treaty of Izmir and the ECO Vision 2025.

He further admired the country's valued efforts for development and progress of the ECO that have been of greater utility and importance to transform the organization into an inspiring and strong regional economic forum.

While appreciating Pakistan's support to ECO's initiatives in Afghanistan for implementing selected projects through ECO Fund for Afghanistan, the Secretary General informed the Minister that the Secretariat was in process of developing some special project proposals for Afghanistan to help it meet the impacts of COVID-19 pandemic.

Both sides agreed to work closely for implementation of ECO Projects, particularly, in the area of transit-transport, health and to be engaged in any other facilitative measures that could help counter the negative effects of COVID-19.

The two sides also discussed other important regional issues including Kashmir and Afghanistan Peace Process which have been directly or indirectly hampering the smooth economic progress in the ECO region. They appeared mutually receptive to address all areas of common concerns.

Regional Validation Workshop Paves



The Way for a Clean Energy Centre for the ECO Region

The Economic Cooperation Organization (ECO) and the United Nations Industrial Development Organization (UNIDO), with the financial support of the Austrian Development Agency (ADA), organized a virtual meeting on 23 June, 2020 to validate the feasibility and viability of a Clean Energy Centre for the ECO region (CECECO). Representatives from ECO Member States, namely Azerbaijan, Iran, Kazakhstan, Kyrgyz Republic, Türkiye, Uzbekistan, and international partners such as Austria, the European Commission, the International Renewable Energy Agency (IRENA) and the International Energy Charter participated in the event.

During the meeting, Ambassador Huseyin Avni Bicakli, Deputy Secretary General of ECO and Mr. Stefan Scholz, Ambassador of Austria in Iran, expressed their mutual commitment to the new centre and regional cooperation as a tool to accelerate the energy and climate transformation.



"The future prosperity and growth of ECO member states highly depend on the access to clean, reliable and affordable energy services", added Ambassador Huseyin Avni Bicakli.

"We are convinced that this center will become a strong member of the Global Network of Regional Sustainable Energy Centers, which we are promoted in partnership with regional economic communities.

"There is plenty of room for joint learning and South-South cooperation on clean energy solutions and business models", said Mr. Tareq Emtairah, Director of the Department of Energy at UNIDO. The participants reviewed the results of CECECO baseline and feasibility assessments, which were conducted by ECO and UNIDO over the past few months.

Fourth Dialogue on an eff-ective Multilateral **Policing Architecture against Global Threats**

Fourth Dialogue on an effective Multilateral Policing Architecture against Global Threats The International Criminal Police Organization (INTERPOL) organized a virtual meeting of the Fourth Dialogue on an effective Multilateral Policing Architecture against Global Threat on May 20, 2020.

The meeting was attended by the representatives of INTERPOL, EUROPOL, GCCPOL, ASEANPOL, AFRIPOL, AMERIPOL, and UNODC. The ECO Secretariat delegation, headed by ECO Deputy Secretary General, also attended the meeting.

The Secretary General of the INTERPOL, Mr. Jurgen Stock, inaugurated the meeting. In his statement, he expressed his gratitude to the INTERPOL Member States as well as the regional and international organizations for participating in the virtual event. He emphasized the significance of data management during the COVID 19 outbreak and touched upon the ways to systematically share the information among the police organizations.

He further briefed the meeting about ECO's profile and recent progress in advancing regional cooperation for formulating ECO regional policies and actions, including those pursued as regards addressing the menace of transnational organized crime.
