The draft, prepared collaboratively, aims to establish a network for facilitating information exchange and capacity-building activities. Approval and implementation of this Plan will enable the organization of seminars

and capacity-building programs, thereby strengthening judicial cooperation within the ECO region.

ECO Member States have strong motivations to strengthen cooperation in tackling transnational organized crime, recognizing its adverse effects on regional economic and social progress.
