1. Establishment of multi-stakeholder research and consultation on digital cooperation to set clear metrics or standards for the inclusiveness of digital technologies and cooperation and also application of engineering and ethical standards and principles;

- 2. Establishment of Regional Digital Help Desks to help governments, civil society and the private sector to understand digital issues and develop capacity to steer cooperation related to social and economic impacts of digital technologies. Regional Help Desk could be led by ECO in collaboration with UN, ITU and regional stakeholders;
- 3. Consultation on laws and regulations to prevent negative effects and abuse of technological advances;
- 4. Consult and cooperate towards clear and transparent standards that will enable greater interoperability of data in ways that protect privacy while enabling data to flow for commercial, research and government purposes, and supporting regional integration and innovation to achieve the inclusive and sustainable targets.
- 5. Playing a constructive role in governing of the Internet and global digital architecture through establishing relevant platforms and means like consultative contact groups and multilateral mechanisms;

I am confident that with your extensive knowledge of the ICTs and professional background, this Forum will explore functional and practical methods of multi-stakeholder cooperation and will open new horizons for further development of our regions.
