The Extraordinary Summit

Report (Ashgabat, 13-14 May, 1997)

The Extraordinary Summit Meeting of the Economic Cooperation Organization (ECO) was held at Ashgabat on 13-14 May, 1997.

The Meeting was participated by H.E. Professor Burhanuddin Rabbani, President of the Islamic State of Afghanistan, H.E. Mr. Heider Aliev, President of the Azerbaijan Republic, H.E. Mr. Akbar Hashemi Rafsanjani, President of the Islamic Republic of Iran, H.E. Mr. Nursultan Nazarbaev, President of the Republic of Kazakhstan, H.E. Mr. A. Jumagulov, Prime Minister of the Kyrgyz Republic, H.E. Mr. Mohammad Nawaz Sharif, Prime Minister of the Islamic Republic of Pakistan, H.E. Mr. Emomali Rahmonov, President of the Republic of Tajikistan, H.E. Mr. Suleyman Demirel, President of the Republic of Turkey, H.E. Mr. Saparmurat Niyazov, President of Turkmenistan, H.E.
