

Statement by ECO Secretary General, H.E. Ambassador Halil İbrahim AKÇA

At the High-Level Symposium on SDG 6 and Targets

9-11 August 2016, Dushanbe

On behalf of the Economic Cooperation Organization, it is a great privilege for me to address this High-Level Symposium on SDG 6 and Targets—Ensuring that no one is left behind in access to Water and Sanitation—where government officials, water policy makers and experts, business and civil society representatives have gathered to discuss how to implement SDG 6 and its related targets. Our shared prosperity and future growth depends very directly on water availability and equitable access to water, as indicated in the Water Development Report of 2016, access to clean and affordable water supports health, livelihoods and the economy, while also creating decent jobs.

The effective utilization of the water resources as well as efficient and harmonious management of our trans-boundary waters will lead to greater food security, better harnessing of our energy sources, creation of diversified transportation means, including effective means of intra and inter socio-economic and political integration, peace and security. We stand ready to support our member countries in achieving these Goals through resource mobilization. I am pleased to inform you that ECO is currently developing ECO Vision 2025, a strategy which will enable to more effectively respond to the higher ambitions of the 2030 Sustainable Development Agenda.

Similarly, ECO is supporting practical measures throughout the ECO Region, which will ultimately help member-states to make progress towards the SDGs. The establishment process of ECO Centre for Efficient Utilization of Water in Agriculture is a relevant example in this regard with the objective of promoting cooperation among member states for effective water resources management, especially to eliminate the risks of water scarcity. "Thorough this center and other measures, we are ready to cooperate with all international institutions, especially UN-DESA, to leave no one behind.

In conclusion, I would like to thank, once again, the Republic of Tajikistan and UN-DESA for their partnership in organizing this event; as such events highlight the centrality of water and sanitation to the successful implementation of the 2030 Agenda.
