Statement by H.E. Mr. Halil Akinci, Secretary General of the Cooperation Council of Turkic Speaking States at the 20th Meeting of the Council of Ministers (Baku – 15th October, 2012)

Mr. Chairman, Secretary General of the ECO, Honourable Ministers, Excellencies,

I would first of all like to congratulate H.E. Mr. Elmar Mammadyarov, Minister of Foreign Affairs of the Republic of Azerbaijan for his election as chairman in office of ECO.

I would also like to extend my sincere congratulations to His Excellency Dr. Shamil Aleskerov on his appointment as Secretary General of the Economic Cooperation Organization and wish all the success in his responsible work.

The fact that all Member States of Turkic Council are also ECO members provides us with great opportunity. With institutional cooperation between Turkic Council and ECO, a greater added-value could be created for all stakeholders concerned. We consider that endorsement of observer status of Turkic Council by Council of Ministers is a pertinent step in this direction. I thank all the Member States of ECO.

In conclusion, I would like to extend my profound thanks to ECO for their kind invitation and express my congratulations to the Government of Azerbaijan for excellent organization of this event and finally, wish all the success to the Meeting.
