# The 1<sup>st</sup> Ministerial Meeting

on Trade and Commerce Report (Tehran, 6 March, 2000)

1. The First ECO Ministerial Meeting on Commerce/Foreign Trade was held on 6<sup>th</sup> March, 2000 in Tehran, Islamic Republic of Iran. The Meeting was preceded by Senior Officials' Meeting, chaired by H.E. Mr. Mostafa Sarmadi, Adviser to the Minister and Director General of International Affairs, Ministry of Commerce, Islamic Republic of Iran, held on 04-05 March, 2000. The Ministerial Meeting was attended by the delegations of Islamic State of Afghanistan, Republic of Azerbaijan, Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Islamic Republic of Pakistan, Republic of Tajikistan, Republic of Turkey and Turkmenistan. The Secretary General of ECO and other ECO officials of the Secretariat also attended the Meeting. The list of participants is placed at *Annex-I*.

# STATEMENTS BY THE SECRETARY GENERAL OF ECO AND THE HEADS OF DELEGATION ON ECO TRADE COOPERATION

- 6. The Secretary General of ECO, in his statement highlighted the present ECO trade cooperation activities, the trade situation in the ECO region and summarized the latest developments regarding relations with regional and international organizations. The text of the Statement is placed as **Annex-IV**.
- 7. The Ministers and the Heads of Delegation made their statements, outlining their views on the trade cooperation and proposed measures on the promotion of the trade among ECO Member States. Copies of their statements, which were made available to the ECO Secretariat, are placed as **Annex-V**.
- 8. The Ministers and the Heads of Delegation noted with appreciation the Statement made by the Secretary General regarding the Secretariat's efforts in promoting trade cooperation in the region. The Ministers also appreciated the progress made with regard to relations with regional and international organizations dealing with trade such as WTO, ITC, UNCTAD and ESCAP. In this connection, the Ministers specifically welcomed the *Observer Status* accorded to ECO by WTO. Moreover, while supporting the ITC Project, the Ministers encouraged the Secretariat to proceed with financing and the implementation of the said Project.

### Agenda item No. 6

### REVIEW OF THE ECO TRADE COOPERATION

- 9. Under this Agenda Item, the representative of the ECO Secretariat submitted a presentation on the ECO trade cooperation. While reviewing the present trade performance of ECO Member Countries alongwith trade policy environment prevailing in the region, he gave background information on the status of the ongoing trade activities and programmes pursued by the Secretariat.
- 10. The Ministers and Heads of Delegation took note with appreciation of the presentation made by the ECO Secretariat and urged the Member States to furnish the relevant and updated trade information to the Secretariat on a regular basis.
- 11. The Ministers and Heads of Delegation expressed their satisfaction concerning the work, which has been done by the Heads of the ECO Customs Administration and requested to proceed with their work in facilitating and simplifying the customs procedures.
- 12. The Ministers and Heads of Delegation emphasized the importance of the participation of the Member States at the appropriate level in the trade-related meetings particularly, the HLEG Meeting on Tariff and Non-Tariff Barriers in the ECO Region.

- 13. The Ministers and Heads of Delegation reiterated the importance of the role of the private sector in trade cooperation and recommended the enhancement of the activities of the ECO Chamber of Commerce & Industry.
- 14. The Ministers and Heads of Delegation urged the Member States to take necessary measures for effective implementation of the Transit Trade Agreement.

# Agenda Item No. 7

# CONSIDERATION OF THE DRAFT FRAMEWORK AGREEMENT ON ECO TRADE COOPERATION

- 15. The Ministerial Meeting considered the draft Framework Agreement on ECO Trade Cooperation (FAT), prepared by the HLEG on Tariff and Non-Tariff Barriers in the ECO region and finalized by the Senior Officials, in their Meeting which was held on 4-5 March, 2000 in the ECO Secretariat. The Ministers and Heads of Delegation approved the Framework Agreement on Trade Cooperation, and decided to open it for signing. The copy of the approved text is placed at *Annex-VI*.
- 16. The delegation of the Republic of Azerbaijan stated their reservation on the Article 12 of the Framework Agreement on ECO Trade Cooperation as following:

"Nothing in the Framework Agreement on ECO Trade Cooperation shall prevent the Republic of Azerbaijan from taking other WTO consistent measures."

# Agenda Item No. 8

### CONSIDERATION OF OTHER TRADE AREAS FOR COOPERATION

- 17. The Ministerial Meeting agreed that the benefits of trade cooperation would be more extensive through the promotion of investment & financial services, tourism, technical & engineering services, research & training and other trade-related services and decided that these issues would be taken up by the High Level Expert Group (HLEG).
- 18. The Ministers and Heads of Delegation also requested that the Member States should prepare themselves for taking part in trading in services which is needed for future cooperation.

ADOPTION OF THE COMMUNIQUÉ OF THE FIRST ECO MINISTERIAL MEETING ON COMMERCE/FOREIGN TRADE, TEHRAN

19. The Ministers and Heads of Delegation adopted the Tehran Communiqué to be issued at the conclusion of their Meeting. The adopted text of the Communiqué is placed at *Annex-VII*.

### ANY OTHER BUSINESS

20. The representative of the Islamic State of Afghanistan made the following proposal, which was welcomed by the Ministerial Meeting:

"In line with the para 14 of the Tehran Communiqué, a Seminar with the participation of experts from ECO Member States, may be held - sometime in the third quarter of 2000. The venue and date of this Seminar will be informed by the ECO Secretariat later on."
