<u>Report</u>

Inaugural Session

The 30th Meeting of the ECO Regional Planning Council (RPC) was held on January 14-16, 2020 at the ECO Secretariat, Tehran. The relevant sectoral committees met on the sidelines of the meeting to discuss and consider their specific areas for making appropriate recommendations to the 30th Meeting of RPC.

2. The ECO Member States' delegations, including the Islamic Republic of Afghanistan, Republic of Azerbaijan, the Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, the Islamic Republic of Pakistan, Republic of Tajikistan, Republic of Turkey, Turkmenistan and Republic of Uzbekistan attended the meeting. The Representative of the Turkic Council also attended the Meeting in the capacity of Observer. The concerned staff of the Secretariat headed by the ECO Secretary General, H.E. Dr. Hadi Soleimanpour, also participated in the event. The Representatives of ECO Specialized Agencies, Regional Institutions and Affiliated Bodies also took part in the Meeting. Agenda Item No.1

Opening remarks

3. While warmly welcoming the participants, the ECO Secretary General, H.E. Dr. Hadi Soleimanpour deeply thanked the delegates for making it convenient to participate in the meeting. He underscored the RPC's important role entrusted by the ECO Council of Ministers (COM), inter-alia, reviewing ECO's activities and programmes to assess their progress and shortcomings, as well as proposing future plan of actions in line with the Treaty of Izmir and ECO Vision 2025. He underlined the steps taken for implementation of the ECO Vision 2025, fulfillment of the organization's objectives in the areas of trade, transit-transport, energy, tourism and organizational reform as well as the organization new approach to make it result and project-oriented. He also acknowledged and admired the efforts and contributions of the Member States made to secure the targets set forth in the Work Programme 2019.

4. The ECO Secretary General overviewed the directorate-wise notable achievements made in 2019, adding the measures for further functional improvement. He emphasized upon an agreed approach to implement ECO Trade Agreement (ECOTA) to accelerate trade activities and enhance trade volume of the Region. The Secretary General acknowledged the visible progress in the area of transport and communications in 2019, underlining the importance of TTFA, the main relevant ECO framework

for cooperation in the field of transport. He further highlighted ECO's collaboration with UNIDO in establishment of ECO Clean Energy Centre (CECECO) and expressed satisfaction on completion of its Preparatory Phase this year. He further mentioned about different projects being pursued by ECO Secretariat in the fields of Tourism, Environment, Agriculture and Minerals. 5. The Guest Speaker and the Deputy Foreign Minister for Economic Affairs of the Minister of Foreign Affairs of the Islamic Republic of Iran, H.E. Mr. Gholomreza Ansari receptively welcomed the participants of the 30th RPC's Meeting, wishing them a pleasant and memorable stay in Tehran. The Guest Speaker also appreciated the ECO Secretary General and his team for successful arrangements of the event. He underlined the great utility of the ECO as an important platform for discussing the ways and means of improving sustainable economic development in the Member States. He expected the Member States to express interests in the ECO affairs and activities, considering that without their active and serious involvement, the realization of the organization's goals would remain elusive.
