A. SECTO	ECTOR: TRADE AND INVESTMENT	
1.	The Council profoundly appreciated the Republic of Tajikistan for announcing to host the 5 th Ministerial Meeting on Economy in the first half of 2020 to evaluate the economic situation in the region as a whole. In this connection, the Secretariat prepared a book entitled "Leveraging the Economic Potential of ECO Region" . The Council accordingly requested the Republic of Tajikistan to convey the date (s), venue, and details of hospitality to the Secretariat at the earliest convenience so that the same may be communicated to the esteemed Member States.	
	The RPC also requested the Member States to confirm their participation for this important meeting, and convey the high level composition of delegations to the ECO Secretariat once the meeting is announced. The Council also expressed its gratitude for keen interest and commitment of the Republic of Tajikistan in holding this vital event and expressed its desire to make it successful with active participation of the Member States.	
2.	The Council appreciated the commitment of the Islamic Republic of Iran for announcing the 2 nd Meeting of ECO Heads of Central Banks in August 2019, in Tehran though it could not be held due to lack of quorum. The Council requested other Member States to volunteer hosting of the 2nd Meeting of ECO Heads of Central Banks along with Deputies/Experts Group Meeting. The Council added that once the meeting is announced, the Member States may actively participate in the said meeting.	
3.	Recognizing the significance of financial matters/issues in the region, the Council requested the Member States to announce hosting of the Experts Group Meeting on Banking and Financial Matters and Forming of ECO Clearing Union at the earliest convenience. The Council accordingly requested that once the meeting is announced, the Member States may actively participate in the meeting to make it a success.	
4.	In the wake of developments taken place at the global and regional level in the economic and trade spheres, the Council noted that it is imperative to hold 5th Ministerial Meeting of Commerce and Foreign Trade on regular basis. The Council expressed its deep gratitude for the Republic of Turkey for announcing this important event in 2020 and accordingly

	requested to convey the schedule of the meeting at the earliest convenience. The Council also requested the Member States to confirm their participation for this imperative meeting and communicate the high level composition of delegations to the ECO Secretariat when the meeting is announced.	
5.	The ECO Secretariat informed that in the light of directions of the 29 th RPC, the Contracting Parties to ECOTA were requested to convene the 8th Meeting of the ECOTA Cooperation Council "to consider the technical and practical issues concerning the operationalization of ECOTA". While appreciating the efforts of the Secretariat for holding the 8 th Meeting of the ECOTA Cooperation Council, the RPC desired to continue efforts towards this end.	
	The Secretariat further informed that the ECOTA Cooperation Council agreed to consider the proposal of the ECO Secretariat by taking it up with the respective governments. It was further shared that the ECOTA Cooperation Council requested to share their views and priorities regarding implementation of ECOTA with the Secretariat in three months, which, however, are awaited.	
6.	Recalling the relevant decision of the 24th COM, the Council reaffirmed the commitment for implementation of the ECO Trade Agreement (ECOTA) for furtherance of the objective of regional integration through Free Trade Area as envisaged in ECO Vision 2025, and called upon the Contracting Parties to accelerate processes for its implementation as well as to devise mechanisms and solutions at the earliest convenience taking into account the concerns and views of the Contracting Parties for the maximal productivity of each of them. The Council recommended that other ECO Member States that are not a party to the ECOTA could be invited to ECOTA Cooperation Council Meetings as observers.	
7.	The Council noted with concern that operationalization of ECOTA has taken considerable time without substantive results. Having considered views of the Contracting Parties, it was agreed that they will inform ECO Secretariat about their views within two months time on operationalization of ECOTA along with problems and offered solutions. The Secretariat based on the views and observations received from the Contracting Parties will prepare a Working Paper for further deliberations to be made in the relevant upcoming

	meetings. The Council agreed to hold 9th Meeting of ECOTA Cooperation Council before the Ministerial Meeting on Commerce and Foreign Trade in 2020.	
8.	The Secretariat informed the Council that the Draft of ECO Multi-Dimensional Trade and Investment Strategy and Prospects of Establishing a Free Trade Area in the Region has been revised and circulated among Member States for views/comments. It was informed that the Islamic Republic of Afghanistan and the Islamic Republic of Pakistan have conveyed their comments. The Council requested the other Member States to send their comments/views, if any, before the forthcoming 5th Ministerial Meeting on Commerce and Foreign Trade, which will be discussed in the said meeting.	
9.	The ECO Secretariat informed the Council that the Republic of Turkey announced to host the 1st Meeting on the Joint Working Group for Preparation of the draft ECO Trade Facilitation Agreement (ETFA) in 2020. It was further informed that at least six times meeting was announced, last time in October 2018, but the meeting had to be postponed because of lack of quorum. The Council deeply appreciated the Republic of Turkey's commitment to this important area, and also welcomed its offer to host it in 2020.	
10.	The Secretariat also informed that as per decision of 28th RPC Meeting, a comprehensive Paper/Strategy titled ' Draft ECO Trade Facilitation Strategy' prepared by the Republic of Turkey in 2017 was circulated amongst the Member State to obtain the respective views of their Trade, Transit and Customs authorities before the Ministerial Meeting. In the light of above decision, the Strategy was again circulated in 2019 among Member States for their comments/views. The Council requested the Member States to provide their views at the earliest convenience so as to discuss it in the 5 th Ministerial Meeting of Commerce and Foreign Trade in 2020.	
11.	The Council called upon the Member States to volunteer hosting the 2 nd Meeting of the ECO Heads of Tax Administration in 2020, to further discuss and finalize the following three draft Documents on ECO Tax Cooperation in the light of decisions of the First Meeting of the Experts of Tax Administration to be submitted to decision making organs of ECO for approval. The documents include;

12.	The Secretariat informed that in order to promote ECO cooperation in the field of capital markets, the ECO Ministerial Meeting on Finance and Economy decided to hold Meetings of ECO Heads of Capital Markets Supervisory Authorities . The deliberations and decisions of the meetings will be submitted to the next ECO Ministerial Meeting on Finance and Economy for decision/approval. Therefore, the Council requested the Member States to consider hosting the first Meeting of ECO Heads of Capital Markets Supervisory Authorities in 2020 and inform ECO Secretariat at the earliest convenience, if possible, before holding of 5th ECO Ministerial Meeting of Finance and Economy.	
13.	The ECO Secretariat informed the Council that so far two ECO Member States namely, the Islamic Republic of Iran and the Islamic Republic of Pakistan have ratified the Agreement on Promotion and Protection of Investment (APPI) among ECO Member States along with the Amendment Protocol and had deposited the Instrument of Ratification. It was shared that the Islamic Republic of Afghanistan has informed in November 2019 about completion of its ratification process; however, formality of deposit of Instrument of Ratification is yet to be completed.	
	Recalling that the APPI has been signed by five ECO Member States (namely, Islamic Republic of Afghanistan, Republic of Azerbaijan, Islamic Republic of Iran, Pakistan and Republic of Turkey) and entry into force requires ratification by four Member States; a ratification of one more Member State will result in coming into force of this vital Agreement. With this in view, the Council called upon the Member States, which have signed the APPI, to complete the ratification procedures along with its Amendment Protocol at the earliest convenience for its early implementation of this important agreement. Also, the Council urged the Member States, which have not yet signed to do the same and ratify the APPI along with

	its Amendment Protocol at their convenience, helping operationalization of the agreement for collective benefit of the region and the Member States.	
14.	The Council requested the Member States to consider hosting the Second Meeting of ECO Investment Promotion Agencies (ECO-IPAs) Forum in 2020 and inform the ECO Secretariat through diplomatic channels.	
15.	The ECO Secretariat recalled the Council that during the 3 rd Ministerial Meeting on Finance and Economy in Tehran, the Republic of Tajikistan was designated as the coordinating country for ECO initiatives on investment. The Council requested the Member States to volunteer hosting of ECO Investment Conference and accordingly convey the date, venue and other details at the earliest convenience.	
16.	The ECO Secretariat informed that based on the decision of the 26 th and 27 th Meetings of the RPC, a proposal for two-year project on ECO Business Forum worth US\$ 50,000/- was prepared and circulated among the Member States to furnish their views/comments, but response in this respect is awaited. The Project Monitoring Group (PMG) meeting held in November, 2019 at the Secretariat recommended holding this meeting in 2020 on the sidelines of the 14 th ECO Summit Meeting, in coordination with the host authorities and ECO-CCI by rationalizing its cost/budget to US\$ 10,000.	
17.	The Council expressed its gratitude to the ECO-CCI on announcing the 4 th ECO Business Forum in April 2020 in Turkmenistan for extended benefits and expansion of intra-regional trade in the region. The Council requested the Member States to encourage their National Chambers to actively participate, and make it successful and result-oriented.	
18.	The Council appreciated the Chamber of Commerce and Industries/Mines of the Islamic Republic of Afghanistan for announcing to host ECO Trade Fair in 2020. Accordingly, the Council requested the Member States and its National Chambers of Commerce and Industries/Mines to actively participate in this event for promotion of trade in the region.

19.	The Council also appreciated the offer of the Islamic Republic of Iran to host ECO Trade Exhibition namely "ECO-RAF" from 13-26 July, 2020 in Yazd, Iran. Accordingly, the Council also requested the Member States and its National Chambers of Commerce and Industries to actively participate in this event for promotion of trade and regional integration.	
20.	As regard the ECO-ASEAN Joint Business Forum and ECO-SAARC Joint Business Forum , the ECO-CCI informed that this forum will be considered in 2020/2021 after holding of 4 th ECO-Business Forum in 2020 with the aim to strengthen inter-regional trade. It was announced that in the meantime ECO-CCI will explore the possibility of expanding trade relations with these economic blocs.	
21.	The Secretariat informed the Council that the Member States were requested to volunteer hosting of the 4 th ECO Trade Promotion Organizations (ECO-TPOs) Forum. It was recalled that Islamic Republic of Pakistan had announced to organize this event in March, 2018 in Islamabad; however, it could not be held due to lack of quorum. In view of this, the Council again requested Member States to announce volunteer hosting this event in 2020 and convey the dates and venue.	
22.	The Council noted with satisfaction that the implementation of the 3rd Phase of the ECO-UNIDO Trade Capacity Building Project (TCBP) for harmonizing the Standardization, - Metrology, Testing and Quality among the ECO Members has been completed and ECO Regional Quality Policy and Guideline for National Quality Policy have been formulated and submitted to good use of Member States.	
23.	The Council noted that elimination of non-tariff barriers is imperative for increasing intra regional trade. With regard to this, it was further observed that promoting ECO Quality Infrastructure and Implementation of the Regional Quality Policy is essentially required. Hence, the Council requested the Secretariat to invite UNIDO, ECO Trade and Development Bank and IDB to provide financial and technical support in 2020 for the implementation of the next phase of the Project. The Council also requested all the Member States to give their full support to the Secretariat in its endeavors for the implementation of the next phase of ECO-UNIDO Trade Capacity Building Project.

24.	The Council thanked the Republic of Turkey for holding the 26 th Executive Committee and General Assembly of the ECO-CCI along with the six Specialized Committees , in Istanbul, Turkey in July, 2019.	
25.	The Council also expressed their gratitude towards the Islamic Republic of Pakistan for holding the meetings of the 27th Executive Committee and General Assembly of the ECO-CCI along with the six Specialized Committees , in Karachi, in November, 2019. It was highlighted that regular holding of these events will produce conducive impact on trade in the region especially through active participation and vibrant role of national chambers.	
26.	The Council appreciated the ECO-CCI for expanding its cooperation and activities especially MoU/Cooperation Agreement with the Investment Promotion and Protection Agency of the Kyrgyz Republic (November 2019), MoU/Agreement for Cooperation with Astana International Finance Center (November 2019) and MoU with the Cooperation Council of Turkic Speaking States -Turkic Business Council (December 2018), Tashkent, Republic of Uzbekistan. The Council considered that such cooperation will help realize the ECO Vision 2025.	
27.	The Council was informed that in view of the ECO-CCI's request, the observer status in the ECOTA Cooperation Council has been granted after completion of the stipulated procedure. The Council congratulated ECO-CCI on this milestone and expressed its hope to play positive and dynamic role in the Council as a major stakeholder in the region. The Council also appreciated the tremendous work done by leadership of the ECO-CCI, headquartered in the Union of Chambers and Commodity Exchanges of Turkey (TOBB), in realization of the ECO Vision, and will help make ECO a more integrated regional bloc through more intraregional trade and expanded economic activities in the region.	
28.	The Council also congratulated and profoundly appreciated Turkmenistan and ECO-CCI for announcing to hold the meetings of the 28 th Executive Committee of the ECO-CCI along with the Six Specialized Committees Meetings, for the first time in Ashgabad, Turkmenistan, in April 2020 along with the 4th ECO Business Forum and 3rd ECO Trade Fair and termed it

	a great success. It was highlighted that in December 2018, these events were held in Tashkent, the Republic of Uzbekistan, for the first time in Central Asia. The Council noted that these events will create good impact and encourage other member countries especially the Central Asian States to hold such events in other parts of Central Asia. The Council also deeply appreciated and encouraged the Member States' national chambers for more participation in such events.	
29.	The Council requested the Member States to urge their respective National Chambers to confirm their participation in the forthcoming meetings of the 28 th ECO-CCI's Executive Committee, General Assembly and the Specialized Committees which will be held in April, 2020 in Ashgabat, Turkmenistan.	
30.	The Council also requested the Republic of Turkey and the ECO-CCI/TOBB to explore the possibility of holding the 5th ECO Business Forum .	
31.	The Secretariat informed the Council that the Second Phase of the Study on Trading Patterns in the ECO Region is being carried out by Pakistan Institute of Development Economics (PIDE). The drafts of the Study have been circulated; and will be shared with the Member States once completed in early 2020. The Council urged the ECO Secretariat to ensure that the Study is completed as soon as possible so that Member States can use the result of the study and get maximum benefit from it.	
32.	The Council while highlighting that so far six ECO Member States are the members of the WTO, requested a full ECO support for the remaining four ECO Member States to become members of the WTO through capacity building to align the trade policies and laws for regulatory reforms as per WTO requirements.	
33.	The Council requested the non-WTO ECO Member States to inform the ECO Secretariat if they are interested in any training workshop/seminar related to their accession to WTO, to explore possibility of holding it. The Council requested the WTO Members of ECO to volunteer hosting and organizing such Seminars and the ETDB to continue provide financial assistance for organizing such seminars in 2020.

34.	The Council appreciated the fresh offer of the Republic of Turkey to host the 9 th Meeting of the ECO Council of Heads of Customs Administration (CHCA) and the 5 th Meeting of the ECO Committee on Customs Cooperation (ECCC) in 2020, and requested the Republic of Turkey to convey the date and venue of the meetings. The Council also requested the Member States to actively participate in these meetings for sustainability of the benefits of previous meetings and realization of the related goals stipulated in the ECO Vision 2025.	
35.	The Council appreciated the Republic of Turkey for setting up the ECO Smuggling and the Customs Offences Data Bank under the Agreement on Establishment and Operation of ECO Smuggling and Customs Offences Data Bank, in 2018 and holding its initial two meetings i.e. 26 February and 24 October 2018. The Council requested the Member States to fully cooperate with the Republic of Turkey for full operationalization of this institutional mechanism aiming to increase the governmental revenues.	
36.	The ECO Secretariat informed the Council that so far, four Member States i.e. the Islamic Republic of Iran, the Islamic Republic of Pakistan, the Republic of Turkey and lately the Republic of the Azerbaijan have already ratified the Agreement on Establishment and Operation of ECO Smuggling and Customs Offences Data Bank . The Council requested the remaining signatories to expedite ratification of the referred Agreement. The Council requested the non-signatory Member States to consider signing and ratifying the Agreement for benefitting from this arrangement.	
37.	The ECO Secretariat informed that the draft text of the Agreement on Mutual Administrative Assistance in Customs Matters was finalized in the 8 th Meeting of the ECO Council of Heads of Customs Administration (CHCA) . This adopted final draft text was circulated among the Member States for completion of formalities and internal governmental processes. The Republic of Azerbaijan and the Islamic Republic of Pakistan have completed their internal procedures. The Council requested the Member States for early completion of their formalities and internal governmental processes. After this, the draft Agreement will be submitted to the decision making organs of the ECO for approval to be opened for signatures.

38.	The Secretariat while recalling the 8 th Meeting of the ECO Council of Heads of Customs Administration (CHCA) in Islamabad in November 2017 informed the Council that the Islamic Republic of Pakistan offered to support the capacity building activities of the Member States in Customs matters through a set of different trainings at the Customs Training Academy at Karachi. The Council also welcomed the willingness and readiness of the Republic of Turkey to share its experiences on the themes such as Implementation of Common Transit Convention, e-TIR System, Simplified Procedures on Expedited Shipments, Customs Enforcement measures as well as Single Window System. Further, it was also suggested that the Member States may share their best practices in different thematic areas, and may communicate the proposed set of trainings with the ECO Secretariat. The Council requested the Member States, which have not provided yet the set of trainings to inform the Secretariat so as to conduct trainings on need basis.	
39.	The Council appreciated the Islamic Republic of Iran to announce the 2nd Meeting of the Technical Committee on the Electronic Data Interchange (EDI) in 2020, and hoped to continue its great work for developing the EDI system for the region. The Council requested the Member States to actively participate in the 2 nd Meeting of EDI for development of the system as per its mandate. The Council decided to merge this meeting with the 2nd Meeting of the Technical Committee on the Electronic Data Interchange (EDI) to be held in Islamic Republic of Iran in 2020 largely on the pretext of similar/common agenda.	
40.	The Secretariat informed the Council that the 233rd and 234th Council of Permanent Representatives (CPR) Meetings held on September 11, 2018 and on November 05, 2018 respectively deliberated on and directed the Secretariat to explore the possibilities of i. Expanding the mandate of the ECO Trade and Development Bank (ETDB) to strengthen and develop trade among Member States and ii. Establishing an ECO Clearing Union to clear payments for the trade among the Member States.	
41.	Recalling the decisions of the 29 th RPC, (para 41), the Secretariat requested the Member States to announce the meeting of Experts Group on Banking and Financial Matters

	and Forming of ECO Clearing Union in 2020 to discuss the said vital issues.	
42.	Recalling the relevant decision of the 24th COM, the Council encouraged the ECO Trade and Development Bank (ETDB) as the regional institution of ECO to continue to develop appropriate modalities, to finance and support the implementation of regional projects, and emphasized the need to further support the Bank through strengthening its role and expanding its Membership.	
43.	The Council requested ETDB to initiate to arrange the first Regional Partnership Forum (RPF) in 2020 in coordination with ECO Secretariat, and called upon the Member States to encourage their relevant national institutions and organizations to actively participate in the subject Forum, once it is announced.	
44.	Recalling the relevant decision of the 24th COM, the Council assigned the task to develop the Structure and Modalities of the ECO Vision Fund provided for under ECO Vision 2025 to the ECO Secretariat and, if appropriate, ECO Trade and Development Bank, with collaboration of relevant institutions.	
45.	The Secretariat informed that the nominations for the General Assembly of the ECO Reinsurance Company (ERC) stands completed. The Secretariat further shared that the Islamic Republic of Pakistan had informed that prior to holding the meeting of Board of Directors and General Assembly of ERC, it is imperative that the required ground work and completion of formalities, including release/transfer of capital of ECO-ERC is required, to make it more successful and result—oriented. It was further shared that response from the Contracting Parties regarding release of paid-in capital or decision thereon is awaited. The Council requested the Contracting Parties to decide on release on paid-in capital to proceed on operationalization of the ECO Reinsurance Company.	
46.	The Council also invited the remaining Member States to consider joining this important ECO institutional arrangement i.e. the ECO Reinsurance Company in order to utilize its immense potential and role in furtherance of businesses and economic activities in the region.

47.	The ECO Secretariat informed the Council that Agreement on Simplification of Visa Procedures for Businessmen and the Additional Protocol to the Agreement on Simplification of Visa Procedures for Businessmen and Transit Drivers of ECO Member States has been signed by three Member States namely, the Islamic Republic of Afghanistan, the Islamic Republic of Iran and the Islamic Republic of Pakistan, however, the Islamic Republic of Pakistan has also ratified the Agreement. The Council requested the Member States, which have not signed or ratified these legal texts, to sign/ratify for early implementation of the Agreement and complementing trade facilitation measures in the region.	
48.	The Secretariat recalled that the Islamic Republic of Iran announced the First Meeting of the Heads of the Commodity Exchange of ECO Member States number of times, latest on 12 th May, 2018 in Tehran, however, it could not be held due to inadequate participation. While appreciating its commitment, the Council requested the Member States to announce holding of this meeting in 2020 and also requested the Member States to actively participate in the Meeting once it is announced.	
49.	The Secretariat informed the Council that the "ECO Trade and Investment Network Web Portal" has been developed on the main ECO Web-Site and the new address is "www.eco.int/trade" . The Council while appreciating the Secretariat for this valuable work recommended the Member States to use the Web Portal to the possible extent for their own benefit.	
50.	The Secretariat informed the Council that for the ECO Trade and Investment Network Web Portal, upon the request of the Secretariat the ECO Chambers of Commerce and Industry (ECO-CCI) had circulated among the National Chambers of Commerce and Industry to provide detailed information about importers and exporters in the ECO Region. So far the Republic of Azerbaijan and Islamic Republic of Pakistan have conveyed information to the Secretariat in this regard. The information received from the Member States have been placed in the page of the ECO-CCI and National Chambers of ECO Trade and Investment Network Web Portal. The Council requested other Member States to impress upon their respective National Chambers of Commerce and Industry to provide information to be

	included in the ECO Web Portal at the earliest convenience to promote trade in the region.	
51.	The Secretariat informed the Council that, the Islamic Republic of Afghanistan partly, the Republic of Azerbaijan, the Islamic Republic of Pakistan, the Republic of Tajikistan and the Republic of Turkey have already provided list of focal points in the relevant fields and these focal points have been placed on the ECO Trade and Investment Network Web Portal. The Council called upon the remaining Member States to designate their Focal Points in the areas of Trade, Investment, Customs, Trade Facilitation, WTO, Tax, Banking, Capital Markets, E-Trade and Visa, and provide their contact details to be placed in section for trade and investment of the ECO-Website.	
52.	The Council expressed its agreement to the revised project titled "Study on Impediments in Implementation of ECO's Trade Tools and Measures to Resolve", prepared by the Secretariat. The Council also requested the Member States to cooperate with the Coordinator/ Team experts, within the project, who is required to visit the Member States to consult the relevant authorities and, among other things, ascertain their viewpoint for the study project.	
53.	The Council appreciated the project titled" Strengthening Cooperation amongst Public and Private Sectors in the ECO Region " and considered it useful in furtherance of trade and investment in the region and in line with the ECO Vision-2025.	
54.	The Council appreciated the project titled "Study of Forming ECO Clearing Union" and recommended to be carried out in 2020 for enhancing monetary cooperation in the ECO region.	
55.	The Council appreciated the Secretariat's flagship document on "Leveraging the Economic Potential of ECO Region" and considered it a seminal work, which will be useful for Member States in identifying and realizing their trade potential in the ECO region, leading to enhanced intra-regional trade and regional integration.	
56.	The Secretariat informed that the Islamic Republic of Iran has proposed to hold a two-day meeting of the National Development Funds of the Member States and announced to

	host this event in 2020 for exploring the possibility to "develop their economic, industrial and commercial policies and priorities in the ECO region in form of an investment strategy in order to identify areas of interest of each member", taking into the account the best practices of some Member States (Turkey, Kazakhstan and Azerbaijan).
