

EXECUTIVE SUMMARY

In line with the targets set forth in the **Implementation Framework** (pages 2-34) of the ECO Vision 2025, the ECO Secretariat has succeeded in the completion of small sized projects during 2020/21 (the details have been reflected in the present document). As with the core emphasis placed by the ECO Vision 2025 on the area of **Trade and Investments**, the two projects have been dedicated to trade-related matters. In specific terms, the development of the ECO regional payment system has been explored in-depth to address

the ECO stakeholder interests in further developing the financial and banking sector of ECO. To facilitate the much needed removal of trade-impeding barriers towards the full implementation of the ECO Trade Agreement, the latter constraints have been countered through the project against the evidence-based, science driven, workable solutions.

To implement the imminent tasks set forth by the Member States for **Transport and Communications**, the small sized project handling the resumption of the Islamabad-Tehran-Istanbul (ITI) container train (currently, re-named as the ITI Cargo Train) has succeeded in the dispatch of the cargo train along the ITI railway route, the main blood artery of the ECO transport. For the reason that this project has entirely been contributed in-kind by the Islamic Republic of Iran, the Republic of Turkey and the Islamic Republic of Pakistan, such concerted effort helped skip a funding request.

In **Agriculture and Industry**, the emphasis has been on ways to inclusively support the development of organic production, which is currently represented in the ECO countries by Small and Medium Entrepreneurs (SME). A particular focus has been put on the advantages and benefits for the farmers and agricultural enterprises, at grass root level, from the ECO region-encompassed Certification and Market Integration.

To fully answer the market supply-and-demand for the ECO countries' meat products (given the fatigue of food cold chain), the Directorate of Agriculture and Industry handled the small sized project, which has made it possible for the ECO countries that the mandatory prerequisite veterinary and sanitary procedures be essentially eased. That can now facilitate the meat produce to be freely exchanged via intensive trade transactions across the ECO region.

In **Human Resources and Sustainable Development**, the project, which prepares the ECO region for the deployment of the ECO member countries' manufacturing capacities in pharmaceuticals, has been completed.

In **Energy, Minerals and Environment**, the ECO Energy Strategy has been developed by a collective effort of the high caliber strategists from the ECO Member States. Currently, the ECO region can benefit from the accurately strategized Plan of Action for the ECO energy

sector, which builds on the comprehensive new energy strategy capturing most recent trends in global energy and through specifics of the ECO region.

In addition to the aforementioned projects, the Secretariat has processed in the course of 2020, the "ECO Vision Fund" project following the endorsement of the latter by the 30th Regional Planning Council Meeting (RPC) and 24th COM and 31st RPC (paragraph-33, A. Sector: Trade and Investment, Work Programme 2021). This project has been deferred till the coronavirus pandemic clears out.

In sum, out of the ten (10) short term bankable projects that were mandated by the 24th ECO Council of Ministers Meeting (COM) (8-9 November 2019, Antalya (Turkey)) to implemented in 2020 and which were further endorsed in the Work Programme 2021 by the 31st Regional Planning Council (RPC) of ECO (12-21 January 2021, ECO Secretariat, Tehran (Iran), the Secretariat has been able to complete seven (7) of which one was contributed by the I. R. of Iran in-kind and one (ECO Vision Fund) was deferred. The rest two of the ten are in the tourism sector and those are currently under consideration.

The processing and implementation of the small projects has been transparent in line with international norms for project reporting, the detailed information is available at: www.eco.int under the Activities of Directorates/Sections pl. see for PMS.

PROJECT BACKGROUND

The previous "ECO PoA for Energy and Petroleum Cooperation" (2011-2015) was adopted at the 2nd ECO Ministerial Meeting on Energy/Petroleum (1 October 2010, Dushanbe).

The 27th Meeting of the Regional Planning Council (5-8 December 2016, Tehran) extended the afore-said PoA until the next - 4th ECO Ministerial Meeting on Energy/Petroleum. The subject PoA envisaged priority cooperation areas of common interest in: the ECO power grid; ECO oil and gas pipelines; energy security and trade; coal; energy efficiency and conservation; renewable energy; and regional energy/petroleum policy and planning.

The 30th ECO RPC mandated the Secretariat to develop the strategy document.

PROJECT OBJECTIVES

- To develop the strategy for regional energy cooperation. It must comply with national interests of ECO Member States that also corresponds to the global energy landscape.
- To be adopted by the Ministers of Energy of the ECO Member States, followed by a relevant Action Plan/Roadmap of implementation.
