



**32<sup>nd</sup> MEETING OF  
THE ECO REGIONAL PLANNING COUNCIL (RPC)**

**Report**

**January 17-26, 2022**

The 32<sup>nd</sup> Meeting of the ECO Regional Planning Council (RPC) was organized in hybrid format from January 17-26, 2022. During the event, the relevant sectoral committees met to discuss and consider their specific areas as well as make appropriate recommendations to the RPC concerning the Work Program and Calendar of Events for 2022.

2. The delegations of the ECO Member States, including the Republic of Azerbaijan, the Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Islamic Republic of Pakistan, Republic of Tajikistan, Republic of Turkey, Turkmenistan and Republic of Uzbekistan participated in the meeting. Moreover, the Representatives of the Turkish Cypriot State and Energy Charter attended the Meeting in the capacity of Observers. The ECO Secretary General along with the Deputies Secretary General and other relevant staff of the Secretariat, as well as the Representatives of ECO Specialized Agencies, Regional Institutions and Affiliated Bodies also attended the Meeting. ### *Plenary Session*

#### **Agenda Item No.1**

##### Opening of the Meeting

3. The ECO Secretary General, H.E. Mr. Khusrav Noziri while welcoming the participants highlighted the significance of RPC in consideration of its essentially important role of analyzing and evaluating the Organization's ongoing activities as well as considering and developing some new projects and programs to be implemented to shoulder, support and continue the regional development process. Referring to the situation emerged in the aftermath of COVID, he noted that it was highly exigent for the ECO to plow ahead with its cooperative agenda for the continuity of regional development process. Despite the post-pandemic challenges, the Organization managed to convene several important meetings in 2021, both in virtual/hybrid and physical formats. Moreover, the Secretary General congratulated the Republic of Uzbekistan for assuming the Organization's Chairmanship for 2022, assuring his complete support and cooperation to ensure the implementation of any initiatives by Uzbekistan which are aimed at maintaining and accelerating the Organization's performance for smooth socioeconomic progress in the region.

4. In citation of 25th COM, the Secretary General expressed his deep pleasure over the COM's approval for expansion of scope of small-sized projects to pre-feasibility/feasibility study projects. He added that the 25<sup>th</sup> COM also allowed the execution of 10 more small-sized projects each within the cost of US \$ 10,000, making the number of projects total 20 to be annually financed from General Reserve Fund (GRF). In addition, the COM desired the ECO to also focus on some mega and long-term projects, alongside carrying out the short term small and medium-sized projects, he intimated. The Secretary General considered that this would be quite supportive to broaden our view and policy for large-scale development in the region.

5. The Secretary General also briefed the Council on some of the ECO's sectoral activities made during 2021 that included the areas of trade and investment,

transport & communication, energy, minerals & environment, human resources & sustainable development, agriculture & industry, tourism etc. While appreciating that the Republic of Uzbekistan and the current ECO Chair came up with a proposal to adopt a regional programme on developing a safe tourism in the post-pandemic period at the 4th Tourism Ministerial Meeting in Bukhara during 2022, he encouraged the member countries for enhancing their efforts and contributions to achieve the tourism targets as envisaged in the ECO Vision 2025. His detailed statement is attached as Annexure.

6. In his inaugural remarks, the Chairman Mr. Ashraf Khodjaev, Director of the Department of Economic Diplomacy of the Ministry of Foreign Affairs of the Republic of Uzbekistan welcomed the participants and thanked them for joining the Plenary Session of the 32<sup>nd</sup> RPC to consider, review and finalize the ECO's Work Program and Calendar of Events-2022. Expressing deep pleasure over the first-time assumption of ECO's Chairmanship by the Republic of Uzbekistan, he assured that his country is well-determined to effectively meet the assigned responsibility for further strengthening regional cooperation within the ECO framework.

7. Referring to the objectives of ECO Vision 2025, the Chairman underlined that Uzbekistan considers it fundamentally important to practically exploit the existing regional potential and the available opportunities for the shared progress and prosperity of the entire ECO Region, particularly, in the fields of trade, transport, energy, investment and tourism. He further stressed the importance for the fortification of trade and economic relations for the collective socioeconomic development in the region, including through the elimination of trade barriers, as well as consistent facilitation of trade procedures.

8. The Chairman noted that joint and coordinated actions were required to systematically restore the pre-pandemic conditions aimed at normalizing the trade, transport and other important activities which are pivotal for unwavering progress. He recalled that a number of proposals to contribute to the development of multilateral partnership were propounded by the honourable President of the Republic of Uzbekistan during 15<sup>th</sup> Summit, for ensuring sustainable socioeconomic progress in the ECO Region. In particular, the Uzbekistan side proposed the 2022 to be declared as the "Year of Strengthening Connectivity", he added. Copy of his statement is attached as Annexure.

While acknowledging the progress made on such activities despite the challenges posed by COVID-19, the Council encouraged the Secretariat to maintain and accelerate the pace of regional development process in coordination and collaboration with the ECO Member States.
