Statement by the ECO Secretary General Mr. Khusrav Noziri at the Plenary Session of the 32nd Meeting of the ECO RPC

(26 January, 2022 - Tehran)

The honorable Chairman, Mr. Ashraf Khodjaev, Distinguished Heads of Delegations, Dear Participants,

It is, indeed, a privilege to welcome you all to this Plenary Session of the 32nd ECO Regional Planning Council, and extend my sincere gratitude for your participation in this important event. I would like to express my sincere gratitude to all distinguished delegates who have wholeheartedly been involved from last week onward, in thorough assessments of all our mandated activities and have provided guidance on the way forward, the outcome of which shall be presented for your kind consideration and endorsement today.

I also take this opportunity to felicitate the Republic of Uzbekistan for assuming the Organization's Chairmanship for 2022. I have fervent hope that under Uzbekistan's able leadership, ECO shall better obviate the major ongoing global and regional challenges affecting all socio-economic aspects of contemporaneous life. I would also like to assure of our full cooperation to ensure the implementation of initiatives by Uzbekistan for the continuity of development process in the region.

I would like to recall that the RPC holds a very significant place in the ECO as it is essentially entrusted to analyze and evaluate the Organization's ongoing activities as well as consider and develop some new projects and programs to be implemented to shoulder, support and assist continuation of our regional development process.

As you are aware, the situation developed in the aftermath of COVID-19 continues to hamper regional and global efforts being undertaken to get back to the pre-pandemic conditions. Though it is impeding our way, the ECO Secretariat, in close collaboration with its Member Countries, has been ardently pursuing its progressive targets in line with ECO's annual Work Programs and Calendars of Events as per previous conclusions and recommendations of the RPC. We have been able to hold several important meetings in 2021, including the virtual organization of the 31st RPC in January, the 14th ECO Summit in March, Midterm RPC Meeting in July, as well as the in-person convening of the 2nd General Conference of PAECO in June at Islamabad and

the 15th ECO Summit preceded by the 25th Meeting of the Council of Ministers (COM) in the Ashgabat city of Turkmenistan during the last week of November 2021.

It is pleasing to note that the 25th COM has approved the proposal of the ECO Secretariat concerning the expansion of scope of small-sized projects to prefeasibility/feasibility study projects. The 25th COM further allowed the Organization to implement 10 more projects annually each within the cost of 10,000 USD to be financed from General Reserve Fund (GRF). Therefore, the total number of annual small-sized projects, which is presently standing at total 20, appears to fuel and augment the ECO's project-and-result-oriented approach.

This notable development is based on and in pursuance of the recommendation of the 31st Meeting of RPC. I congratulate and thank the Council for its kind support to this end. In addition, the COM has desired that the ECO should also focus on some mega and long-term projects, alongside carrying out the short term small and medium-sized projects. This will contribute to a long-term perspective and help strategize our approach to the development of our region, inter alia, through proceeding with large-scale development projects.

I have the further pleasure of informing you that based on the approval of ECO Council of Permanent Representatives (CPR), a High-Level Committee (HLC) was formed for conducting Midterm Review of the ECO Vision 2025 and developing follow-up mechanism on the proposals of ECO Heads of State/Government that were put forward during the 14th ECO Summit. The given task was successfully accomplished by HLC, and duly endorsed as well as appreciated by the 25th COM. From now on, the ECO Secretariat is required to submit annual progress reports to the COM regular meetings on the state of affairs of implementation of the measures and recommendations envisaged in the HLC's Report.

Distinguished Delegates,

Although the progress is being made in diverse areas of scope for greater regional interest and community improvement, I take this opportunity to convey some sectorwise activities of the Organization.

Trade is one of the core areas of activity on ECO's agenda of cooperation to support the process of regional development. Our region accounts 6.6% of the global population, contributing only 2% in the global trade. The region's share in the global trade amounted to661 billion USD in 2020 with exports of 289.78 billion USD and 371.4 billion USD imports. The intra-regional trade remained around 49.8 billion USD in 2020 which is almost 7.5% of the region's global trade. The primary reasons for this low share include, inter alia, lack of complementarities among economies of the Member States and high cost of doing business and higher costs in intra-regional trade.

The post-pandemic regional and global economic recovery is inevitably linked to an increased and scaled-up cooperation amongst the Member States. To normalize, maintain and accelerate regional trade and related activities as well as overcome the impediments to this end, an expanded collaboration is required to be aimed at moving forward for greater value addition to be culminating in Regional Value Chains (RVC) to push trade flows. Such a target is optimistically achievable by implementing the ECO's agreed legal and institutional frameworks. Relevantly, the Secretariat in close collaboration with Member States is pursuing trade liberalization under ECO Trade Agreement (ECOTA) and expansion of Preferential Trade Regime under a Free Trade Agreement as envisaged in the ECO Vision 2025.

To get there, Parties must finalize outstanding work under the Agreement that has remained unfinished and make their best to figure out a best practical way forward. The overarching significance of trade and its role as promoter of overall cooperation and growth within ECO call for meaningful interaction and the flexibilities required for ECO's enhanced intra-regional and global trade. A study conducted by the Secretariat, to introduce at least three scenarios for implementation of ECOTA, was appreciated and recommended by the 5th Ministerial Meeting on Finance and Economy in 2021 for Member States' consideration, which was accordingly shared with the Member Countries.

Moreover, the ECO is further firm for reviving and bolstering the supply side through the creation of investment-friendly climate in the region. In this regard, efforts are being made to effect the operationalization of ECO Agreement on Promotion and Protection of Investment (APPI). Trade facilitation is also a very important area that is in focus of ECO leaders. A draft Trade Facilitation Agreement along with list of non-tariff barriers prepared by the Secretariat has also been shared for views of the Member Countries to finalize necessary trade facilitation strategy which is targeted to improve trade facilitation index in the region.

To meet the envisioned goals aimed at increasing regional trade flows and creating conducive working environment to promote trade and investment in the region, the Secretariat has carried out a feasibility study on **Regional Payment System in the ECO**. The intent of the perceived project is to facilitate financial transactions among the selected commercial banks in our region and the prospects of creating an ECO Clearing Union among the Central Banks of the Member States. The study is further aimed at establishing a network of nominated regional commercial banks to regulate trade related payments for wider transparency, predictability and uniformity as well as reducing costs in doing business and trade in the region.

I would like to recall that the ECO Trade and Development Bank (ECO-TDB), a very important organ of the Organization, is functioning professionally and progressively. It

can play a momentous role to accelerate and shoulder our efforts for sustainable development in the region, if patronized by all ECO nations. While serious efforts are being made to expand the Bank's membership and enhance its shares/capital, the relevant authorities of the remaining Member Countries are sincerely encouraged to expedite their consideration process for joining our financial body. It may be noted that the ECO Secretariat, in consultation with the ECO-TDB, is working to develop some regional projects for the shared prosperity and high dividends in the Member States. However, the maintainable support of the Member Countries is inevitably required to ensure fruitful progress to that end.

Cooperation amongst the Economic Zones of the region is also one of the primary areas of our concern, which is inevitable for achieving the desired growth in trade and investment. In this regard, ECO Secretariat held the 2nd Meeting of the Heads of Free Trade/Special Economic Zones of ECO Member States on August 2, 2021. It is worth-mentioning that the detailed Terms of Reference for Study on preparation of the guidelines and Joint Action Plan for the establishment of ECO Regional Network of Special Economic Zones/Free Trade Zones (SEZs/FTZs) in the ECO Member States have been prepared. The prospect for the said Zone is that it will integrate the existing networks of Special Economic Zones of each of the ten Member Countries through one-point-of-entry at ECO, with the objective to spur up the growth in economic uplifting and trade exchange among the ECO countries on privileged terms.

Furthermore, the First Meeting of the Heads of National Development Funds was held on December 16, 2020 which, inter alia, agreed to explore possibility of setting up a network of the Sovereign Wealth/National Development Funds in the region to finance infrastructure related regional projects. We are looking forward to the collaboration and cooperation of the ECO Member States to achieve the collective aims in promoting the establishment of new enterprises in high value-added segments of the industrial value chains in the region and institutionalizing a comprehensive dialogue mechanism among the Sovereign and National Development Funds of the Member States on investment-related issues with a view to promoting cooperation in sectors of mutual interest.

Dear Participants,

Transport also remains one of the major sectors, which is essentially important to secure ECO's goal of greater regional integration. I am glad to inform that some notable progress has been made for enhancing connectivity in the region. It most prominently includes (i) the finalization of commercialization of KTI Corridor; (ii) operationalization of ITI Cargo Train; (iii) implementation of some parts of KTAI Corridor and (iii) operationalization of ECO-ITI Road Corridor. Moreover, on the sidelines of the 15th ECO Summit held in late last November, an MoU has been signed between the relevant authorities of Kazakhstan, Turkmenistan and Iran on the implementation of KTI

Railway Corridor. We are moving forward in a steady mode for making consolidated progress in this sector.

The advancement of the **Energy** agenda of ECO necessitates enhanced ownership and active involvement by all stakeholders. ECO Vision 2025 laid down the long- and midterm regional objectives and expected outcomes in the energy sector. To provide supportive policy environment and enhanced policy coherence, 4th ECO Energy Ministerial Meeting held in 2021, adopted fundamentally new ECO Energy Strategy and its Action Plan 2030. Our joint efforts can be devoted to come up with proposals on project development and regional cooperation initiatives to implement the subject Action Plan.

Joint ECO-UNIDO Project on establishment of ECO Clean Energy Centre is also an explicit example of sustainable energy transformation efforts set out also in our new ECO Energy Strategy. The 25th COM has approved the Charter of the Centre and endorsed the selection of the Republic of Azerbaijan to host the bureau of this Centre. It is targeted at increasing the share of clean energy in overall energy mix amongst ECO Member States and further to manage cooperation to avail the region's tremendous opportunities in renewable energy efficiency. We strongly hope that the host country along with other Member States will utilise ad-hoc mechanism that has also been established under the 25th COM decisions for soonest operationalization of the Centre.

In addition, the ECO Member States are striving to dig out maximum trade opportunities and selectively enhance physical infrastructure to eventually facilitate the electricity exports and imports that could be fuelled by the available reserves of natural gas and hydro-potential. In this regard, on-going pilot project to establish ECO Regional Electricity Market can become turning point in 2022 by the joint endeavours of our Member States. Taking advantage of the RPC, the Member States may decide for establishing joint mechanism of power trade through implementation of envisioned project.

As regards **Environment**, the data is unequivocal: climate change is widespread, rapid, intensifying and already impacting every region on Earth. The six years, since the Paris Climate Agreement, have been the "six hottest years" on record. We face a stark choice: we either choose to recognize that business as usual isn't worth the devastating price we're paying and make the necessary transition to a more sustainable pattern of consumption and production or we accept that we're investing in our own extinction.

In this context, the ECO countries have reiterated their commitment towards environmental protection and sustainability in line with the relevant objectives of ECO Vision 2025 and the UN Sustainable Development Goals. One of the environmental common concerns in the region is the Land Degradation which has cross-cutting social, environmental and economic impacts. It is very moment that our Member States render

every possible support to launch this comprehensive project on ECO Landcare Program. I extend my sincere gratitude to all Member States for their continued support and special thanks to the Government of Turkey for holding in-person preparation meeting for implementation of this project.

The Secretariat would also like to embark on the launching implementation process of Framework Plan of Action on Environment Cooperation and Global Warming for ECO Member States and the Work Plan on Biodiversity in ECO Region. ECO Institute of Environmental Science and Technology (ECO-IEST) has played effective role during recent years to strengthen the capacity of key actors in environmental conservation in the region and promote exchange of information and experiences with efficient management of resources. The Member States as well as host country - Iran are expected to collaborate effectively on empowering the Institute to meet its mandates as reflected in its Charter.

Dear Delegates,

Tourism is globally acknowledged as one of the most dynamic and job creating sectors. However, it has been among the most affected areas during the pandemic due to the suspension of air travels, lockdowns and social distancing protocols imposed globally. The unconducive post-COVID conditions also hampered several ECO tourism events. However, recently it became possible in August 2021 to hold International Festival of Dushanbe - ECO Tourism Capital along with the International Forum on Agro-Tourism Development dedicated to the development of agro-tourism in the region.

The Ashgabat Consensus for Action, adopted by the 15th ECO Summit, assigns the ECO Tourism Ministers to address the serious challenges in ECO tourism industry according to the other regional and global post-COVID initiatives. In line with this and to revitalise the tourism sector, the Secretariat has prepared a Plan of Action on elimination of COVID-19 pandemic consequences in the tourism sector for facilitating recovery in the ECO region and circulated it for the proposals and views of the Member States.

It is encouraging that the Republic of Uzbekistan and the current ECO Chair has proposed a regional programme on developing a safe tourism in the post-pandemic period to be adopted at the 4th Tourism Ministerial Meeting in Bukhara during 2022. It further appears to pay attention to the development of religious tourism and other joint tourist products, widening of geography of aviation links and development of tourist infrastructure.

Distinguished Delegates,

Agriculture and Industry also remains one of the most important sectors on ECO's priorities in special consideration of the challenges posed by COVID-19. Considering the ongoing conditions and views of the Member States, the Secretariat, in cooperation with ECO Regional Coordination Center for Food Security (ECO-RCC) and FAO, has updated the ECO Regional Programme for Food Security (ECO-RPFS). Moreover, the establishment of ECO Center of Excellence for Efficient Utilization of Water for Agriculture (ECO-CEEUWA) is also under process. The 3rd **Working Group Meeting for Establishment of this Center was held in 2021. The relevant d**raft Plan of Action and draft Statute have been finalized with valuable cooperation of the Member States.

To support sustainable socioeconomic development in the region, the ECO Regional Institute for Standardization, Conformity Assessment, Accreditation and Metrology (RISCAM) can play instrumental role to contribute to the strengthening of the quality infrastructure in the region through cooperation with the relevant international organizations. The 8th High Level Working Group (HLWG) on Standardization, Conformity Assessment, Accreditation and Metrology was organized by RISCAM in 2021. Our task ahead is to have joint ownership, responsibility and accountability with a view to trigger joint cooperation for establishment of Technical Management Boards on RISCAM.

The **Human Resources and Sustainable Development** is another area of our prime concern. Pursuing the objectives of ECO Vision 2025, the 8th Ministerial Meeting on Disaster Risk Reduction held in March 2021, adopted the ECO Regional Framework on Disaster Risk Reduction and its implementation roadmap (2021-2025). The 1st Meeting of Senior Officials/Heads of Disaster Insurance Authorities was held on December 14, 2021 where Member States discussed the establishment of the (a) ECO Regional Disaster Information System and (b) ECO Disaster Insurance System. The Report of the session was circulated among Member States for their views. The ECO is in touch with the Asian and Pacific Centre for the Development of Disaster Information Management (APDIM). A joint ECO-APDIM Project on Enhancing capacity in Member Countries has been prepared and introduced to the Member States which is aimed at improving disaster management framework for cascading risks.

Regarding area of health, a small-sized project on the Regional capacity on intra-trade of pharmaceuticals (RCIP) was recommended by the 31st RPC in 2021. A consultant was hired for development of the envisioned project, and necessary questionnaires were distributed among Member States. The Final Report of the small-sized project was also circulated amongst the Member States for their consideration in the middle of 2021.

The ECO is also focused and working to magnify the **Judicial and Parliamentary cooperation** in the region. To meet such ends, efforts are being made to ensure the establishment and operationalization of the ECO Regional Center for Cooperation of Anti-Corruption Agencies and Ombudsmen (RCCAC). Moreover, the formation of ECO

Police (ECO-POL) is also being pursued in collaboration with the Member States. Though a notable progress is achieved, the accelerated actions and responses of the Member Countries are required to support our endeavours in this regard.

It is encouraging that the parliamentary dimension of the ECO is also developing. The Charter of the Parliamentary Assembly of ECO (PAECO) came into effect after four Member States ratified it. The 2nd General Conference of Parliamentary Assembly of ECO Member States held at Islamabad in June last year was very constructive and successful. I call on Member States to consider joining the Charter of the Parliamentary Assembly of ECO.

Dear Participants,

Due to the recently developed conditions in Afghanistan, the ECO leaders during the 15th Summit in Ashgabat expressed firm support to the international efforts aimed at providing urgent humanitarian aid to the Afghan people through effective, transparent and accountable mechanism. The continuity of development process in Afghanistan is quite essential for the collective wellbeing of the entire ECO region. The Organization is deeply determined to secure the developmental goals of ECO Advocacy Program for Afghanistan. Relevantly, the Member Countries are strongly encouraged to provide their valued proposals to support the Organization in its endeavours to assist the socioeconomic development in Afghanistan.

Moreover, the enhancement of Organization's **International Relations** constitutes an important component of ECO's strategy to achieve its strategic goals and objectives. ECO enjoys cooperative relations with a number of organizations, including the United Nations, OIC, European Commission, IDB, WTO, SCO, CICA, OTS, ASEAN and a host of UN Specialized Agencies, Funds and Programmes, like UNIDO, UNESCAP, FAO, UNCTAD, and many more. Recently, the *ECO's image in the international arena has notably enhanced*. The UN General Assembly has passed a fresh resolution on ECO-UN cooperation in September 2021 inviting, inter alia, its Specialized Agencies, Funds and Programmes to support ECO's initiatives and activities. Furthermore, I am pleased to mention that during the 25th Meeting of the Council of Ministers held on November 27, 2021 in Ashgabat, ECO and UNESCAP have signed a fresh Memorandum of Understanding for further institutionalizing the cooperative relations existing between the two organizations.

Distinguished Delegates,

Today, the Council is set to adopt the ECO Work Program and Calendar of Events for 2022. I am sincerely thankful and extend my deep felicitations to all the Sectoral Committees for dedicated work to finalize the contents of these documents.

I am privileged to mention that the Regional Planning Council endorsed the Secretariat's proposal to arrange a brainstorming session at the level of relevant deputy ministers of the Member States in the second quarter of this year to initiate the next phase of ongoing reform process.

I consider that the role of ECO is increased in the developing working conditions inflicted by the pandemic. However, our combined initiatives and synergic actions would leave no stone unturned on our way to success for shared progress and prosperity in the region. Before I conclude, let me once again thank all of you for your kind participation in this important roadmap meeting. I am optimistic that the outcomes of this meeting will lead us to make fruitful achievements in 2022.

Dear Mr. Chairman, Dear Mr. Secretary General, Excellences and distinguished delegates,

On behalf of the Delegation of the Republic of Azerbaijan, I would like to extend our greetings to the participants of the 32nd Meeting of the ECO Regional Planning Council (RPC).

I'd also like to express our gratitude to the Government of the Islamic Republic of Iran and the Secretariat of the ECO for organizing this meeting smoothly.

Dear participants,

The growing economic prominence of the region is a key component in the ECO region's good outlook for regional economic growth. The region offers great prospects for promoting economic and business relations across many sectors of Member States' national economies, thanks to some complementarities in their economies and a diverse market. This, in turn, encourages intra-regional trade growth and leads to increased inter-regional trade beyond the ECO region.

Azerbaijan places a premium on cooperation within the ECO. Ashgabat Declaration and the Midterm Review of ECO Vision 2025, as we all know, was endorsed by the Heads of Member States at their most recent ECO Summit in Turkmenistan, with the goal of increasing intra-regional trade, increasing ECO's share of global trade, and further unlocking the full potential of regional commerce. With this goal in mind, Azerbaijan is creating a web of infrastructure projects such as East-West, South-West, and North-South transportation corridors to help promote regional and even inter-regional trade. Given the importance of such infrastructure projects in generating economic growth and trade potential in

land-locked nations, I believe Azerbaijan is doing everything it can to build and share prospects with its ECO partners. With this goal in mind, Azerbaijan tries to diversify and upgrade its transportation infrastructure in order to increase the interconnections between Trans-European and Trans-Asian infrastructure networks, as part of its goal of developing transit potential.

The president of Azerbaijan told his colleagues about the Zangazur corridor during the most recent ECO Summit. We can now say that the Zangazur corridor has become a reality. The East-West and North-South corridors will benefit greatly from this new transportation infrastructure. I am certain that this route will also benefit the ECO Member States.

Furthermore, we are convinced that completing the Rasht – Astara rail link in Iran as soon as possible will assist in the realization of the North-South Transport Corridor across Azerbaijan in the near future, providing a new impetus to trade opportunities for the countries involved, as well as the entire region. The North-South Transport Corridor has always been on the agenda of both Azerbaijan's and Iran's heads of state.

A high level of contribution and assistance demonstrates our intention to engage more closely with ECO partners on transportation and trade concerns. This is something that ECO can and should benefit from. As a result, Azerbaijan welcomes its ECO Member State partners to utilize those infrastructure ties to develop trade between themselves and other countries.

Dear participants,

The Charter of the ECO Research Center was signed by Azerbaijan and Turkey during the 14th ECO Summit in March 2021. I am grateful to the Member States for supporting the initiative of Azerbaijan's late President, Heydar Aliyev. Azerbaijan will do everything possible to ensure that the Center based in our country runs smoothly. I extend an invitation to the remaining Member States to participate in this vital endeavor.

Azerbaijan is also thankful for the ECO Member States' valuable support in its quest to host the ECO Clean Energy Center, and is committed to developing the center as a platform for helping the region's States' energy transition, and welcomes the Member States to sign the Charter as soon as possible.

Dear colleagues,

There is sufficient potential for ECO to be transformed into a stronger and efficient organization that, in our opinion, could be more focused and develops a practical toolset for project implementation. Simultaneously, it is necessary to conduct regular

analyses of the Organization's activities, prepare assessments, ensure a follow-up of the reform process, mainstream the Secretariat's functions, improve the follow-up mechanism of high-level meeting decisions, and give priority to specific projects in order to improve the legal and functional mechanisms of multilateral cooperation within the Organization.

We repeatedly point out that the Republic of Azerbaijan continues to play an active role in ECO. We believe that as a result of joint efforts and existing potential of the Organization, the Member States will strengthen their positions in the coming years.

Next year will mark the 30th anniversary of Azerbaijan's membership to the organization. Since joining ECO, our country has actively participated in a number of initiatives aimed at strengthening regional economic and trade connections, and we remain committed to expanding mutually beneficial collaboration.

In conclusion I would like to wish to our Meeting a success and fruitful discussions, as well as accomplishment of desirable results for all participants.

Statement by H.E Mr. Seyed Jalaledin Alavi Sabzevari The Permanent Representative of Islamic Republic of Iran to the ECO at the 32th RPC of ECO

Mr. Chairman,

Let me begin by congratulating your appointment as the Chairman of this RPC meeting. I am thankful to all Member States who attended the sectoral Committees as well as the Council meeting today, both in person and in virtual mode. We are also grateful to the distinguished Secretary General and his able team for excellent arrangement of the Committee meetings as well as this plenary session. At the end, I would like to remind that the ECO founding documents clearly stipulate that RPC should be convened at the level of heads of planning organizations of the Member States. Indeed, RPC is a contribution by planners to the political machinery of the Organization. We think there is a need to revive RPC as it is projected in our founding documents. In our turn, we will push for renewed participation of Iran's high level planning officials in the next RPC meeting.

I appreciate again Mr. Chairman's leadership as well as the Secretary General and all esteemed Member States contributions into this important 32nd RPC meeting. I thank you for your attention.

This reflects the political will of the Member States alongside overwhelming capacity of the organization to rise at the need of the hour.

Dignitaries,

I would like to emphasize that RPC of the ECO provides us a platform to discuss ways to improve and develop our region through promoting trade and investment. It also provides us an opportunity to explore possibilities and utilize the available abundant human and natural resources for the benefit of our people.

Working under the UN Charter, ECO offers an invaluable platform to establish a single market for goods and services like European Union. Improved connectivity &people to people contacts can help in increasing intra-regional trade and enhancing economic cooperation among the Member States. The role of ECO Cultural Centre in Iran, Economic Bureau in Turkey and Science Foundation in Pakistan are adding great deal of efficiency of the Organization.

Ladies and Gentlemen,

Our shared history, common borders, outlook towards common problems and cultural affinities further complement our strong ties. However, these strengths need effective channelization and a common strategy to synergize our endeavors for the collective progress & prosperity of our peoples.

Ladies and Gentlemen,

Over the past three decades or so, the ECO Member States have been collaborating to accelerate the pace of regional development through their common endeavors. Besides shared cultural and historic affinities, they have been able to use the existing infrastructural and business links to further fortify their resolve to transfer their hopes and aspirations into a tangible reality at the forum of RPC.

Similarly, we hope that different initiatives of ECO that are aimed at promoting investment in the region, may succeed such as Agreement for Promotion and Protection of Investment, establishment of ECO Re-Insurance Company and agreement on matters related to taxation etc.

Excellencies,

Economic development of the ECO region, as elsewhere in the world, has experienced a setback during 2020. Production has temporarily halted during that period, to prevent regional community from covid-19-related hazards.

Investment which naturally feeds real sector economy has largely been crowded out by pandemic-styled prudence thereby suppressing regional economic activity. That, has especially impacted export-oriented and commodity-linked investments in the ECO region. On the positive side, many see the global crisis as a catalyst for process of structural transformation of international production and supply chains that may, in turn, lead to adequate adjustments in financial systems.

Dignitaries,

We must appreciate that in the form of ECO, we have a regional multilateral platform available to formulate a collective response and policy for our common issues.

Given the current challenges, the ECO has done well in developing Covid-19 guidelines to facilitate trade and movement of goods and persons at the border crossing points and organizing most of the events online during 2021.

As we have seen during this RPC that various events or ministerial meetings were held in the past but they were not held at a regular interval which is required in order to monitor our progress. Significant gaps in between such events negatively impact progress on important issues.

In order to overcome this issue, we need to develop a calendar of events to assure continuity and consistency. If it's not possible for the participants to physically attend any event, it may be held virtually on convenient dates.

Ladies and Gentlemen,

"ECO Vision 2025", adopted during the 13thECO Summit in Islamabad is a key document to assess progress made thus far. The mid-term review of ECO Vision 2025 carried out during latest COM Meeting at Turkmenistan was a very valuable and successful exercise. Now we need to assess the implementation of various objectives of ECO Vision seriously and to develop a realistic timeline for achieving other objectives as well.

Excellencies,

Other tangible outcomes include operationalization of the transport and economic corridors especially KTAI and ITI. We are pleased to note the successful run of TIR consignments from Pakistan to Azerbaijan and Turkey through Iran and the operationalization of Islamabad-Tehran-Istanbul Cargo train. Regional connectivity and development of economic interlink ages are the key pillars of the policy of Government of Pakistan and inline with our leadership's vision of geo-economic integration and connectivity of our region. We intend the ITI corridors to be fully operational with involvement of private sector of enroute Member States so that it becomes a self-sustained project with ECO ownership, it will also promote operationalization of other corridors in the ECO region.

Excellencies,

We would like to highlight the finalization of the host country agreement of the ECO Science Foundation by Pakistan, about which the ECO Secretariat and esteemed Member States have been duly informed. We look forward to the full operationalization of ECO Science Foundation with the arrival of the new President and consistent support of all ECO Member States. We would like to take this opportunity to stress upon the need of ratification of ECO Science Foundation Charter and its additional protocols by non-ratifying Member States in line with the spirit and objective to promote scientific and technological collaboration among ECO Member States.

Dignitaries,

World merchandise trade contracted by around 8% in 2020 over 2019, to US 17.5 trillion in 2020.On the other hand, the contraction in ECO region's world trade declined by more than 9%, from US\$ 729.7 billion to US \$ 661.5 billion over the same period.

The share of the ECO region in Global Trade in Services was US \$ 115 billion in 2020. This included ECO exports of \$ 55 billion and imports of \$ 59 billion. The total volume of intra-regional trade stood at around US\$ 50 billion, around 7.5 % of total trade of the ECO member states in 2020. We hope that different initiatives of ECO that will help in promoting intra-regional trade and investment in the region.

Excellencies,

With regards to financing regional projects, we wish to see ECO Trade Development Bank further expanded to achieve the benchmark capital requirement of 1 billion USD, so that it establishes itself as a fully functional regional financial instrument. It will be able to finance regional projects and assist the Member States through provision of finances for bankable projects. We believe ECO-Trade Development Bank will pave the way for establishment of ECO Clearing Union to forge cooperation with the Asian Clearing Union and to facilitate payments and thereby promote intra-regional trade.

Mr. Chairman!

The progress of the RPC requires a firm stride with a vision to create robust linkages among the Member States. I will take this opportunity to offer my considerations for the respected participants as key takeaways of 32ndRPC:

- i. Double intra-regional trade and increase ECO's share in the global trade, especially commercial services sectors i.e. transport, logistics, tourism etc. and transform the ECO region into a zone of economic growth and collective prosperity.
- ii. Enhance regional cooperation and political will in all the priority areas of ECO such as Trade & Investment, Transport & Communication, Energy & Environment, Tourism, Agriculture & Industry, Sustainable development, and Parliamentary Coordination.
- iii. Promote labour and capital mobility through improved access to transport, information and opportunities and through simplifying issuance of visas and procedures at the border crossing points;
- iv. Hold events rather than postponing, which often happens due to conflicting schedules of the participants from the Member States;
- v. Setting up of task forces for promotion of tourism comprising of Member States from relevant agencies is a welcome initiative of this RPC Meeting;

Statement by Mr. Sayfullo Qodirov Head of the Department of International Relations Ministry of Transport of the Republic of Tajikistan at the 32nd Meeting of RPC of the ECO

Уважаемые коллеги,

Организация Экономического Сотрудничества, являясь региональным межправительственным организацией, со дня своего образования внес значительный вклад в развитии особо важных секторов, такие как торговля, транспорт и коммуникации, энергетика, туризм и т.д.

Как известно, торговое и инвестиционное сотрудничество является одной из приоритетных сфер деятельности Организации.

Сегодня удельный вес стран-членов во внешнем торговом обороте Республики Таджикистан составляет порядка сорока процентов от его общего объёма. В этом направлении, считаем целосообразным разработку дальнейшего совместного плана по эффективной реализации торгового потенциала региона ОЭС.

Наша Организация, также уделяет особое внимание развитию транспорта и коммуникации с акцентом на роль транзитных транспортных коридоров, которые являются ключевым звеном сотрудничества и развитии экономики между нашими странами.

Стоит подчеркнуть, что государства-члены ОЭС обладают огромным транспортно-коммуникационным потенциалом, и эффективное использование существующего потенциала может послужить экономическому росту в регионе.

В свою очередь, Правительство Республики Таджикистан придает особое значение развитию транспортных коридоров для повышения качества жизни населения, экономического роста и ее превращения в удобную транзитную зону.

В связи с этим, Республикой Таджикистан реализуются проекты в основном направленные на укрепление транспортной инфраструктуры, формирование новых транзитных транспортных коридоров, выход на морские порты и создание благоприятных условий для международных автомобильных перевозок.

С этой целью в годы независимости в транспортной сфере страны по непосредственной инициативе Правительства Республики и при финансовой поддержке международных финансовых институтов были реализованы 59 инвестиционных проектов регионального значения на общую сумму более 2,1 миллиард долларов США.

Уважаемые коллеги,

Несмотря на то, что пандемия внесла свои коррективы в развитие торговоэкономических отношений стран-региона за последние два года, Правительство Республики Таджикистан в сотрудничестве со своими соседями приложило усилия для обеспечения продолжения деятельности международных грузоперевозок.

Из-за негативного влияния пандемии COVID-19, международная транспортнологистическая система оказалась одной из наиболее пострадавших сфер, поэтому вопрос использования цифровых технологий и внедрения интеллектуальных транспортных систем на сегодняшний день является весьма актуальным.

В связи с этим, в 2019 году была принята Концепция цифровой экономики Республики Таджикистан, основанная на Национальной стратегии развития Таджикистана на период до 2030 года, и представляет собой общее видение использования современных цифровых технологий.

Кроме того, хочу особо подчеркнуть, что сегодня вопрос организации мультимодальных перевозок является актуальным для укрепления регионального сотрудничество в области транспорта.

Республикой Таджикистан совместно с Республикой Узбекистан и Китайской Народной Республикой принимаются необходимые меры по активизации транспортно-транзитного коридора Узбекистан – Таджикистан – Китай, с целью возрождения «великого Шелкового пути». Также, совместно с Туркменистаном и турецкими коллегами прорабатывается вопрос создания мультимодального коридора Турция – Иран – Туркменистан – Узбекистан – Таджикистан – Китай.

Следовательно, в целях укрепления регионального сотрудничества и создания благоприятных условии развития транспортной отрасли в регионе ЭКО, выражается просьба Секретариату ЭКО уделить особое внимание дальнейшей координации следующих вопросов:

- 1. Активизация и развитие международных транспортных коридоров;
- 2. Создание региональных логистических центров;
- 3. Организация мультимодальных перевозок, и цифровизация всех транспортных процессов международных автомобильных перевозок (в первую очередь внедрение e-CMR и e-TIR).

Уважаемые коллеги,

Сотрудничество в сфере энергетики имеет большое значение для экономического роста и устойчивого развития в регионе ОЭС.

Мы заинтересованы в активном участии в реализации разрабатываемых проектов по соединению и формированию региональных энергетических сетей, в частности по созданию Регионального энергетического рынка.

Подчёркиваем важность своевременной и полной реализации проекта строительства высоковольтной линии электропередачи КАСА-1000.

Таджикистан, как известно, располагает огромными ресурсами чистой возобновляемой энергии. Около 98% электроэнергии Таджикистана производится на гидроэлектростанциях.

В этом направлении разработка Стратегии обеспечения энергетической устойчивости региона ОЭС может содействовать реализации проектов, которые ориентированы на возрастающее использование возобновляемой энергии и развитие «зелёной» экономики.

Таджикистан заинтересован в развитии сотрудничества с государствами-членами ОЭС в области промышленности. В этом направлении считаем важным уделить внимание расширению инвестиционного сотрудничества, а также разработке механизмов финансирования малых и средних предприятий.

Одной из сфер регионального сотрудничества, в наибольшей степени пострадавшей от пандемии, является также туризм. Устранение негативных последствий пандемии и восстановление внешнего и внутреннего туризма в нашем регионе требуют укрепления сотрудничества стран-членов в этой области.

В этой связы, странам членам ЭКО необходимо предприниять совместные усилия по реализацию мер, нацеленных на всемерное использование туристических возможностей наших стран.

В заключении хотелось бы подтвердить нашу готовность и впредь принимать активное участие в деятельности Организации во всех приоритетных направлениях на благо устойчивого развития региона ЭКО.

Ladies and Gentlemen,

Excellencies,

It is a great pleasure for me and my delegation to be with you on the occasion of the thirty second (32nd) Meeting of the Regional Planning Council (RPC).

I would like to convey my sincere gratitude to the ECO Secretariat for the arrangements made for the successful conduct of this Meeting.

Distinguished Delegates,

Unfortunately, as humanity, we all have been struggling with the threats and risks posed by the COVID Nineteen (19) pandemic which has been affecting every sphere of human activity including the economy, trade, transport and tourism. After almost two years into the pandemic, the total confirmed COVID Nineteen (19) cases exceeded two thousand seventy (270) million, and the total deaths, unfortunately, exceeded the 5 million lives.

Besides its devastating effects on every aspect of human life, the COVID Nineteen (19) has significantly disrupted the global economy and international trade.

During this intense period, as humanity, we observed that collective action is required to address the very challenges posed by pandemic and experienced in every area of life. Being aware of this, as Türkiye, we have been trying to respond to assistance requests received from all around the world since the onset.

Up to now, we have delivered aid to twelve (12) international organizations and one hundred and sixty (160) countries. We have also supported some members of ECO by

granting exporting and purchasing licenses for medical equipment and by providing personnel and training aid.

Within this context, as ECO member countries, we should concentrate on how we can make better use of our organization to reinforce our economic cooperation through enhancing mutual understanding, dialogue, cooperation and solidarity among us.

Distinguished Colleagues,

Unfortunately, so far, we couldn't succeed to make better use of the significant potential of ECO and our member countries. The current level of intra-ECO trade, which is about eight point three percent (8.3%), is far below its potential. We should intensify our efforts to boost our trade volume to the desired levels. In this regard, we should, first of all, implement the ECOTA.

Esteemed Participants,

Another important aspect to enhance our economic cooperation especially intra-ECO Trade is strengthening transport and connectivity among member countries. In this respect, effective implementation of the Transit Transport Framework Agreement (TTFA) and smooth and efficient functioning of the ECO road and railway projects are extremely crucial for the ECO Region.

Within this context, it is a great pleasure to mention that the opening ceremony of the Istanbul-Tehran-Islamabad Cargo train between three neighboring sister countries has been realized in December. The beginning of the train service is a significant step towards regional connectivity. I am very pleased to have the opportunity to address the August Forum of 32nd Meeting of the RPC!

Excellencies, on behalf of ECO Science Foundation (ECOSF) and on my personal behalf, I express my deep gratitude to all the Member States and ECO Secretariat for their cooperation extended to the Foundation. Our acknowledgement and special appreciation to the Government of Islamic Republic of Pakistan for their patronage, logistic support and continued budget contribution.

Ladies and gentlemen, in today's fast technological development, the ECOSF fully recognizes that investment in Science, Engineering, Technology and Innovation (SETI) builds the strong foundation to help sustain & enhance; the economic growth, community well-being and integrated development of any country or region. ECO region can achieve global competitiveness, if it ensures that the region has qualified and capable human resource, to develop and maintain the infrastructure and capacity, and keep pace with technological development. The ECO comprising of just 10 countries with well established, strong historical and religio-cultural linkages, is better positioned to steer the economic development and harness the economic benefits for the whole region. The fact that China's mega programme of Belt and Road Initiative (BRI) is across the ECO region, makes it even stronger argument for ECO to benefit from; ECOSF in this respect has demonstrated excellent collaboration to the benefit of member countries. I am also pleased to report that the Foundation has developed a robust collaboration with China under the BRI as reported previously. In 2020 ECOSF joined hands with Beijing Technology and Business University (BTBU) and launched the "BTBU-ECOSF Joint Training Center on Scientific, Technological and Economic Cooperation" under the BRI. It is funded by the China Association for Science and Technology (CASAT). The Center serves as a strategic training platform for many economic sectors, which is critical for infrastructure development and socio-economic growth for B&R countries, including the 10 ECOSF member countries.

Under the initiative, we have so far organized four trainings on:

- 1) "Management and Development of Special Economic Zones" in December 2020
- 2) "Low Carbon Development for Belt and Road (B&R) Countries/ECO Countries" in July 2021
- 3) "Digital Transformation for the Belt and Road Countries" in October 2021
- 4) Science, Technology & Innovation Policy and Instruments for Sustainable Development for the Belt and Road Countries in December 2021.

Dear Delegates, ECOSF has developed strong collaboration and is working very closely with China Association of Science and Technology- CAST since 2017. Under this collaboration, ECOSF is focal organization for STI and science education in ECO region for One Belt One Road (OBOR) programmes. So far, ECOSF has facilitated/sponsored participation of 972 young students and teachers/coordinators/officials from Member Countries in the B&R Teenager Maker Camps, Teacher Workshops and Student Contests held in China. ECOSF has also been contributing towards the development; "Fusion of OBOR Civilizations" school curriculum in collaboration with Inter-Academy Partnership Science Education Programme (IAP-SEP) and CAST under the BRI. The curriculum is focused to promote global peace and harmony through S&T education.

ECOSF is also pleased to report that the Capacity Building Program on IBSE launched in NurSultan-Kazakhstan in 2015; is continuing nicely in Iran and Pakistan. We are set to get Azerbaijan, Tajikistan and Turkey on board through the National Academies of Sciences who have shown their interest, but the financial constraints and COVID-19 issue have hampered the plans.

Excellencies, it must be realized that the Foundation CANNOT pursue its intended goals and function, without adequate budgetary support from the Member States. <u>The fact is that over the last three years, the Foundation has been facing serious financial crisis; so much so that the Foundation had to cut down its core activities and is not able to even pay the full salaries and benefits to the staff! At the moment, we only receive the</u>

mandatory budgetary contribution from the Government of Pakistan. Hence, the Foundation greatly appreciates the support of Pakistan in keeping the organization alive.

Member States are therefore urged to pull the Foundation out of serious financial challenge on immediate basis by paying their outstanding budgetary arrears and contributions. That is the only way forward to let the Foundation continue its functions.

The Foundation appreciates the Government of Pakistan for paying their annual mandatory budget contributions since inception in the year 2012, whereas, I.R. of Iran had provided partial mandatory budgetary support for some events within Iran in the past.

We call upon I.R. of Iran and other three ratifying member states- Afghanistan, Tajikistan and Turkmenistan to kindly make their mandatory contributions to strengthen the Foundation. The Member States, who have not yet ratified the ECOSF Charter and its Additional Protocol, are urged to do so at their earliest, so as to benefit from Foundation's programs and let it function at the fullest.

Excellencies, Ladies and Gentlemen, I am personally and on behalf of the Foundation, grateful to the Government of Islamic Republic of Pakistan for signing the Host Country Agreement in December 2021, thereby making it possible for staff from other Member Countries to join ECOSF in Islamabad. I hope that my successor from I.R. of Iran Prof. Syed Komail Tayebi will join soon and I wish him all the best. This also means that this RPC meeting is going to be my last meeting; hence I personally thank all the Member States and the Secretary General, the past four Secretaries General of ECO as well as the Scientific Community of the region & ECO Secretariat staff, especially the Assistant Directors (present and past) of International Relations for their continuous support in establishing the organization and running it for the last over eight years. My sincere appreciation to ECOSF's small but dedicated and able team for their efforts and support in my endeavours as the Founder President.

At the end, I assure you of continued efforts of the Foundation for pursuing its mandate with dedication. I also hope that the Member States will own the organization and support it with their mandatory budget contribution. I express my sincere thanks to the ECO Secretariat for the commendable efforts in organizing this 32nd Meeting of RPC despite the COVID-19 pandemic, and wish the ECO family all the best ahead.

Statement by Prof. M. Akif Kireçci President of the ECO Educational Institute at the 32nd Meeting of RPC of ECO

(26 January, 2022 - Tehran)

Mr. Chairman, Your Excellencies, Heads of Delegations, Presidents of Specialized Agencies, Ladies and Gentlemen,

I salute the ECO family here as a whole. On behalf of the Educational Institute, it is a pleasure for me to share with you some of our accomplishments and activities in the area of education since the last ECO RPC meeting.

One of the most important developments was signing of the **Host Country Agreement** between the Government of the Republic of Turkey and Economic Cooperation Organization Educational Institute (ECOEI) relating to the Rights, Privileges and Immunities of the ECOEI on 23 July 2020 in Ankara. It is a tremendously important step towards institutionalization of the organization, whereby we establish a firm ground for its future activities. Currently, the Host Country Agreement is at the Turkish Grand National Assembly for ratification.

As you may recall, the 3rd Meeting of ECOEI **Board of Trustees**, held on 12 August 2020, reviewed and approved ECOEI's Scale of Assessments, its Annual Budget, and the Institute's **Work Program** for 2020-2022. I'd like to invite all Member States to peruse our Work Program, which is available on our website and to take part in our activities. Since it has been approved by the Education Ministers of all ECOEI Member States, the Work Program has the potential to be a draft Plan of Action on Education as a whole. Therefore, I suggest that the Council would take the necessary step by recommending its adoption as such.

During the past year, the Educational Institute had to be very selective when organizing its activities and strived to achieve its targets despite the challenges such as COVID-19 and financial difficulties. We focused on projects that are high impact in terms of fostering development through education in ECO Member States.

We also organized two online workshops on "How to Write and Publish Articles for International Journals" -one with Isfahan University on 19 August 2020 and the other with International Islamic University, Islamabad on 29 March 2021- to improve the academic writing skills of graduate students and young scholars in these universities. We aim to hold similar workshops with other universities in the ECO region to contribute to the academic output of the young scholars in the Member States.

We are determined to extend our activities to every level of education, and we put particular emphasis on early childhood education. We organized an online **Preschool Education Summit** on 25-26 2 September 2021 with the theme "Do not give up on your dreams." More than 700 educators, teachers to-be and parents benefited from workshops with diverse themes such as gifted children at preschool age, teaching math using drama, puppet theatre, children's literature, musical activities, speech disorders, introduction to coding and many more. ECOEI strives to have an active role in improving preschool education practices and rendering it accessible to all children in the region. The report of this Summit will be prepared and shared with the Member States.

Our most recent high profile event was a High Level University Representatives Forum on internationalization of higher education, held online on 30 September 2021 with the participation of 60 experts from 7 countries and 30 universities. In the forum, chance to discuss opportunities and challenges internationalization of and regional cooperation on higher education in three comprehensive roundtable sessions. This was a major step in bringing universities in the ECO Region together so that they can meet each other, share their ongoing projects, and establish partnerships. We are designing a full-fledged web portal that aims to promote student mobility within the ECO region by facilitating the initial research of prospective students on educational opportunities offered by universities in the ECO region. Our web platform, StudyinECO.org, will provide information on each member country and provide an overview of its education system. The prospective student will be able to list available degree programs at universities and filter them according to several criteria of interest. By providing all necessary information in one database, studyinECO.org will make university choice and application easier for international students and increase digital visibility of universities in the ECO region. With the participating universities, we may even collect international applications each semester for different programs and hand over the information to evaluation committees and announce the application results. Educational Institute's primary goal in creating this platform is to help stimulate economic development and intellectual exchange through increased student mobility within the ECO region.

In the past two years, another major goal we had in mind was to produce reference works for region's youth. We have completed the editing and preparation of the articles from the **Symposium on Common History**, **Education**, **Culture and Civilization** for publication. The book consists of two volumes with forty-seven papers from fifteen different countries. We have also published a series of reports based on the results of the sessions held during the **Language Teaching and Learning Workshop** on October 19-20, 2018 in Ankara. These reports put forward the challenges of teaching and learning ECO languages and encompass recommendations for both teachers and policy makers. Lastly, ECOEI has published "The Status of Mathematics Education in the ECO

Member States" which is a comparative analysis of mathematics results in TIMMS and PISA in Azerbaijan, Iran, Kazakhstan, and Turkey.

ECO Educational Institute is ready to take on the task of promoting highly educated societies as envisaged in ECO Vision 2025 Statement. We are firmly committed to support advancement of education in Member States, through supporting experts, educators, institutions, and students, establishing regional networks on higher education, regional exchange and scholarship programs/mechanisms. Yet, I'd like to highlight that our success heavily depends on the ownership of the member states. The most important step to show ownership would be to establish consistent and institutionalized channels of communication. Therefore, I'd like to invite Member States to nominate their focal points, who may ideally be officials at the respective Ministries of Education of Member States. I would also like to invite Governments of Kazakhstan, Uzbekistan and Turkmenistan to join the Institute and become full members.

I believe that ECO Educational Institute has come a long way since its inception and will continue to thrive as an indispensable tool for advancement of ECO Member States. As I do in all ECO meetings, I would like to close my statement by repeating my favorite reminder "Every dollar invested in education contributes fifteen-fold in economy." I assure you that ECO Educational Institute makes every effort to fulfill its mandate.

Statement by Ms. Fatemeh Mirbagheri, International Affairs Manager of ECI 32nd Meeting of RPC of ECO

(17-26 January 2022)

Honorable Chair, distinguished delegates,

At the outset, allow me to extend my congratulations to your Excellency for your election as the chairperson of this meeting. It is a pleasure for me to address this important event on behalf of ECO Cultural Institute.

Also, on behalf of the ECO Cultural Institute, I would like to extend our sincere gratitude to the Republic of Turkey for the ratification of the Charter of ECO Cultural Institute at the latest meeting of the Council of Ministers.

Following the 31st Meeting of Regional Planning Council, ECO Cultural Institute has arranged a wide variety of cultural programs and activities. The complete report of the activities of our Institute is available in the working paper of the Committee of Specialized Agencies and Affiliated Bodies of the ongoing RPC meeting but our most important activities were as follows:

In line with the former consultation meeting between the three ECO specialized agencies and the significance of a trilateral partnership for further realization of ECO aims and objectives, a virtual consultation meeting between the presidents of all the specialized agencies was held on "The Role of Culture, Education and Science in Sustainable Development "on 18 January 2021.

Also, in continuance of joint activities between the specialized agencies of ECO, the First Joint Symposium of the Rectors of ECO Member-State Universities was held virtually on 04 March 2021. It is considered a milestone in the partnership between the ECO Cultural Institute, ECO Educational Institute, ECO science Foundation and Allameh Tabataba'i University. The Institute managed to attract participation of the major universities of all the ten ECO member states. The second meeting is scheduled to be held in 2022 in the Republic of Kazakhstan.

To strengthen the network connection among national libraries, the 5th meeting of ECO Heads of National Libraries was held online on 15 June 2021. The purpose of this meeting was to exchange views on common issues of the National Libraries of the member countries and to create a new chapter in cooperation in the field of cultural interactions at the regional level and to share experiences during the Covid-19 pandemic.

The meeting was organized in cooperation with Iran's National Library as the host. The event was participated by authorities of most of the ECO member states as well as President of the International Federation of Library Associations and Institutions (IFLA) and Acting Representative of UNESCO Cluster Office. The 6th meeting is scheduled to be held in 2023 in the Republic of Azerbaijan.

To make arrangements for the teaching of the languages of the Region which is among the key objectives of the Institute, a complete handbook of Urdu language and grammar for Persian speakers) written by the late Dr. Shahid Choudhary with a foreword by the honorable Ambassador of Pakistan in Iran, republished by ECI because it is much in demand as a reference for university students and researcher.

Also, ECI in partnership with Saadi Foundation held an online Persian learning course for the members of diplomatic corps residing in Tehran. It is a starter course and is gratis. ECO Cultural Institute plans to hold similar courses for the other common languages in the ECO region.

To preserve traditional festivals and rituals of the ECO region, ECO Cultural Institute held the celebration of "Nowruz, an Occasion for Solidarity" in March 2021 to mark the arrival of spring and to promote solidarity and friendship among the peoples of the ECO region. The event yielded a spectacular attendance; present at the meeting were President of the Academy of Persian Language and Literature, Ambassadors of Afghanistan, Kyrgyzstan, Tajikistan, Turkmenistan and a group of ambassadors and diplomats from other countries. The celebration was also well received by a great number of enthusiasts on social media.

Commemoration of the famous figures of the ECO region is one of the key mandates of the ECO Cultural Institute. In this regard, On the occasion of the 144th birth anniversary of Allama Iqbal, ECO Cultural Institute held the international event "Iqbale Ishq" on Monday, November 15, 2021 in partnership with the Embassy of Pakistan and the Sahar TV Channel.

Also, on the occasion of the 580th birth anniversary of Amir Alisher Navoi, the renowned poet and writer, ECI in partnership with the embassy of Uzbekistan in Tehran held an international webinar in February 2021, titled " Alisher Navoi's works as the cultural achievements of the ECO region".

Furthermore, on the occasion of the 110th birth anniversary of Mirzo Tursunzoda, people's poet and national hero of Tajikistan, an international webinar in cooperation with the Embassy of the Republic of Tajikistan in Tehran, titled "Poet of Peace and Friendship" was held on Thursday 20 May 2021.

For preserving the historic heritage of the ECO region, ECI has published an inclusive book titled "World Intangible Heritage in the ECO Region" which is the collection of

intangible heritage of all the ten member states inscribed in UNESCO Intangible Cultural Heritage List.

For promotion of tourism in the ECO region, ECI has started a series of special issue of its quarterly journal, ECO Heritage. Over the last year, two journals dedicated to the cities Dushanbe, Capital of Tajikistan and Khiva in Uzbekistan. Also, two issues of the quarterly will be dedicated to the cities of Sheki in Azerbaijan and Sari in Iran. ECI is willing to promote the other major cities of the ECO region in its journal upon the request of the esteemed member states.

Finally, regarding new publications of our Institute, ECI has published 6 new books and 5 quarterly journals during the year 2021.

Distinguished delegates, Ladies and Gentlemen,

ECO Cultural Institute has a great potential to efficiently play its role in ECO cultural integration through its activities. However, organization of cultural events is subject to necessary support from the Member States and availability of funds. Taking into consideration the fact that ECI is mostly dependent on the financial contribution of its four member states, we stress on the urgent need for timely payment of annual contributions by the member states, as delays would hamper ECI's activities.

ECI welcomes proposals from all the ECO member states for holding joint cultural events and strongly encourages all the member states to participate in the programs of the Institute. This will help the smooth functioning of the Institute in promotion of the rich common cultural heritage of the region.

Lastly, we would like to invite those signatory member states of the Institute to ratify its Charter and the remaining ECO member states to accede to ECI.

Statement by Dr. Atousa Goodarzi, Dean ECO College of Insurance (ECO-CoI) 32nd Meeting of RPC of ECO

(17-26 January 2022)

Distinguished Delegates
Ladies and Gentlemen,

It is a great honor for me to participate, in this meeting on behalf of ECO College of Insurance. I would like to express my appreciation to the Secretariat for their efforts and I hope that the meeting would succeed to achieve its goals and objectives.

I would like to take this opportunity to submit a brief report on activities of the ECO College of Insurance during the last year.

Given the various developments in the international arena, modern diplomacy has started to expand its functions and manifestations in the world today. One of the major directions it has taken is the *Academic Diplomacy* and the active role played by the academia in developing peace and friendship among different nations.

To this aim, Allameh Tabataba'i University, as the main state-owned university in Iran which specialises in the areas of humanities, social sciences, and the application of technology, together with the ECO College of Insurance which is conducting academic and research activities inside Allameh Tabataba'i University and under the support of the Economic Cooperation Organisation (ECO) have been eagerly involved in a plethora of academic events and activities in 2021 to fulfil their roles and reveal their commitments in the realisation of the goals of Academic Diplomacy.

Accordingly, Allameh Tabataba'i University and the ECO College of Insurance have had extensive cooperation with the universities and higher education institutes throughout the ECO region in 2021. In what follows, I will try to provide a brief overview of the major activities we have had with the universities in the ECO Member States.

- 1. We have signed and exchanged 2 memorandums of understanding with *Heriva Institute of Higher Education* and *Payam Institute of Higher Education* in *Afghanistan*, and one memorandum of understanding with the *Istanbul Arel University* in *Turkey*.
- 2. ECO College of Insurance has held *an international session* entitled "Afghanistan in the Past, Present, and Future" in partnership with the Scientific Association for Afghan Studies, in which scholars from Iran and Afghanistan delivered speeches.
- 3. To help solve the country's problems, we held a session entitled "The Rise of the Taliban: the Challenges and Requirements of Iran's Foreign Policy towards Afghanistan" with the presence of diplomats and professors from Iran and Afghanistan.

- 4. 4. In the Autumn Semester of 2021, a course was offered on *Energy Economics* in the Regional Studies Department. Professors from *Iran and Kazakhstan* taught and students from *Iran, Kazakhstan, and Russia* attended the course.
- 5. Another joint session entitled "India and Pakistan's Foreign Policy towards Afghanistan" was held online in the Regional Studies Department in December 2021. This session was held in collaboration with Ferdowsi University of Mashhad and professors from Afghanistan, Pakistan, and India participated in this online event.
- 6. A series of *workshops* on "*Introducing the Cultural Rituals of Ramadan in ECO Countries*" were held in the spring of 2021. The workshops were held for *ten evenings* during the holy month of Ramadan, and every night a professor from *one of the ECO member countries* delivered a speech on the topic. Participants from *most ECO Countries* attended the workshops.
- 7. A webinar entitled "Contemporary Russian Policy in the South Caucasus, and Iran-Russia Interactions in the region" was also convened in the Regional Studies Department. The webinar was chaired by one of the College's faculty members and taught by a professor from Russia.
- 8. The *joint spring school* entitled the "Prospect of the Balance of Power in Asia in the 2020s" was held in partnership with the Iranian Political Science Association (IPSA) for 10 days and teachers from ECO countries, including Turkey, Uzbekistan, Afghanistan, and Pakistan were the lecturers of the school.
- 9. A webinar was held on "Recent Turkish Foreign Policy in the South Caucasus" where Dr Azki Ozen, a professor from Sabanci University of Turkey was the speaker.
- 10. We held an event entitled "Recognition of Avicenna's Thought and Knowledge Heritage" in partnership with the ECO Cultural Institute in the summer of 2021.

It is worth adding that Allameh Tabataba'i University, in collaboration with the ECO Cultural Institute, hosted *the first Summit of Rectors from ECO member-state universities* in March 2021, and 22 *university rectors and presidents* participated in this event. We are currently founding *the ECO Universities Network* to provide a good academic sphere for all academics in the region to share their ideas and contribute to the wellbeing of the region.

I hope the measures taken in the ECO College of Insurance in 2021 have managed to provide a platform for further cooperation between the ECO-region universities and countries.

Suggestions for the 2022 year

1) Holding short-term courses and workshops for the staff employed in the ECO Member-State embassies;

The College has the capacity to hold courses in the areas of

- a. Insurance
- b. Stock exchange and financial markets
- c. International Relations and Regional Studies

Therefore, applicants interested in attending these events are invited to suggest their desired courses, and the ECO College can plan for holding the programmes.

- 2) Given the allocation of 4 scholarship quotas for each ECO Member State (excluding Iran), all countries are invited to nominate the applicants to study in the programmes available at the ECO College.
- 3) The ECO College is well prepared to improve its bilateral interactions with all ECO Member States. To this aim, we would like to suggest that members from the embassies of ECO states visit the ECO College, and our faculty and students have the opportunity to visit the ECO Secretariat and the embassies of ECO states (mainly during special events).
- 4) ECO College is equipped with one of the best libraries in Iran in the areas of regional studies, actuarial sciences, finance, and insurance. Accordingly, if the esteemed embassy members would like to donate general books (on such topics as the culture, literature, economy, finance, etc. of each ECO member country) or specialised volumes to our library, parts of the library could be embellished with the names of the donating countries.
