

# 33rd Meeting of the ECO Regional Planning Council (RPC)

## **Event's Report**

The 33rd Meeting of the ECO Regional Planning Council (RPC) was held on January 16-19, 2023. The event organized in hybrid mode was chaired by the Republic of Azerbaijan as the ECO Chair for 2023. Within the framework of RPC, the relevant sectoral committees met to discuss and consider their specific areas for making appropriate recommendations to the 33rd Meeting of RPC regarding the ECO Work Programme and Calendar of Events for 2023.

2. The Delegations of the Member States, including Afghanistan, Azerbaijan, Iran, Kazakhstan, Pakistan, Tajikistan, Türkiye, Turkmenistan and Uzbekistan participated in the meetings. The Representatives of the Turkish Cypriot State attended the Meeting as an ECO Observer. The concerned staff of the Secretariat headed by ECO Secretary General Ambassador Khusrav Noziri also participated in the event. Moreover, the Representatives of ECO Specialized Agencies, Regional Institutions and Affiliated Bodies attended the Meeting. <u>Annexure-I</u> contains the list of participants.

## **Plenary Session**

#### Agenda Item No.1

#### i. Opening remarks

- 3. The ECO Secretary General welcomed the participants and delivered a comprehensive statement to brief the Council on ECO activities and programs. He highlighted the role of RPC and importance of the meeting that is entrusted to analyze and evaluate the current activities of the Organization as well as mandated to consider and develop some new projects and programs within the cooperative frameworks of the ECO, specifically Vision 2025. He stressed that the preparation of annual ECO Work Programmes and Calendar of Events is the most significant task of RPC as the documents provide roadmap to ECO for continuing its regional activities and engagements.
- 4. While recalling the year 2023 proclaimed as the year of "Green Transition and Interconnectivity" he re-felicitated the Republic of Azerbaijan for assuming ECO Chairmanship on January 1, 2023. The Secretary General emphasized that despite the post-COVID's inconducive working conditions, the Organization successfully managed the organization of various events in 2022. Within this context referring the in adequate number of participations, he requested the Member States actively participate in all ECO events and activities to support the Organization in maintaining effectiveness, efficiency and progress. *Annexure-II* contains his complete statement.

#### ii. Election of the Chairman

5. As per ECO's rules and procedures, Mr. Orkhan Zeynalov, Special Envoy, Ministry of Foreign Affair of the Republic of Azerbaijan was elected to inaugurate and chair the Plenary Session of the 33<sup>rd</sup> Meeting of RPC.

- 6. The Chair welcomed the delegations and thanked them for their active participation in the meeting. While announcing the formation of Sectoral Committees and naming their Chairs, he expected that the 33<sup>rd</sup> Meeting of the RPC would yield productive outcomes to help the Organization for making further advancements.
- 7. Addressing the Council, the Chair acknowledged the importance of activities carried out for maintaining the regional development process under the Chairmanship of Uzbekistan in 2022, and the country's brilliant proposal that proclaimed the 2022 as the "Year of Strengthening Connectivity" in the region. Furthermore, he recalled the Azerbaijan's theme of Chairmanship that declared the 2023 as the year of "Green Transition and Interconnectivity" based on the targets set forth in the ECO Vision 2025. In this regard, he informed that Azerbaijan's priorities, including green transition and interconnectivity would be considered within comprehensive and coordinated regional context with a view to strengthening synergies among the Member States in line with their national priorities. *Annexure-II* contains his complete statement.
