## 33<sup>rd</sup> Meeting of the Regional Planning Council (RPC) (Hybrid)

**ECO Work Programme 2023** 

A. SECTOR	R: TRADE AND INVESTMENT
1.	The Council appreciated the confirmation of the Republic of Azerbaijan on hosting the 6 <sup>th</sup> Ministerial Meeting on Finance/Economy preceded by the SOM in 2023 which could not been held in 2022 due to lack of quorum.  The Council requested the Member States to initiate preparations for the meeting.
2.	The Council took note of the fact that the 5 <sup>th</sup> ECO Ministerial Meeting on Commerce and Foreign Trade (ECO-MM on CFT) has not taken place in 2022. The Council profoundly thanked the Republic of Türkiye for their offer to host the 5 <sup>th</sup> ECO Ministerial Meeting on Commerce and Foreign Trade (ECO-MM on CFT) during 2023.  The Council, accordingly requested the Republic of Türkiye to announce exact dates, venue, the preferred mode and hospitality details of the meeting at the earliest convenience in 2023. The Council further observed that the delay in hosting the Ministerial Meeting has contributed to the unsatisfactory level of progress on various ECO initiatives and activities in increase in trade by implementing preferential trade, trade facilitation through customs cooperation, payment systems and trade promotion through private sector cooperation, simplification of Visa Procedure for Businessmen etc.
3.	The Council recalled that the 4th ECO Ministerial Meeting on Commerce and Foreign Trade (ECO-MM on CFT) established two Joint Working Groups (JWGs) for the following:  i) Establishment of Joint Working Group to finalize the Multi-Dimensional Regional Trade and Investment Strategy as well as an Action Plan defining the role, responsibilities and timeframe for launching promotional activities by the relevant organizations for the ultimate goal of creating a Free Trade Area in the ECO region.  ii) Establishment of a Joint Working Group for preparing a draft ECO Trade Facilitation

	Agreement aimed at simplification of Customs Procedures, harmonizing transit trade mechanisms and putting in place transparent customs regulatory regimes.	
	The Secretariat informed the Council that the draft paper on ECO-MDTIS was circulated by the Secretariat, among Member States. The Islamic Republic of Afghanistan, Republic of Azerbaijan, Islamic Republic of Iran, Republic of Kazakhstan, Islamic Republic of Pakistan, and Republic of Uzbekistan have shared their views/comments. The Council requested Member States to expedite sharing their views/comments on the draft paper on Road Map on Multidimensional Regional Trade and Investment Strategy to pave way to realize the goal of Free Trade Area along with an Action Plan on defining role, responsibilities and timeframe for establishment of Free Trade Area in the ECO.	
	The Council further requested the Membership to share their nominations for holding the 1st JWG Meeting to finalize "Trade and Investment Strategy" and to conduct "Preliminary Study on the Prospects of Establishing a Free Trade Area" along preferably before the forthcoming 5th Ministerial Meeting on Commerce and Foreign Trade.	
4.	The Secretariat further informed the Council that a comprehensive paper, titled "Draft ECO Trade Facilitation Strategy" was prepared by the Republic of Türkiye in 2017 and circulated by the Secretariat for soliciting comments. The same was re-circulated among Member States to obtain their views, in 2020. So far the Islamic Republic of Afghanistan, the Republic of Azerbaijan and the Republic of Uzbekistan have provided their views/comments.	
4.	The Council was informed that the Secretariat circulated the draft Agenda and other relevant details for holding the 1 <sup>st</sup> JWG Meeting to negotiate " <i>Draft Trade Facilitation Strategy</i> " and a ' <i>Trade Facilitation Agreement</i> ' along with the relevant comments/views. However, it could not be held due to lack of confirmation from Member States. The Republic of Türkiye agreed to host the 1 <sup>st</sup> Joint Working Group Meeting in April 2023.	
5.	The Council appreciated the offer of the Islamic Republic of Pakistan for organizing the 9 <sup>th</sup> ECOTA Cooperation Council Meeting in May 2023 in physical mode.

	After organizing the 9 <sup>th</sup> ECOTA Cooperation Council Meeting, the Republic of Türkiye proposed to host the 5 <sup>th</sup> ECO Ministerial Meeting on Commerce and Foreign Trade to be preceded by a Senior Officials Group Meeting.	
	The Council urged Member States to effectuate ECOTA provisions with a view to achieving more liberalized trade in the region through implementing tariff concessions, eliminating Non-Tariff Barriers (NTBs), improving trade facilitation and harmonizing regulations. The Council requested ECOTA Signatory States to share their views/comments on the working paper and agenda of the 9 <sup>th</sup> ECOTA Cooperation Council Meeting already circulated by the Secretariat.	
	The Secretariat informed the Council that the report of the research study, titled "Impediments in Implementation of ECO's Trade Tools and Measures to Resolve" was shared with the ECOTA Signatory States for their views/comments.	
6.	Only the views/comments from Islamic Republic of Afghanistan could be received, and have been circulated to Member States. The Council requested ECOTA Parties to assess the scenarios presented by the Secretariat in the aforesaid research study, which was much appreciated by the 5 <sup>th</sup> Ministerial Meeting on Finance and Economy. The Council reiterated that all proposals may be discussed in the 9 <sup>th</sup> ECOTA Cooperation Council with a view to bring it to the table for discussion and adoption in the 5 <sup>th</sup> Ministerial Meeting on Commerce and Foreign Trade.	
	The Council appreciated the ECO Secretariat for following up and noting the importance of completing all legal and procedural requirements for the implementation of ECOTA.	
7.	The Council requested the Islamic Republic of Iran and the Republic of Tajikistan to complete all pending legal and procedural requirements including the submission of all the three product lists by the Islamic Republic of Iran, and the ratification of the Annexes to ECOTA and the submission of pending product list by the Republic of Tajikistan to pave the way towards effective implementation of the Agreement.

8.	The Council recommended that other ECO Member States, not a party to the ECOTA and the ECO CCI could be invited to ECOTA Cooperation Council Meetings as observers.	
9.	The Council suggested that the next ECOTA Cooperation Council Meeting should deliberate the expansion of the scope of ECOTA to a Free Trade Agreement, as mandated in the ECO Vision 2025.	
10.	The Council requested the volunteer Member States to consider hosting the 2 <sup>nd</sup> Meeting of ECO Investment Promotion Agencies (ECO-IPAs) Forum in 2023. The Council further urged Member States to ensure their participation once the schedule of the meeting is announced.	
11.	The Council recalled that the 1 <sup>st</sup> Meeting of the Experts of Tax Administration, on 26-28 May, 2014 in Tehran had finalized the following three draft documents on ECO Tax Cooperation, namely:	
	<ul> <li>a) The Charter for Establishment of ECO Tax Administration Cooperation Society (ECOTAX);</li> <li>b) ECO Memorandum of Understanding on Cooperation in Taxation and Related Matters; and,</li> <li>c) Agreement on the Exchange of Information in Tax Matters.</li> </ul>	
	The Council requested the ECO Secretariat to host the 2 <sup>nd</sup> Meeting of the ECO Heads of Tax Administration once it receives feedback on three basic draft documents in 2023, and requested the Member States to provide the required feedbacks promptly enabling the Secretariat to host the meeting	
	The Council requested the Secretariat to organize a preliminary discussion meeting to review the draft agreements by holding a virtual meeting before the main event. Member States have been requested to confirm their participations in both the meetings, which is kindly awaited. Meanwhile, views/comments of the Republic of Azerbaijan, the Islamic Republic of Iran, the Republic of Kazakhstan and the Islamic Republic of Pakistan have been received. The

	Republic of Kazakhstan has not expressed any interest in joining the agreements.	
12.	The Council appreciated the offer of the Republic of Azerbaijan to host the 9 <sup>th</sup> Meeting of the ECO Council of Heads of Customs Administration (CHCA) in May 2023 and the offer of the Republic of Türkiye to host the 5 <sup>th</sup> Meeting of the ECO Committee on Customs Cooperation (ECCC) in April 2023.	
	The Council kindly requested the Republic of Azerbaijan and Republic of Türkiye to communicate the mode, date and venue of the meetings. With a view to facilitate the Republic of Azerbaijan and the Republic of Türkiye to set the meeting dates, the Council urged Member States to confirm their participation in advance so that the postponed event could finally be organized in 2023.	
13.	The Council took note of the fact that the draft text of "the Agreement on Mutual Administrative Assistance in Customs Matters" was finalized in the 8 <sup>th</sup> Meeting of the ECO Council of Heads of Customs Administration (CHCA) in 2017. This adopted final draft text was circulated among Member States for completion of formalities and internal governmental processes. The Republic of Azerbaijan and the Islamic Republic of Pakistan have completed their internal procedures.	
	The Council kindly requested Member States for early completion of their formalities and internal governmental processes.	
14.	The Council requested Member States to support each other on customs matters through providing a set of relevant trainings and capacity building activities, and to inform the Secretariat so as to conduct trainings on need basis.	
	The Council appreciated the offer of the Republic of Türkiye for organizing training courses on Authorized Economic Operator (AEO), Single Window, Implementation of TIR system, simplified procedures on expedited shipments and implementation of customs enforcement matters in return of any request made by the Member States.

	The Council requested the interested Member States to provide their needs on relevant capacity building/training courses with the Secretariat.	
	The Council was informed that "ECO Smuggling and the Customs Offences Data Bank" under "the Agreement on Establishment and Operation of ECO Smuggling and Customs Offences Data Bank" entered into force in December, 2017 to increase governmental revenues of Member States by preventing pilferages. In order to make it operational, Member States, signatory to the Agreement; were requested to kindly take the following actions:	
15.	1. The Islamic Republic of Afghanistan has been requested to kindly deposit the original version of the Instrument of Ratification with the ECO Secretariat; which is awaited.	
	2. The Republic of Tajikistan, being the only remaining signatory of the Agreement awaiting ratification, has been requested to kindly share the Instrument of Ratification at the earliest.	
	The Council stressed the non-signatory Member States, namely the Republic of Kazakhstan, the Kyrgyz Republic, Turkmenistan and the Republic of Uzbekistan, to consider signing and ratifying the Agreement at their earliest convenience.	
	The Council was informed that the Republic of Azerbaijan, Islamic Republic of Iran, Islamic Republic of Pakistan and the Republic of Türkiye have shared their nominations for the Working Group recommended by "the 1st Experts Group Meeting on Banking and Financial Matters and Forming of ECO Clearing Union".	
16.	The Council again requested the remaining Member States to provide their nominations in order to hold the 1 <sup>st</sup> Meeting of <i>Working Group of the Central Banks on ECO Clearing Union (ECU)</i> and present its recommendations to the 2 <sup>nd</sup> Experts Group Meeting on Banking, Financial Matters of ECO and Forming ECO Clearing Union in 2023.	
	The Council appreciated the offer of the Islamic Republic of Iran to host the 1st Meeting of

	Working Group of Central Banks on ECO Clearing Union (ECU) in third quarter of 2023.	
17.	The Council appreciated the project titled "ECO Regional Payment System (ERPS) Feasibility Study Phase-I". The Council requested Member States (except Islamic Republic of Afghanistan and Islamic Republic of Iran) to share their comments on the report of the study with the Secretariat and actively participate in the 2 <sup>nd</sup> Meeting of the Expert Group on Banking, Finance and the ECU.	
18.	The ECO Secretariat informed the Council that the Republic of Türkiye has deposited the original copy of the Instrument of "the Agreement on Promotion and Protection of Investment (APPI)". The Agreement has come into force after the deposit of the 4th Instrument of Ratification as per Article 12 of APPI. However, the formality regarding the deposit of the Instruments of Ratification is yet to be deposited by the Islamic Republic of Afghanistan. The Council was informed that the Islamic Republic of Afghanistan will deposit the original Instrument of Ratification to the Secretariat at the earliest date.  The Council appreciated the Republic of Türkiye for depositing the Instrument of Ratification and called upon the Republic of Azerbaijan to complete the ratification procedures along with its Amendment Protocol at the earliest convenience. The Council urged the non-signatory Member States, i.e. Republic of Kazakhstan, Kyrgyz Republic, Republic of Tajikistan, Turkmenistan and Republic of Uzbekistan to consider signing/ratifying the Agreement.	
19.	The Council appreciated the proposal of the Islamic Republic of Iran to form an Investment Promotion Committee or Working Group in solving issues about investment, and devising an MoU for furthering cooperation after the signature of APPI.	
20.	The Secretariat informed the Council that the "ECO Trade and Investment Network Web Portal" is available on the main ECO Web-Site with the following address: "www.eco.int/trade". The Secretariat further informed the Council that upon the request of the Secretariat, the ECO Chambers of Commerce and Industry (ECO-CCI) had circulated a request among the National Chambers of Commerce of the Member States for providing

	The Council requested other Member States also to share their updated company information through their National Chambers at the earliest.	
	The Secretariat suggested that the Secretariat may work with Member States and their National Chambers to make "the ECO Trade and Investment Network Web Portal" more productive and beneficial for economic operators in the region.	
21.	The Secretariat also proposed regular update of relevant information on focal points to be presented on the web portal. The Council appreciated the suggestion of the Secretariat and called upon Member States to designate and if necessary, update their focal points in the areas of Trade, Investment, Customs, Trade Facilitation, WTO, Tax, Banking, Capital Markets, E-Trade and Visa, and provide their updated contact details to be placed in section for trade and investment of the ECO-Website.	
22.	The Council appreciated the project titled, "Study on Preparation of the Guidelines and Joint Action Plan for the Establishment of ECO Regional Network of Special Economic Zones/Free Trade Zones".  The Council requested the interested Member States to convey their willingness to host the 3 <sup>rd</sup> Meeting of the Heads of SEZs/FTZs of ECO Member States in preferred mode in 2023.	
23.	The Secretariat informed the Council that detailed TORs for "Study on Preparation of the Guidelines and Joint Action Plan for the Establishment of ECO Regional Network of Special Economic Zones/Free Trade Zones (SEZs/FTZs) in the ECO Member States" were prepared by the Secretariat and the services of a specialist will be hired as per rules.  The Council requested the Secretariat to follow-up for conducting the aforesaid study and share the outcome of the study with Member States for their views. The Council requested

24.	The Secretariat appreciated the offer of the Islamic Republic of Iran for hosting the 2 <sup>nd</sup> Meeting of SW/NDF preceded by Experts Group Meeting of the ECO Member States in 2023.  The Secretariat informed the Council that the TORs for the project titled "Study on Preparation of the Road-Map for Formulating a Comprehensive Plan among the Sovereign and National Development Funds of Member States" has been finalized, and a specialist has been hired to	
	conduct the study. The report of the study will be communicated once finalized by the specialist.	
	The Secretariat informed that the 1st Meeting of the Heads of the Commodity Exchange of ECO Member States was offered to all Member States for hosting in 2022, however, could not be held.	
25.	The Secretariat informed the Council that it is seeking nominations from Member States to host the meeting. The Council requested the ECO Secretariat to host this meeting virtually. The ECO Secretariat conveyed that the exact date of the meeting will be communicated later through diplomatic channels.	
26.	The Council took note of the medium-sized project proposal that will be pursued with UNIDO and the IsDB in 2023. The Council appreciated the proposal of the Secretariat to allocate some seed money through the Secretariat funds, as a medium-sized project to follow-up the matter with the UNIDO and IsDB for funding.	
27.	The Council requested the Islamic Republic of Pakistan to host the 4 <sup>th</sup> ECO Trade Promotion Organizations (ECO-TPOs) Forum in the third quarter of 2023. The Islamic Republic of

	Pakistan kindly indicated their readiness to consider hosting the said event and informing the Secretariat through diplomatic channel, then the Council requested the Secretariat to host the event in case of no volunteers. The Council requested other Member States to ensure participation of their Trade Promotion Organizations in 2023.	
	The Council stressed urgent actions to be taken towards the implementation of the decisions of the previous meetings particularly on the draft "ECO Agreement on Joint Trade Promotional Activities".	
	The Council took note of the project titled "Trade Promotion and Strengthening Cooperation amongst Public and Private Sectors in the ECO Region".	
28.	The Council requested the ECO Secretariat to initiate a 2-year renewable project worth US\$ 50,000/-, to be provided by the Secretariat from its budget (as was done in the past for the project titled "expanding intra-regional trade"). Project Management Group (PMG) meeting in November 2019 decided to make a project for holding Business Forum which could not be held in 2020 as planned on the sideline of the ECO Summit Meeting. However, the 4th Business Forum of the ECO Member States was held in hybrid format on 26th November 2021 in Ashgabat.	
	Accordingly, the Council requested Member States to offer their views on the said project at their earliest convenience. The Council acknowledged that these activities will foster private sector cooperation in the region in coordination with ECO-CCI.	
29.	The Council recalled that the 3 <sup>rd</sup> ECO Trade Fair could not be organized yet. Accordingly, the Council requested Member States for early hosting of the 3 <sup>rd</sup> ECO Trade Fair in 2023.	
30.	The Council recommended ECO Trade Promotion Organizations (ECO-TPOs) in coordination with ECO-CCI to push for early organizing the trade fairs and exhibitions as mandated by ECO Vision-2025.

	The programmes for media will be crafted and implemented by individual Member States and ECO-CCI to utilize their role for promotion of regional trade and economic activities.	
31.	The Council appreciated the offer of the Islamic Republic of Iran to host ECO Trade Exhibition, namely "ECO-RAF" in Yazd which could not be held. The Council requested the Islamic Republic of Iran to hold this Exhibition in 2023. The Council also requested the Member States and their National Chambers of Commerce to actively participate in this event for promotion of trade and regional integration.  The Council requested the Islamic Republic of Iran to provide exact date of this event.	
32.	Recalling the decisions of the 30 <sup>th</sup> & 31st RPC meeting the ECO-CCI informed that ECO-ASEAN Joint Business Forum and ECO-SAARC Joint Business Forum will be considered in 2023 with the aim of strengthening inter-regional trade. The Council noted that the matter is pending for long, and requested the ECO-CCI to provide an update regarding the ECO-ASEAN Joint Business Forum and the ECO-SAARC 'Joint Business Forum.'	
33.	The Council was informed that the 2 <sup>nd</sup> Phase of the Study on Trading Patterns in the ECO Region carried out by Pakistan Institute of Development Economics (PIDE) has been completed. The PIDE submitted its study report, which has been subsequently shared with Member States in 2020. However, no comments have been received from Member States yet. The Council requested Member States to give their views on the report of the 2 <sup>nd</sup> Phase of the PIDE study.	
34.	The Council requested the remaining Member States who have not joined ECO-TDB to join this important regional financial institution. The Council encouraged the ECO-TDB, as the regional institution of ECO to continue to support the implementation of regional projects as per the development mandate based on the Agreement of Establishment.	
35.	The Council requested ECO-TDB to initiate arranging the 1st Regional Partnership Forum (RPF) in 2023 in coordination with the ECO Secretariat, and requested Member States to volunteer to host this event in 2023.

36.	The Council requested the non-ECO-TDB Members to commence their membership process so that the membership of the Bank could be expanded.	
	The Secretariat informed the Council that fresh nominations for the General Assembly (GA) of the ECO Reinsurance Company (ERC) have been received from the Islamic Republic of Iran, the Islamic Republic of Pakistan and the Republic of Türkiye.	
37.	The Islamic Republic of Pakistan had informed that prior to holding the 1 <sup>st</sup> meeting of Board of Directors and General Assembly of ERC, it was imperative that the required ground work and formalities, including release/transfer of paid-in capital of ECO-ERC, should be completed to make it more successful and result-oriented. The Council was informed that the Islamic Republic of Iran has conveyed its readiness to transfer its contribution in paid-in capital.	
	The Council recommended Contracting Parties to share their views for the transfer of paid-in capital contributions to ECO-ERC. The Council noted that with a view to accelerating commercial activities in the region, completion of all such procedures may be expedited to operationalize the ERC in 2023.	
38.	The Council invited remaining Member States to consider joining this important ECO institutional arrangement, i.e. the ECO Reinsurance Company in order to utilize its potential and role in furtherance of businesses and economic activities in the region.	
	The Council appreciated the Islamic Republic of Pakistan for virtually hosting the 1 <sup>st</sup> Meeting of ECO Heads of Capital Markets Supervisory Authorities in 2022.	
39.	The Council appreciated the confirmation of the Islamic Republic of Iran on hosting the 2 <sup>nd</sup> Meeting of ECO Heads of Capital Markets Supervisory Authorities on 11-12 June 2023 in physical mode providing accommodation and local hospitality for 2 representatives from each ECO Member State. The Council appreciated that the Islamic Republic of Pakistan notified their focal points, and requested remaining Member States to share their focal point

	details as well.	
40	The Council was informed that considering the importance of investment promotion among the Member States of ECO Region, the Islamic Republic of Iran proposed the Secretariat, to initiate cooperation with UNCTAD in preparing and publishing "The Investment Policy Review (IPR) of the Member States of ECO Region".	
40.	The Council recommended the Secretariat to complete the investment policy details from all Member States before initiating work on the proposal – recalling that such information has so far been received from 5 Member States, i.e. the Republic of Azerbaijan, Islamic Republic of Iran, Kyrgyz Republic, Islamic Republic of Pakistan, and Turkmenistan.	
41.	The Secretariat informed the Council that UNCTAD has been approached to conduct the IPR of the ECO Region. A draft Project Concept Paper to this effect has been prepared, and is still under consideration, in particular, for the required funding for initiating the IPR project. The council tasked the Secretariat to pursue the project with UNCTAD to complete the IPR of the ECO region.	
42.	The ECO Secretariat recalled the Council that during the 3 <sup>rd</sup> Ministerial Meeting on Finance and Economy in Tehran, the Republic of Tajikistan was designated as the coordinating country for ECO initiatives on investment.  The Council requested the Member States to volunteer for hosting the 4 <sup>th</sup> ECO Investment Conference and tasked the Secretariat to pursue collaboration with IsDB for funding to host the event.	
43.	The Council recommended that "the ECO Special Business Forum" may be held physically in 2023 after significant improvements in the pandemic situation. The Secretariat will communicate with Member States for hosting this Forum and will inform accordingly through diplomatic channels.	
44.	The Council urged Member States to coordinate with their National Chambers / private sector bodies for the timely confirmation of their participation in the 5 <sup>th</sup> ECO Business Forum
