



# Report on the Inaugural Ceremony the First Conference of the Parliamentary Assembly of the Economic Cooperation Organization (PAECO)

### 11-12 February, 2013 Islamabad Pakistan

## Report on the 1st Conference of Parliamentary Assembly of Economic Cooperation Organization (PAECO), Islamabad, February 11-12, 2013

The initiative taken by Dr. Fehmida Mirza, Hon'ble Speaker National Assembly of Pakistan in 2011 materialized when Speakers from the parliaments of ECO countries gathered in Islamabad on 11 February, 2013 to formally sign the Charter of a new Parliamentary Assembly. Hence, the Parliamentary Assembly of Economic Cooperation Organization (PAECO) was formally established.

- 2. It may be recalled that Hon'ble Madam Speaker had proposed the concept of a parliamentary forum of ECO countries during her meeting with then Secretary General of ECO in March 2011 when she visited Tehran on the occasion of Naurouz celebrations (March 26-28, 2011). The proposal was followed by lengthy discussions in various meetings of the Council of Permanent Representatives (CPRs), Parliamentary experts and Council of Ministers (CoMs).
- 3. The Inaugural Ceremony and the 1st Conference of PAECO were attended by parliamentary delegations from Islamic Republic of Afghanistan, Republic of Azerbaijan, Islamic Republic of Iran, Islamic Republic of Pakistan (host country), Republic of Tajikistan and Republic of Turkey. All delegations were represented by their respective Speakers, except Afghanistan's delegation which was led by their second Deputy Speaker of Wolesi Jirga. On instructions from their respective parliaments, diplomats from Republic of Kazakhstan, Republic of Kyrgyzstan and Republic of Uzbekistan officially attended the Inaugural Ceremony and the Conference. The list of participants is attached as Annex-I.
- 3. A detailed program of the First Conference was prepared, which included meeting of the Women Parliamentarians, Signing Ceremony of PAECO Charter, Inaugural Ceremony, Meeting of Executive Council, and the General Conference of the Assembly. Each event of the 1st PAECO was arranged according to a set agenda.

#### **Signing Ceremony of Charter:**

4. Leaders of delegations attending the 1st Conference of PAECO signed the PAECO Charter, thus making the establishment of the PAECO. The Hon'ble Madam Speaker put her seal of approval of the Charter first, which was followed by Speakers of Republic of Azerbaijan, Islamic Republic of Iran, Republic of Tajikistan, Republic of Turkey and Deputy Speaker of Wolesi Jirga of Afghanistan. Secretary General of ECO also witnessed the ceremony. (Copy of Signed Charter is attached as Annex-II)

#### **Inaugural Ceremony:**

- 5. Hon'ble Dr. Fehmida Mirza, Speaker, National Assembly of Pakistan, who envisioned this forum formally inaugurated the Conference in an impressive ceremony held at Crystal Ball Room, Marriott Hotel Islamabad on 11<sup>th</sup> February 2013. In her inaugural address, the Speaker, National Assembly thanked all the Speakers for their cooperation in making this forum a reality. She drew attention of the delegates to some key challenges, faced by the region despite having largest repository of human and natural resources in the world. Copy of Madam Speaker's inaugural speech is attached as Annex-III.
- 6. Earlier, in his welcoming remarks, Mr. Karamat Hussain Niazi, Secretary National Assembly of Pakistan expressed his sincere gratitude to the distinguished Speakers, Parliamentarians and members of the delegations from the ECO Region for their presence in Islamabad as participates of the First Conference of PAECO. Copy of Secretary National Assembly's welcoming remarks is attached as Annex-IV.
- 7. The inaugural speech by Speaker, National Assembly of Pakistan was followed by remarks of Honourable Speakers of participating countries. They all complemented Madam Speaker for her initiative of having parliamentary forum and for hosting the 1st Conference of PAECO in Islamabad. The distinguished guests showed their satisfaction for the preparations made for the Conference. (Remarks of all distinguished Speakers are attached as Annex-V). Later, in the evening, a dinner was hosted by the Hon'ble Speaker in honor of all the participants, which was followed by a cultural performance.

#### **Meeting of ECO Women Parliamentarians:**

8. Another significant event of the first Conference of PAECO was first-ever holding of the meeting of ECO Women Parliamentarians on the theme: "Role of Women Parliamentarians in Strengthening Democracy and Social Justice in ECO Region". The Women Parliamentarians made a unanimous pledge to jointly work for women's empowerment in the Region. The Women Parliamentarians also agreed upon a joint statement. Copy of Joint Statement is attached as Annex-VI.

#### **Meeting of the Executive Council:**

- 9. A meeting of the Executive Council as per Article 5 (a) of the PAECO Charter was held on 11<sup>th</sup> February, 2013. The Council formally elected Hon'ble Dr. Fehmida Mirza as President of the Council. In her address to the Speakers Council, she informed the Speakers about regrets by Republic of Kazakhstan, Republic of Kyrgyzstan, Republic of Turkmenistan and Republic of Uzbekistan to attend the Conference. The Council took following decisions by consensus:
  - i. The Conference of PAECO will be held on annual basis.
  - ii Afghanistan offered to host the 2<sup>nd</sup> Conference of the PAECO, which will be held in Kabul in 2014. Consequently, Hon. Neamatullah Ghaffari, Second Speaker of Afghanistan was elected as Vice President of PAECO.

- iii. Rules will be framed in order to provide an institutional structure to PAECO. A committee, comprising of the Secretaries and designated officials from all member States will be constituted to undertake this important task. The committee will submit its report in the next meeting of PAECO in Kabul.
- iv. Secretary PAECO was authorized to seek Observer status for the newlyformed Assembly in the Inter-Parliamentary Union and the Parliamentary Union of the Islamic Countries.
- v. The Council also noted with satisfaction the holding of the first-ever meeting of Women Parliamentarians from the ECO Countries and agreed to provide this important forum all the needed assistance for its steady growth.
- vi. The respective parliamentarians should push their governments to give serious attentions to enhancement of communication, increasing intraregional trade and investment, exchange energy resources and jointly work for peace in the ECO Region.
- vii. Hon'ble Ali Larijani, Speaker Islamic Republic of Iran suggested for issuing a joint declaration at the end of the 1st Conference of PAECO mentioning the objectives of the newly formed forum.

#### **General Conference:**

- 10. The General Conference of the Assembly was held on 12th February, 2013. On this occasion, Hon'ble Speaker was formally elected President of the First Conference of the Parliamentary Assembly of the ECO Countries. In her remarks, the Hon'ble Speaker thanked the participating parliamentarians for electing her President of the PAECO. She further said that the PAECO Charter envisioned the parliamentarians of the 10 member countries to jointly promote common values, interests and opportunities. She also emphasized to invoke the dictums of "Parliamentary Diplomacy" in fostering democracy, peace and development in the ECO Region. She further said that the Member Parliamentarians were duty-bound to transform these promises into action-oriented results. Honourable Madam Speaker assured the member countries that she would try her best to strengthen this forum during her tenure as President of PAECO. A copy of her statement is attached as Annex-VII.
- 11. Proceedings of the General Conference were divided into two sessions. Parliamentarians of the participating countries shared their valuable ideas on the following topic during both sessions of the General Conference of the PAECO.
  - a. Parliament's Oversight role on Intra-Regional Trade and Investment for the Sustainable Socio-Economic Development of the Region.
- 12. The General Conference remained very important event where participates of the 1<sup>st</sup> Conference of PAECO shared their valuable ideas and experiences. It provided immense knowledge and wisdom to all participates which eventually will help them to implement those ideas in policy making in their respective parliaments. The first session of the General Conference was presided over by Honourable Dr. Fehmida Mirza, the newly elected

President of General Conference. Besides lead speeches by H.E. Cemil Cecik, Speaker of Grand National Assembly of Turkey and Dr. Ali Larijani, Speaker, Islamic Parliament of Iran, the parliamentarians made total 13 deliberations during both sessions. The list of lead speakers and interventions is attached as Annex-VIII. Verbatim record of the proceedings will be printed separately.

- 13. During the proceedings of the Executive Council and General Conference, there is consensus on following points:
  - a. There is a need to utilize the forum of PAECO for pushing respective ECO governments to take practical steps towards increasing trade, investments and other areas of mutual cooperation.
  - b. Promotion of pro-active role of Parliamentarians for eliminating terrorism as it was a threat to democracy.
  - c. There is a need to fully harness potential of ECO member countries for fostering trade and investment.
  - d. Active participation is required by member states for achieving the goals of crucial ECO Trade Agreement (ECOTA).
  - e. Foremost task of the PAECO should be to stress upon the governments through legislative and oversight role to fully activate ECOTA and ECO Trade and Investment Bank in Istanbul, Turkey. All the ECO member countries should sign the banking agreement for commencement of the bank.
  - f. There should be continued constructive dialogue through PAECO to ensure 100% participation in all agreed ventures.
  - g. PAECO should facilitate private sector through supportive legislations and removing numerous barriers, which creates hurdles in intra-regional trade and investments.
  - h. There is need to build reliable road and rail links in the ECO region, which hold key for sustained economic activity. The projects like the North-South and East-West Railways and opening of all-weather road systems are essential for the integration of our Region.
  - i. The prime objective of this forum is to further the ideals of economic cooperation.
  - j. It was also agreed that the sustainable socio-economic development was not possible if it did not address the needs of women and children.
  - k. The PAECO should make use of headways in achieving MDGs' indicators by strengthening the forum of ECO Experts Group on MDGs through a combined parliamentary mechanism. National Assembly's Committee on MDGs is already working and Pakistan will be happy to share experience with other PAECO countries.
  - l. The platform of PAECO must work on long-term basis for empowerment of women.
  - m. It was also agreed to raise voices for the rights of people of occupied Kashmir and Palestine etc through the platform of PAECO.

- n. Parliamentary exchanges should be increased and parliamentary seminars, workshops and discussions should be arranged on mutually agreed issues on regular basis.
- o. Different committees may be formed by Assembly, related to the various subjects.
- p. Executive Council decided that 2<sup>nd</sup> Conference of PAECO would be held in Afghanistan.

#### **Concluding Remarks:**

Assembly. She expressed her satisfaction on the successful holding of the 1st Conference of PAECO in Islamabad. She termed success of the Conference as "joint achievement" and also appreciated personal interest of all Speakers of ECO Parliaments and for their contributions. "Frequent events like this and exchanging of ideas will bring understanding among all members of the South Asian region", said Madam Speaker. She also appreciated all parliamentarians for their inputs in the theme of the Conference. Honourable Speaker made it clear that achieving MDGs was the biggest challenge for democracies and it required holistic approach. Climate change and related risks, chronic poverty and growing inequalities, uncontrolled population growth and urbanization and global financial crisis were the key challenges for the Region and genuinely required joint efforts in this regard. At the end of her speech, she thanked all Honourable Speakers, parliamentarians and all others concerned for their active participation in the Conference. Vote of thanks was also adopted. A copy of the concluding remarks is attached as Annex-IX.

#### **Bilateral Meetings:**

15. Bilateral meetings were also held on the sidelines of the First conference of PAECO. Honourable Speaker of Pakistan held successful meetings withal visiting leaders of parliamentary delegations. Besides, the visiting delegations also interacted with one another. During these meetings, various means of parliamentary cooperation came under discussion, with the objective of cementing and strengthening relations among parliamentarians.

#### CHARTER OF THE PARLIAMENTARY ASSEMBLY OF THE ECONOMIC COOPERATION ORGANIZATION (PAECO)

Whereas the Speakers and the members of Parliaments of the ECO Member countries;

Conscious of their common social, economic and political interests, aspirations and the ties of history and friendship that bind their peoples;

Desirous of forming an organization to strengthen and foster friendly ties, understanding, co-operation and joint action to promote their common values, interests and opportunities:

Recognizing that the ECO Member countries have created a framework for the Parliaments to co-operate among themselves to achieve the ideals of the Izmir Treaty (The Charter of ECO):

Aftirming their acceptance of the spirit, purposes and principles of the ECO Charter and of supporting the work of the ECO and promoting knowledge of its principles and activities;

Conscious of the importance of parliamentary diplomacy in fostering democracy, peace and development in our region;

Recalling the decisions of successive ECO Summits on people to people co-operation leading to finalization of guide-lines for extending recognition to ECO Member countries' Parliaments;

Convinced that such recognition would result in increased involvement of the people of ECO Member countries;

DO HEREBY unanimously agree to establish an Assembly to be known as Parliamentary Assembly of Economic Cooperation Organization Countries "PAECO" [hereinafter referred to as the "Assembly" with the following Objectives and Institutional Arrangements: A distant

#### **OBJECTIVES**

The objectives of the Assembly shall be to:

- (a) strengthen people to people contacts with a view to achieving mutual understanding, trust and friendship among the peoples of the ECO member countries;
- (b) promote contact, co-ordinate and exchange experiences among Parliaments and Parliamentarians of the ECO Member countries;
- (c) provide a forum for exchange of ideas and information on parliamentary practices and procedures and for making suggestions;
- (d) support the work of ECO and promote knowledge of its principles and activities among Parliamentarians of ECO Member countries;
- (e) co-operate in international forums in matters of common values, interests and opportunities;
- (f) enhance parliamentary interaction through strengthening Parliamentary Friendship Groups in the parliaments of the members of PAECO; and
- (g) promote exchange of visits of Parliamentary committees, officers between and among parliaments of the members of PAECO.

#### ARTICLE-2

#### **COMPOSITION**

- (a) All the ECO Parliaments shall be entitled to the membership of Parliamentary Assembly of ECO countries (PAECO).
- (b) The Assembly shall be composed of the Speakers/Presiding Officers and Parliamentarians representing the national Parliaments of ECO Member countries.
- (c) One Branch of the Assembly shall be formed in each Parliament. The Speaker/Presiding Officer of the Parliament shall be the President of the Branch and the Secretary or any other officer so designated by the Speaker shall be the Secretary of that Branch.
- (d) Observer status shall be granted to any other Parliament or Organization with approval of the General Conference.

- (c) Special guests shall attend the Plenary upon the invitation of the President of the Assembly with the consensus of the Member Parliaments.
- (f) Every Branch shall adhere to the objectives of the Assembly.
- (g) Each Branch shall have its own rules which shall conform to the rules of the Assembly.

#### **ASSEMBLY**

The Assembly shall comprise:

- (a) General Conference:
- (b) Executive Council;
- (c) Secretariat

#### ARTICLE-4

#### GENERAL CONFERENCE

- (a) The General Conference shall discuss and approve all matters falling within the objectives of the Assembly and are proposed to it by the Executive Council.
- (b) Each delegation to the General Conference shall be composed of up to 5 Members of Parliament including the Speaker, and Secretary of the Branch, provided that each delegation shall include at least one woman parliamentarian.
- (c) The Conference shall meet once a year in one of the Member, countries, preferably by rotation in alphabetical order.
- (d) The women delegates to the General Conference shall hold their separate meeting on the sidelines of the General Conference to discuss and propose women-related issues for consideration of the General Conference.
- (e) The Speaker of the host country shall be the President of the General Conference and the Secretary of the Parliament of that country shall be the Secretary of the General Conference.
- (f) The Speaker of the country hosting the next Conference shall be the Vice-President of the General Conference.

- (g) The term of office of the President, the Vice-President and the Secretary of the General Conference shall be from the commencement of one Conference to the commencement of next Conference.
- (h) The General Conference shall establish Committees to examine important issues.

#### EXECUTIVE COUNCIL

- (a) There shall be an Executive Council of the Assembly comprising the Speakers/Presiding Officers of the ECO countries parliaments. The Executive Council will meet prior to the General Conference.
- (b) The Speaker/Presiding Officer of the host country shall be the Chairman of the Council and shall hold office from commencement of one conference to the commencement of next Conference.

The Executive Council shall decide:

- (i) program and budget of the Assembly;
- (ii) agenda for discussion in the Executive Council, General Conference, and for any other conferences/meetings;
- (iii) all matters concerning the organization and conduct of the Executive Council, General Conference and other conferences/meetings;
- (iv) frame rules of the Assembly; fix the date and venue of conferences/meetings;

#### ARTICLE-6

#### SECRETARIAT

- (a) There shall be a Secretariat of the Assembly headed by the Secretary, who shall be responsible for the work of the Secretariat.
- (b) The permanent Secretariat of PAECO shall be in Islamabad, the Islamic Republic of Pakistan. The Secretariat will extend support to the country hosting the next General Conference.

- (e) The Secretary of the PAECO Secretariat shall be appointed by rotation. The mode of election/appointment of the Secretary of PAECO Secretariat shall be decided by the Executive Council in its first meeting. Till that time, the Secretary National Assembly of Pakistan shall be the Secretary of the PAECO Secretariat.
- (d) The Secretary shall inter alia:
  - (i) Prepare drafts of plan, program and budget for the Assembly:
  - (ii) Prepare and circulate to all Branches records of the proceedings of the Executive Council, General Conference and other conferences/meetings
  - (iii) Publish periodically an Assembly News Bulletin and also issue publications dealing with the subjects of interest to the Assembly;

#### GENERAL FUND

- (a) There shall be established a General Fund for the PAECO Secretariat with voluntary contributions from the member countries and other institutions and organizations in the manner to be decided by the Executive Council.
- (b) Expenses on local hospitality, logistic support and internal travel shall be borne by the host country. Expenditure on international travel shall be borne by the respective visiting delegations.

#### ARTICLE-8

#### OFFICIAL LANGUAGE

The official language of the Assembly shall be English. Arrangements may be made by the host country for unofficial Russian interpretation.

#### ARTICLE-9

#### **Entry into Force**

The Charter shall enter into force immediately after four Member States sign the Charter and notify the ECO Secretariat that the required internal legal procedures have been fulfilled.

It is my privilege to inaugurate the 1st Conference of the Parliamentary Assembly of the ECO Countries. This is a momentous occasion when the ECO s parliamentary fraternity has assembled in Islamabad to turn a new leaf in the history of our Region. I, therefore, warmly welcome all the distinguished Speakers, Parliamentarians and members of the delegations from the ECO countries, who have travelled long distances to participate in this important Conference. The signing of the PAECO Charter marks a historic step.

It reflects the shared resolve of the people's representatives to work together for the common prosperity in a spirit of friendship, trust and mutual understanding. I congratulate all of you on this worthy accomplishment and also express my deepest gratitude to the entire political and parliamentary leadership of the ECO countries for their valuable support in turning the idea of PAECO into a workable reality. Here, I would also like to appreciate the ECO Secretariat, especially its able Secretary General, for their valuable cooperation in seeking consensus on all related issues.

#### Ladies and Gentlemen!

I had proposed the concept of PAECO at Tehran in February 2011 on the occasion of the Naurouz celebrations. Naurouzis the time when Mother Nature sparks a new beginning. As we all prepare to welcome the arrival of the spring season, let us hope that the initiation of PAECO at this time marks the political and economic rebirth of the ECO, which will reaffirm its foundations; broaden its scope and provide it with a constructive platform for a meaningful people-to people engagement. Since time immemorial, our common bonds of history, culture, religion and commerce have closely knit our nations together. This joint heritage provides ideal grounds for the socio-economic integration of this region.

The ten ECO Member states combine to form the largest repository of human and natural resources in the world. With a total area of around 8 million Sq. Kilometres, inhabited by more than 400 million people, they represent over 5 percent of the world s land mass and 6% of its entire population. This makes ECO nearly double the size of the European continent and almost equal in

terms of its consumer market. What is more, ECO's geographical position serves as a bridge between the East and the West and makes it the trade corridor of the world. This great potential, however, awaits its optimum utilization from the plat form of ECO. The adverse global and regional scenarios such as challenges concerning terrorism in all its forms and manifestations, intolerance and extremism have emerged as serious threats to the region s stability, peace and security.

It is also because of these reasons that ECO has not been able to achieve its promised targets. The ECO Ministerial Meeting passed the crucial 5-Year Plan of Action on Energy Cooperation in 2010. This awaits its implementation even after 3 years. It is an irony that there remains a wide gap between the Region s abundant energy resources and the acute needs of its member states, especially Pakistan. Proposals like the ECO Vision 2015, which anticipated our region as a Free Trade Area by 2015; the ECO Trade Agreement; and the ECO Trade and Development Bank have all remained off-the-mark. The Intra regional trade is less than US\$ 50 billion. Despite sharing common borders, the inability to develop effective and reliable transport systems have not allowed any two of our member's states to become each-othe's leading trading partners.

These are the shortfalls, which have contributed to the rise of poverty, illiteracy, and spread of disease, unemployment, environmental degradation and lack of opportunities. These considerations led me to propose the parliamentary platform of the ECO countries, through which, we the parliamentarians could jointly infuse our energies and action to the ideals of regional cooperation. The Parliaments, as the representative voices of the people, provide a platform for fruitful exchange of ideas. The parliamentarians have an important role to play in affecting the state polices for the collective good of the people. We hold the people s mandate to create consensus out of conflict by recognizing and resolving the contentious issues.

Individually, our national branches can help our governments in finding solutions through supportive legislations and framing policy. Collectively, we can engage into a meaningful parliamentary diplomacy for understanding and accommodating each other for the realization of our mutually agreed goals. In the forthcoming sessions of the 1st General Assembly of our newlyfound PAECO, the worthy delegates will be identifying their role as Parliamentarians in pursuing the agenda of sustainable socio-economic development by promoting trade and investments in the ECO Region. I am confident their meaningful contributions will help give new dimensions to the existing level of cooperation amongst our member states.

#### Ladies and Gentlemen!

The plight of women and children in ECO countries is a critical area of our common concern. PAECO holds an added responsibility to address their needs for the fact that out of 10 member Parliaments of our organisation, 3 are headed by women Speakers. Since ECO region is the bridge between East and West and North and South, its geographic location is ideal for development of diverse trading routes across the continents.

During the past years, various projects and activities have been initiated to realize the potential for socio-economic development in ECO region. The establishment of ECO Trade and Development Bank, finalization and implementation of ECO Trade Agreement and ECO Transit Trade Agreement, activation of ECO Chamber of Commerce and Industry, initiating transport projects for interlinking the region with major world markets, implementation of ECO Food Security Programme, initiating projects on energy cooperation, agriculture, poverty alleviation, tourism, health and counter-narcotics are among the many of ECO's initiatives aimed at realizing our collective goals.

However, keeping in view the enormity of the challenges facing our region and people, let us not be complacent with what has been achieved during all these years.

The total world trade in 2011 stood at US\$ 18 trillion<sup>1</sup> of which the share of ECO countries remains much less than 10 percent<sup>2</sup>. The intra-regional trade of our region presently stands at approximately \$45bn.<sup>3</sup> One can see that there exists a great potential for increasing trade and investment in this region.

At this august occasion with honourable parliamentarians of the member states among us, we need a fresh resolve and a renewed expression of our political will to make sincere efforts for the achievement of our goals.

#### Ladies and Gentlemen,

Our region faces complex socio-economic challenges which could be better tackled in a collective manner. With the start of cooperation at the parliamentary level, we are positive that the existing collaboration will be enhanced to realize our common goals of regional growth and development.

ECO with its resources and outreach will help in enhancing the intra-regional trade and attracting investment in the region.

The PAECO can offer its assistance to national parliaments in tracking and monitoring the ratification and implementation of the major ECO agreements. Additionally, the Parliamentary Forum will be in a position to encourage the respective Governments to provide resources to expedite the ratification and implementation processes.

If properly harnessed, intra-ECO trade and investment have the potential to serve as the bedrock for the region's economic resilience against economic crises and macroeconomic shocks. Enhanced regional trade and investment flow will also provide employment opportunities for the teeming population of our region, particularly for youth.

Let me express my confidence that in the coming years, PAECO will become a strong pillar of support to national and regional parliaments across the region for achieving our objectives of socio-economic development.

We the women parliamentarians from ECO Countries assembled for the meeting of the Women Parliamentarians at the First Conference of the Parliamentary Assembly of the ECO Countries being held in Islamabad, this 11thday of February 2012;

Share the common aspirations of our people within the region to live in peace and prosperity through social and economic justice;

*Welcome* the efforts of all ECO countries to strengthen social and economic justice of which women empowerment is an integral part;

Considering that the women of ECO region can be a source of great strength for the overall sustainable development of the ECO region.

Realizing that the needs and concerns of ECO women are more or less common in the emerging geo-political, socio-cultural and economic scenario, and so are some of the constraints to meet these challenges;

Recognizing that the women representatives have a special role and responsibility in articulating and shaping women's socio-economic and political empowerment within their respective countries;

*Reaffirming* the desire to build a just and inclusive order within the region that promotes people-centricsocial and economic justice.

Inter alia calls upon member countries to focus on the social, economic and political empowerment of women as well as on the potential of women's agency for social change

It is acknowledged women achieve results and advance their interests:

- i. If in numbers which is important for the critical mass factor
- ii. If they organize themselves into women's groups within parties and on multi-party level such as the Women's Parliamentary Caucus in Pakistan
  - iii. If they are mainstreamed into the body of politic of the parliamentary system

#### DO HEREBY UNDERTAKE THROUGH THIS ISLAMABAD DECLARATION

 To join hands and raise a collective voice through initiating discourse and series of dialogue to address the emerging socio-economic needs and concerns of the women of the ECO countries:

- To make concerted and collective efforts to position women for undertaking meaningful role at the policies and decision making levels within all spheres of the political and socioeconomic development;
- To emphasize on adopting special measures to promote women's economic, social and political progress within our respective countries
- To evolve mechanisms that ensure positive and greater cooperation through launching ECO
   Women Parliamentarians Forum

The Meeting Further extends its gratitude to the Parliamentary Assembly of ECO Countries for deciding to incorporate such an initiative into its Charter and to encourage the holding of its first meeting as the first agenda item at its First Conference being held in Islamabad 10 – 13 February 2013.

Transmits the joint statement to the Executive Council with the request that the honorable Speakers individually and collectively would continue to facilitate in taking it forward

Further requests, it is transmitted to the first meeting of the Women Parliamentarians at the First Conference of the Parliamentary Assembly of ECO Countries for attention as having taken place successfully and appropriately

I also consider the successful signing of the PAECO Charter and the holding of our1st Conference the joint achievement of all Parliaments of the ECO Region. I warmly acknowledge the personal interest of each one of you in making this possible and also congratulate you for your valuable contributions. The wisdom and foresightedness, reflected in the keynotes and interventions of worthy Speakers have identified crucial vistas of enhanced cooperation. I am sure that under our collective leadership, the newly-established PAECO will foster strong intra-regional linkages.

Distinguished delegates!

The topic of the 1st Conference of the PAECO:

"Parliaments' Oversight Role in Promoting Intra-Regional Trade and Investments to Ensure Sustainable Socio-Economic Development in the ECO Region" generated a healthy and target-oriented debate. ---- honourable members spoke on this key subject in the two sessions today and invited our collective attention to some of the burning issues.

All these esteemed speakers were unanimous in their conclusion that the full potential of the ECO, in the fields of trade and investment had not been harnessed. This could be increased to 8 folds if properly undertaken. They also pointed to the fact that although concrete plans and tangible institutions were floated but in the absence of active participation by all member states, these remained largely dormant. The crucial ECO Trade Agreement has only been signed by 5 countries while the rest of the 5 countries are out of its fold. Even those, who are signatories to ECOTA have not endorsed it so far.

This is also the case with ECO Trade and Investment Bank, which is only participated by 4 member states. Therefore, the foremost task before PAECO should be to push our respective governments, through our legislative and oversight role to fully activate these forums. We must also engage into a constructive dialogue through PAECO to ensure 100 per-cent participation of all member states in all agreed ventures.

Another area of our focus should be facilitating the private sector through supportive legislations and removing numerous barriers, which create hurdles in intra-regional trade and investments. The importance of building reliable road and rail links in the ECO region hold the key for sustained economic activity. The projects like the North-South and East-West Railways and opening of all-weather road systems are essential for the integration of our Region.

#### Ladies and Gentlemen!

As PAECO takes its initial steps, it is important for all of us to realize that the prime objective of this forum is to further the ideals of economic cooperation. We must, therefore, identify and agree on realistic targets. Let us not forget that long journeys always start with small steps. The convergence of ECO Region is only possible by respecting and recognizing the diversity of our respective member countries. We must, therefore, work in a spirit of mutual respect, trust and confidence.

And before I conclude, I would especially like to stress that sustainable socio-economic development is not possible if it does not address the needs of our women and children. The Millennium Development Goal indicators of our Region show that almost all Members states lag behind on issues, pertaining to women's empowerment or mother and child health. The PAECO can make useful headways in this area by strengthening the forum of ECO Experts Group on MDG through a combined parliamentary initiative.

A Parliamentary Committee in the National Assembly of Pakistan, as constituted by me, is already working for speeding up the pace in this important direction. We will be happy to share this experience with our PAECO colleagues. The holding of the first meeting of the Women Parliamentarians of PAECO yesterday is also an important milestone. This forum must be strengthened on long-term basis and converted into a dynamic platform under PAECO.

The need now is to sustain this meaningful parliamentary dialogue. As the President of this Conference for 2013-14, I will be working on finding ways to increase the momentum of parliamentary exchanges among member Parliaments. Through PAECO, we will reorganize parliamentary seminars, workshops and discussions on mutually agreed issues on regular basis. I am confident that with the able support of all distinguished Speakers of the ECO Parliaments, we will succeed in taking the PAECO to another level. As I conclude, I, once again, whole-heartedly thank all of you for your support to my idea of PAECO and in the holding of this Conference.
