# The 86<sup>th</sup> CPR Meeting

Report (Tehran, February 24, 2004)

The 86<sup>th</sup> meeting of the Council of Permanent Representatives (CPR) was held at the ECO Secretariat on February 24, 2004, under the chairmanship of H.E. Mr. Medet Sadyrkulov, Ambassador / Permanent Representative of the Kyrgyz Republic. The Permanent Representatives / Representatives of the Transitional Islamic State of Afghanistan, Republic of Azerbaijan, Islamic Republic of Iran, Republic of Kazakhstan, Kyrgyz Republic, Islamic Republic of Pakistan, Republic of Tajikistan, Republic of Turkey, Turkmenistan and Republic of Uzbekistan as well as the ECO Secretary General along with the ECO staff attended the meeting. CPR requested Turkmenistan and Uzbekistan for sending nominations for both Selection Committee and Awards. Since Turkey has just sent nominations for Awards, CPR requested Turkey for sending nominations for the Selection Committee as well.
