- Accurate and readily available data on trade flows with partner countries are essential for policymakers and analysts to make informed decisions, identify emerging trends, and tap into new opportunities.

- According to the OIC Economic Outlook 2022, the top five OIC exporters in 2021 were the United Arab Emirates, Malaysia, Saudi Arabia, Indonesia, and Türkiye, with Qatar, Iraq, Kazakhstan, Nigeria, and Oman also making the list of the top ten.
- These countries were responsible for a significant percentage of total OIC exports.

- Given the reliance of many OIC member countries on exports, the accuracy and availability of trade data is essential for policy-making and economic analysis.
- Moreover, some OIC countries are vulnerable to changes in global commodity prices, natural disasters, or political instability, which can impact their economies.
- Thus, analyzing their balance of payments is crucial.

- In 2021, the OIC countries recorded a current account surplus of US\$ 121 billion, marking an impressive turnaround from the US\$ 170 billion deficit the previous year.
- Despite continuing deficits in services trade, the improvement in the balance of merchandise trade was a significant factor contributing to this surplus.
