The ECO has significant resource capabilities to truly become an effective instrument of regional integration in modern

conditions. Our countries are united by common historical and cultural roots that go back centuries to the times of flourishing trade cooperation along the entire Great Silk Road.

Кугдуz Republic welcomes the Resolution on Cooperation between the UN and the ECO, adopted by the UN on August 25, 2023. We appreciate the proposals of the UN to develop strategies in the areas of trade liberalization and attracting foreign direct investment in order to promote their global and regional economic integration with the assistance of UNCTAD (ЮНКТАД -United Nations Conference on Trade and Development), WTO (World Trade Organization) and the International Trade Center ECO member states.

In this regard, we consider it necessary for the ECO to maintain a consolidated position with the UN on promoting regional interconnection and implementation of common tasks on the agenda of our regional cooperation.

Secondly, during the last 77th session of the UN General Assembly, the five-year resolution on sustainable development of mountain regions for 2023-2027 was adopted. This resolution was supported by 109 countries. Taking this opportunity, I express my gratitude to the ECO member states for their support and hope for close cooperation in the development of mountain regions.

Moreover, I would like to address to all ECO member states to support the candidacy of the Kyrgyz Republic for nonpermanent member of the UN Security Council for the period 2027-2028.

I hope that you will express your solidarity in this very important decision for us.

In the era of digitalization, one of the significant initiatives of the Kyrgyz Republic is also the High Technology Park of the Kyrgyz Republic, so called HTP. The HTP is an innovative zone where legal entities and individuals can obtain the status of HTP Residents, which provides unique tax advantages and creates favorable environment for business development and attracting investments in accordance with the Law of the Kyrgyz Republic "On the High Technology Park". HTP provides the most attractive preferences in the world. For the first half of 2023 HTP residents of the Kyrgyz Republic achieved significant results. Their income amounted to over \$17 million.

I would like to emphasize that this platform will allow all project participants to successfully sell their products. In this regard,

we propose to combine our capabilities and invite IT companies from ECO member states to cooperate and develop joint information products in the HTP of the Kyrgyz Republic.

Dear Colleagues,

It is obvious that the promotion of trade and economic ties and the implementation of regional projects are possible only in conditions of stability and security in the region. In this context, development of the situation in Afghanistan has a direct impact on the regional security system, as well as the success of trade, economic, transport, logistics and energy integration of the states of the region depends on our ability to assist the Afghan people in overcoming the economic and humanitarian crisis in the country. Kyrgyzstan is extremely interested in expanding regional trade and economic relations and electricity exports within the framework of the subregional project "CASA-1000".

In this regard, the Kyrgyz Republic welcomes intentions of the Temporary Government of Afghanistan to make efforts in stabilizing the situation in the country. Kyrgyzstan also calls on the ECO member states to continue assisting Afghanistan in promoting regional projects. We are confident that implementation of such projects will help to strengthen security and establish peace in the region.
