at the 7<sup>th</sup> CICA Ministerial Council Meeting,  
December 17, 2024**

I also commend the Republic of Kazakhstan for its exemplary chairmanship, under which CICA has undergone significant transformation and reform, evolving into a more reputable and effective forum in Asia and beyond.

We are focused on pursuing trade integration, connectivity both physical and digital, energy cooperation and green transition, and food security as part of our sustainable agenda duly outlined in the ECO Vision 2025.

At our 28<sup>th</sup> Meeting of the Council of Ministers in Mashhad on December 3, we adopted the Mashhad Communiqué which reinforces our commitment to enhancing intra-regional linkages and connectivity networks and to fostering global partnerships to amplify our impact and visibility in the international arena.

To foster people-to-people connections and capitalize on our overlapping geography, history, culture, and traditions, ECO has undertaken a number of initiatives including the practice of announcing ECO Tourism Capital annually. This year it is Shahr-e-Sabz in Uzbekistan, next year it would be Erzurum Türkiye and Shusha Azerbaijan for 2026.

We are also set to launch our new guiding document for the post-2025 era: the ECO Strategic Objectives 2035. This framework is expected to inject greater momentum into our work and reinvigorate the spirit of regional cooperation and progress.

In conclusion, I reiterate that ECO attaches great importance to deepening its ties with CICA. On behalf of the ECO Secretariat, I assure you of our fullest support and commitment to strengthening this partnership to advance our shared goals and objectives.
